Call to Order:	There being a quorum established, Dr. Tsuchiyama called the meeting to order at 1:05 p.m.
<u>Approval of</u> <u>the Minutes</u> :	It was moved by Dr. Corcoran, seconded by Dr. Kroll, and unanimously carried to approve the Board meeting minutes of April 4, 2019 with changes.
	After some discussion, the following changes to the minutes were requested (underlined material added, while bracketed material is to be deleted):

Subchapter 6 Examinations

§16-72-33 Examination. (a) Effective Jan 2020, all licensed acupuncture practitioners must provide proof of active diplomat status <u>of Oriental Medicine</u> with NCCAOM or its successor testing agency.

Subchapter 3 Authorized Practice; Scope of Practice; License

§16-72-4 An acupuncture practitioner is authorized to examine and diagnose for the purpose of treatment of the human body by piercing and/or stimulating certain acupuncture point or points to regulate the [flow and balance of energy,] neurovascular, immunological, endocrine and pain pathways <u>and the flow and balance of energy</u>.

e a. Inquiry regarding ordering lab work

Executive Officer's Report:

Executive Officer Araceley informed the Board that he had received an inquiry about whether acupuncturists in Hawaii are allowed to order lab work. The Board explained that the current scope of practice does not include the ability to order lab tests.

b. <u>Inquiry into "battlefield acupressure" by the Veteran Affairs</u> <u>Department</u>

Executive Officer Araceley informed the Board that he had received an inquiry about "battlefield acupressure," and whether it required a license to practice.

The Board discussed "battlefield acupressure" and "battlefield acupuncture," which Uniformed Services University has purview over and uses interchangeably. When it is done on federal land, the practice falls under federal law.

In Hawaii, an individual must have a license in acupuncture to practice "battlefield acupressure" and/or "battlefield acupuncture."

c. Clarification on testing requirements

Executive Officer Araceley asked the Board if the Foundation of Oriental Medicine (FOM) exam is equivalent to the Acupuncture Comprehensive Exam (ACE) scores. The Board does recognize the ACE score in place of the FOM.

<u>New Business</u>: a. <u>ACAOM Changes to Accredited/Pre-accredited Program Degree</u> <u>Structure</u>

Chair Tsuchiyama shared news from the Accredited Commission for Acupuncture and Oriental Medicine (ACAOM) regarding degree structure and naming conventions for the professional acupuncture community. ACAOM approved a revised degree structure with title designations that will bring consistency to the field and profession of acupuncture.

Ongoing Business: a. Finalizing Hawaii Administrative Rules (HAR) Chapter 16-72 Revisions

After some discussion, the following changes were requested (underlined material added, while bracketed material is to be deleted):

Subchapter 3 Authorized Practice; Scope of Practice; License

§16-72-4 <u>Authorized practice of acupuncture</u>. An acupuncture practitioner is authorized to conduct <u>examine and diagnose for the</u>

> <u>purpose of</u> treatment of the human body by means of stimulation of a <u>piercing and/or</u> <u>stimulating</u> certain acupuncture point or points <u>to</u> regulate neurovascular, immunological, endocrine and pain <u>pathways and</u> for the purpose of controlling and regulating the flow and balance of energy-in the body. <u>The practice includes</u> <u>cutaneous or invasive stimulation of specific-points on the skin with</u> <u>needles</u>. <u>Techniques included are</u> the techniques of piercing the skin by inserting needles and point stimulation by the use of acupressure, electrical, mechanical, thermal therapy, moxibustion, cupping, <u>laser acupuncture, acupuncture injection therapy,</u> <u>auricular acupuncture, lifestyle and dietary consultation and or</u> traditional therapeutic means-, including prescribing and dispensing <u>herbal medicine</u>.

Subchapter 6 Examinations

DAG Levins entered the room at 2:02 p.m.

§16-72-33 Examination. Effective January 2020, all applicants applying for license as an acupuncturist shall pass all exams administered by the National Certification Commission for Acupuncture and Oriental Medicine's (NCCAOM), or its successor testing agency, necessary to obtain an Oriental Medicine Diplomate or its equivalent as determined by the board.

Dr. Corcoran left the room at 2:17 p.m.

Subchapter 7 License Renewal

There was discussion relating to the inability of previous licensees to meet NCCAOM Diplomate status. The Board noted that the intent of the examinations changes is to require continuing education courses.

§16-72-46 Renewal. <u>Upon renewing their license all licensees</u> <u>licensed after January 1, 2020 must show proof of current</u> <u>NCCAOM diplomate status.</u>

> (a) <u>Licensees licensed prior to January 1, 2020 may choose</u> to provide 30 continuing education credit hours approved by the NCCAOM wherein 1 credit hour must be in Ethics and 1 credit hour in Acupuncture Safety. Licensees must hold a current, valid CPR (cardiopulmonary resuscitation) certification approved by the American Red Cross or the American Heart Association.

	It was moved by Dr. Kroll, seconded by Dr. Corcoran, and unanimously carried to approve the abovementioned changes.
