> EO Fernandez began by saying that both Ms. Bobbi Lum-Mew from the Hawaii Post-secondary Education Authorization Program ("HPEAP") and Dr. Kamakawiwo'ole, the current Director of Training for Hawaii School of Professional Psychology at Chaminade were asking the Board about who should sign Board internship verification forms required for licensure.

After a brief discussion, the Board formed the following informal opinion.

Since the Board's internship verification form requires the direct supervisor to sign off on the applicant's experience, it does not appear that there is anything for HPEAP, or Dr. Kamakawiwo'ole to do. The applicants should be in contact with the supervisors of their internship experience in order to verify their internship hours.

Furthermore, with regard to those graduates who do not have access to their records, who have not already placed their records in a database such as the one provided by Association of State and Provincial Psychology Boards ("ASPPB"), and who are applying to other jurisdictions, the Board unfortunately cannot comment on what can be done as this is not within its purview. As in past discussions regarding the closure of Argosy's Hawaii School of Professional Psychology program, the Board understands the predicament of those affected, and sends its most heartfelt regards.
