NJ S 4171

SUMMARY: Permits authorization for dispensation of medical marijuana through telemedicine and telehealth by health care practitioners (APRNs are considered "health care practitioners" under NJ's medical marijuana statutes).

“Veterinary Nurses”

The Chair asked Ms. Oliveira to lead the discussion on whether or not the Board would have concerns with the term “veterinary nurse” in lieu of “veterinary technician” as some veterinary technician programs are changing to “veterinary nurse” programs that may require the Board of Veterinary Examiners to amend their laws/rules to recognize the term “veterinary nurse.”

Ms. Oliveira stated that as a public member she would not find it confusing and that even the NCSBN did not consider this a public safety risk and therefore takes no position on this matter.

Ms. Stone Murai stated that the term “nurse” is protected under the nurse practice act under HRS 457-2 that reads as follows:

(d) Any person who holds a license to practice nursing as a registered nurse in this State shall have the right to use the title "Registered Nurse" and the abbreviation "R.N.". No other person shall assume the title "nurse" or in any manner imply that the person is a nurse except as provided in sections 457-8 and 457-8.5 or use the abbreviation "R.N." or any other words, letters, signs, or devices to indicate that the person using the same is a registered nurse.

After further discussion, upon a motion by Mr. Boyer, seconded by Ms. Kodama, it was voted on with the Chair, Vice Chair, Ms. Boyer, Ms. Daub, Ms. Kodama, Dr. Napoleon and Ms. Stone Murai voting “yes”, Ms. Oliveira voting “no” and Mr. Duldulao abstaining that the Board would have concerns with the “term” “veterinary nurse” as this would imply that the “veterinary nurse” meets the requirements or is licensed pursuant to HRS 457 and that HRS 457 also includes title protection for “nurses” licensed under this chapter.

Scope of Practice

Does RN Scope of Practice Include Manning a Health Clinic With No Onsite Care Provider?

The Chair asked Ms. Kodama to lead the discussion on the following email inquiry:

"I'm a licensed RN practicing at Maui Memorial Hospital as well as Hana Health Clinic. My question has to do with a situation I'm finding myself in today at the Hana Health Clinic.

Ordinarily I work with a care provider (MD or PA) here at the clinic however today there is none. The clinic is open, we are not scheduling patients and if an urgent patient comes in the receptionist and I have been instructed to call the MD on call and she will come to the clinic. There is also AMS available to this population. I was unaware that this was the plan for the day. They did send an email last week but I did not access my work email until today.

My question is this: am I operating within my scope of practice by manning a health clinic with no onsite care provider? I am not seeing patients however I am answering the phone and triaging as needed.

Thankfully my skill level makes me feel confident I can handle any emergencies, however in the ICU there is always a care provider and support staff to draw from. If I were to be honest, this situation is concerning to me and I'd rather not practice this way but if this is perfectly legal I assume I should not be overly concerned."

Ms. Kodama stated that it would depend on the practice setting's policies and procedures to address on-site supervision.

The Chair referred to HAR Chapter 89 and HRS Chapter 457 and in certain sections it allows an RN to "supervise" unlicensed assistive personnel but does not require that an RN be "supervised" at all times.

It was the consensus of the Board that the nurse practice act does not prohibit an RN from "manning a health clinic with no onsite care provider".

RN Performing Botox, Dysport, laser hair reduction, dermal fillers, microneedling with radio frequency, OxyGeneo facials, and chemical peels

The Chair asked Mr. Jomel to lead the discussion on the following email inquiry:

"I'm reaching out to you for your help with my understanding of Chapter 457, HRS, as it applies to a Report of Ongoing Unlicensed Activity regarding a RN who is currently licensed in HI and owns and operates Aloha Med Spa, Inc., which she recently opened on Kauai, where she is providing Botox and Dysport, laser hair reduction, and dermal fillers, along with microneedling with radio frequency, OxyGeneo facials, and chemical peels.

It has been our understanding that a physician's license is required to perform Botox, dermal filler and laser hair reduction services. I've reviewed Chapter 457-2.5 and 457-12, HRS, and NCSBN Model Rules, Chapter 3: 3.2.1(a) – Standards Related to RN Professional Accountability, and 3.2.2 (g) and (h) - Standards Related to RN Scope of Practice; and the NCSBN Model Act, Article III, Section 2 - Registered Nurse, but I wasn't able to determine a definitive answer to the issue of whether a RN can perform the above services.

The RN in this case stated that she is performing the services within the scope of her RN license, and she is performing them under Aloha Med Spa's Medical Director, who is a licensed physician. Copies of pages 9 & 10 of the Minutes from the 4/15/18 Board of Nursing Meeting; and copies of Certificates of Participation/Completion/Attendance she received for training in: (1) Laser Mastery; (2) Aesthetic Laser; (3) Laser, Intense Pulsed Light and Radio Frequency; (4) Bloodborne Pathogen and Infection Control; (5) Hydrafacial Treatments and Procedures; (6) Eclipse PRP for Facial Rejuvenation as an injectable or with Micro Pen Elite; and (7) Epionce Basic Account Training (Epionce products include "peel system treatments" using salicylic acid and malic acid); (7) Galderma Injection; (8) Kybella Injection; (9) Juvederm Volbella XC Injection; (10) Lumenis: Splendor X, Pollogen Legend+, FemTouch on Acupulse and Geneo; (11) Coolsculpting; and (12) Autologus Application Training.

My understanding of the 4/15/18 Nursing Board minutes is that they indicate that the Board informally opined that LPN's and RN's may perform laser treatments and cosmetic medical procedures if certain conditions are met, the one that most impacts being "acting as an agent of the supervising physician".

The Chair referred to the definition of "Scope of practice as a registered nurse" in HRS 457 and that in order to perform such activities as administering Botox and Dysport, laser hair reduction and dermal fillers, along with microneedling with radio frequency, although not basic nursing tasks, the individual should have the appropriate education and training to perform such activities.

Mr. Duldulao referred to the April 2016 minutes of the Board of Nursing in which the Board discussed an inquiry on whether or not an RN can provide cosmetic Botox injections and what kind of supervision would be required. The Board' informal interpretation of the nurse practice act at that time was as follows:

"After some discussion and careful consideration, although the Board had concerns that the administration of botox for cosmetics purposes and laser treatments were not basic nursing tasks and that other licenses may be required in order to perform such treatments for cosmetic purposes, it is the Board's informal interpretation that the nursing laws and rules do not specifically prohibit a nurse from administering botox or performing laser treatments, therefore, an RN may administer medications such as botox and may perform laser treatments provided the performance of professional services commensurate with the education preparation and demonstrated competency of the individual having specialized knowledge, judgment, and skill...and using reasonable judgment in carrying out

prescribed medical orders of a licensed physician (HRS §457-2, definition of “The practice of nursing as a registered nurse”)

Furthermore, the RN is accountable and responsible for the quality of nursing care rendered.

In addition, pursuant to HRS §457-1.5, “The scope of nursing practices established in this chapter and by the rules of the board shall serve as general guidelines and are not intended to address the appropriateness of the use of specific procedures in any particular work setting or to grant permission to implement specific procedures in any particular work setting.”

In accordance with HAR § 16-201-90, the above-mentioned interpretation is for informational and explanatory purposes only. It is not an official opinion or decision and is thus, not binding on the Board.”

The Vice Chair stated that the RN would have to carry out the orders of a licensed physician in order to obtain the prescription drugs to administer or to perform “laser” procedures as the Hawaii Medical Board considered “laser” treatment a medical procedure.

Ms. Boyer added that pursuant to the Decision-making framework, these specific procedures may not be prohibited.

Consequently, after some discussion, it was the consensus of the Board to uphold their April 2016 decision.

- HAPN converted their platform to ENP which is highly interactive website. He stated that in the past two months, 33% increase in engagement, a 10% increase in renewal membership and a 20% increase in new membership.
- HAPN will be offering purely social gatherings which you do not need to be a member to attend.
- The new ENP network will allow matching preceptors with students.
- Will be increasing their dues starting January 1, 2020 from \$60 to \$80
