- Agenda: The agenda for this meeting was filed with the Office of the Lieutenant Governor as required by Hawaii Revised Statutes ("HRS") section 92-7.
- Call to Order: There being a quorum present, the meeting was called to order at 10:30 a.m. by the Chair.
- Executive Officer's Report:
- a. Boards and Commissions Orientation- October 11, 2019  
  
EO Tamanaha reminded the Board that the upcoming Boards and Commissions Orientation will be held at the State Capitol and is open to all current Board members.

Approval of the Board Minutes: It was moved by Mr. Inouye seconded by the Vice Chair, and unanimously carried to approve the Applications Review Committee minutes, the Board Meeting Minutes and the Executive Session minutes, of the July 10, 2019 Meeting.

The Chair asked the Board if Item 6b of the agenda could be moved out of order immediately followed by Chapter 91.

It was the consensus of the Board to move Item 6b out of order, followed by Chapter 91:

Strategic Review Committee: The Chair stated that the Strategic Review Committee is continuing to review testing material and the exam for Private Detective and Guards, however, he stated that he hoped the Committee could start looking at addressing new trends relating to disciplinary action. The Chair stated that after review of the final decisions posted on the Office of Administrative Hearings website from the last three years relating to the Private Detective Guard Industry he noticed three primary trends:

- 1) Repeat entities coming before us for disciplinary action.
- 2) When entities are licensed in another state they fail to disclose they had prior disciplinary action in another state.
- 3) Unlicensed guard services.

The Chair suggested that if the Board sees a pattern in consistent disciplinary action, that the Board may want to revisit the oral interview questions to address these concerns to ensure that Agencies and Principal Guards are aware of the laws and rules.

EO Tamanaha stated that in regard to changing the exam review when the Board interviews applicants is an internal matter developed to ensure the Board was consistently asking the same questions, thus, it may be changed at any time to try to elicit information on applicants understanding of the laws and rules, especially regarding using unlicensed guards. She stated we could further emphasize that the use of unlicensed guards is considered illegal and will result in disciplinary action taken against their license.

Following the Board's review, deliberation, and decision in these matters, pursuant to Chapter 91, HRS, the Chair announced that the Board was reconvening to Chapter 92 Meeting at 10:48 a.m.

**The Board resumed its regularly scheduled agenda.**

Executive Session: At 10:56 a.m., it was moved by the Vice Chair, seconded by the Mr. Inouye, and unanimously carried to move into executive session pursuant to HRS §92-5 to consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section HRS §26-9 or both, and to consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities, as provided in HRS §92-5(a)(1) and (4).

EXECUTIVE SESSION

At 11:30 p.m., it was moved by the Chair, seconded by Mr. Inouye and unanimously carried to move out of executive session.

- a. Oral Interview for Licensure

    - (i) Kaipo Miller (GD)(Sole)

Chief Faaumu welcomed Mr. Miller back into the meeting room and thanked him for sharing his experience as a police officer, however, Chief Faaumu shared the Board's concern with Mr. Miller's use of force policy. Chief Faaumu acknowledged that Mr. Miller is applying as sole proprietor with no employees, in the event Mr. Miller transitions into adding employees, does Mr. Miller have a use of policy?

Mr. Miller assured the Board that if and when that transition occurs, he would have a use of force of policy in place, as it is a big part of liability. Mr. Miller asserted that he would train his employees using the observe and report response. However, he clarified that based on the scenario that was presented to him during the interview, he went straight to protecting himself because his life was in danger. He noted that the individuals that he plans on hiring will be an elite selection of individuals that will probably have prior training that exceeds his use of force policy. He stated that what they do as a reaction to being cornered based on the skill set they have, will be entirely on them. With that being said, Mr. Miller restated that his basic policy of use of force would be to observe and report. He stated that he will start will first teaching the importance of command presence and going from there based on the situation.

EO Zambrano asked given the situation that one of Mr. Miller's employees were not being cornered but instead in a position where the employee was threatened with a bat with room to escape, what would his training include.

Mr. Miller stated he would train them to evade the situation and notify police. However, if things escalated and now his employee's life or the life of others is being threatened the scenario changes. He stated at schools they train staff the run, hide, fight system. For instance, if someone is coming at you with a gun, you wouldn't just stand there to be shot at instead you would want to close the gap by placing hands on the individual. He stated that you must take action. With that being said, he acknowledged that his perspective may be different from others because he is thinking worst case scenario.

Chief Faaumu thanked Mr. Miller for articulating his use of force policy. Chief Faaumu stated that for him, Mr. Miller addressed the concerns he had.

The Chair asked the other Board members if they had any other questions or concerns. There being none, the Chair asked Mr. Miller if he was aware of HRS 703- use of force policy and if so, did he have any questions. Mr. Miller stated that he had no questions. The Chair followed up by asking if Mr. Miller knew what the concept of proportionate response was? Mr. Miller stated that if someone puts their hands on him then he may put his hands on them, if someone pulls a weapon on him, he can use any and all means necessary to protect himself.

The Chair stated that the Board wants to make clear of Mr. Miller's understanding that there is a distinction relative to use of force as a career law enforcement compared to his role as a security guard.

Mr. Miller stated that he understands that during the interview his answers may have been intense based on the scenario, however, his answers were based on experience. He assured the Board that he understands the transition and that liability is a big deal for him. He stated that he plans on hiring only qualified individuals. He stressed that he would never put his employees in a position where they would not be able to justify their actions in a court of law.

The Chair asked if Mr. Miller would be able to provide the Board with his use of force policy.

Mr. Miller stated that once he has one in place, he will be able to provide it to the Board.

With a motion by the Chair, seconded by Chief Ferreira, it was voted on and unanimously carried to approve the application for Kaipo Miller for Security Guard licensure.

Executive Session: At 11:53 a.m., it was moved by the Vice Chair, seconded by the Mr. Inouye, and unanimously carried to move into executive session pursuant to HRS §92-5 to consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section HRS §26-9 or both, and to consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities, as provided in HRS §92-5(a)(1) and (4).

At 1:16 p.m. the meeting reconvened to its regular order of business.

***Before moving to the next order of business, the Chair called for a moment of silence to remember and honor the fallen victims and heroes of 9/11.***

New  
Business:

a. Use of Pepper Spray

The Chair stated that the Vice Chair wanted to revisit the topic of the use of Pepper Spray. The Chair noted that the last time the Board looked at this topic was May 14, 2015. He referred to the minutes which states:

“The Executive Officer asked the Board if pepper spray is considered to be a chemical spray and therefore prohibited? The Board reviewed section 16-97-17 which prohibits the carrying of any weapon unless authorized in writing by the appropriate state agency or chief of police. Mr. Chang responded that training is required in the use of pepper spray and Chief Kubojiri added that training is required for care after the use of pepper spray in case of respiratory problems. Thus, it was moved by Mr. Chang, seconded by Chief Kubojiri and unanimously carried that any type of spray even naturally derived irritant sprays should still be approved by the appropriate county police chief for use in that county.”

The Vice Chair stated he received a recent inquiry asking whether it was still appropriate to require the approval of the county chiefs for security personnel to use pepper spray. The Vice Chair admitted his recollection of the topic wasn't very clear and he could only remember the 2002 decision by the Board that deemed that pepper spray was not considered a weapon and did not fall under the Board's purview. He stated that he was unaware of the 2015 decision which the Chair provided.

The Chair stated that he did some research regarding the use of pepper spray and found that according to the Board of Education, the Board of Education determined that it was a “dangerous instrument.” He also noted that Hana Security was fined by the Hawaii Labor Relations Board for failure to provide “adequate medical evaluations to best determine employee fitness associated with Oleoresin Capsicum used as a part of training...when medical examinations

are appropriate for adequate employee protection, the employer shall, at the employer's cost, provide examinations to best determine the effect of toxic material or harmful physical agents on the health of employees". The Chair stated that Hana provided pepper spray to their employees without any training. The Chair stated that employers must give their employees the proper training to use the device and to how to mitigate it.

Chief Ferreira stated when the County of Hawaii issued pepper spray to their officers they have a policy in place when to use it, where to use it, who to use it on who not to use it on and what to observe after they deploy it because medical attention may be required and they must be able to identify those signs. These officers go through training that requires annual recertification. The officers are required to also be exposed to the spray, so they know how to deal with it if it accidentally is deployed. Chief stated that if the county is responsible for the approval, he would need to check the ordinances and would want to see written policy regarding an applicant's use and training on pepper spray.

EO Tamanaha referred the Board to HAR 16-97-17 which states:

"Private detectives or guards shall not carry firearms, blackjacks, batons, night sticks, chemical sprays, stun devices, or other weapons unless specifically authorized in writing by the appropriate state agency or chief of police in the county or counties in which the private detective or guard is doing business"

EO Tamanaha stated that according to the Board's current rules, the Board does not allow the carrying of weapons, however, with that being said the Board informs applicants to check with the county chiefs, so the responsibility ultimately falls under the county offices.

Chief Faaumu said that in the law enforcement positions, they train and equip their personnel based on the challenges they are facing. Chief Faaumu stated that if the industry is moving toward using pepper spray because of the threat levels or the population they are servicing, then he would need to review by a case to case basis and he would like to see a policy and training in writing.

Mr. Inouye asked if the components of pepper spray changed since the 2015 decision and if not, he would recommend that we reaffirm the decision that the Board made in 2015.

Mr. Owens stated that he just wanted to mention a few things for the Board to consider in their discussion for allowing guard employees to use pepper spray. First, he stated that in the county of Oahu anyone over the age of 18 can purchase and use pepper spray in their own defense or the defense of others without any training. This law is regarding private persons. In addition, Mr. Owens stated that the Board once classified that pepper spray was not considered a weapon and that current law enforcement offices do not currently have a process in place for approval of pepper spray.

The Chair clarified with Mr. Owens that even if the Board previously ruled that pepper spray was okay, the most recent minutes says otherwise.

With no other discussion, upon a motion by the Chair, seconded by Chief Faaumu and unanimously carried to reaffirm the Board's May 14, 2015 decision that any type of spray even naturally derived irritant sprays should still be approved by the appropriate county police chief for use in that county.

Executive Session: At 1:30 p.m., it was moved by Chief Faaumu, seconded by Mr. Inouye, and unanimously carried to move into executive session pursuant to HRS §92-5 to consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section HRS §26-9 or both, and to consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities, as provided in HRS §92-5(a)(1) and (4).

At 1:54 p.m., it was moved by Chief Faaumu, seconded by the Vice Chair and unanimously carried to move out of executive session.
