EO Tamanaha stated that there our Examination Branch had some confusion regarding a candidate's eligibility to sit for the exam after two failed attempts. She stated that after two failed attempts, an individual must wait 90 days, before being eligible to sit for the third attempt, however our exam branch clerks interpreted the rules as only applying to individuals who fail the exam within two consecutive months. Therefore, EO Tamanaha stated that she clarified with the Examination Branch that it was the Board's intent to preserve the test bank, thus, no matter if an individual failed two consecutive months or every other month, the individual would need to wait 90 days before their third attempt.

Executive Officer's

EO Zambrano provided a brief overview of the Boards and Commission Orientation. He stated that there were remarks from both David Ige and Catherine P. Awakuni Colón, DCCA's director. In addition, Brian Yee, the supervising Deputy Attorney General, spoke about the protections they offer while serving on the Board.
