## Legislative Proposals:

#### A. <u>Amendments to section 453-1, Hawaii Revised Statutes</u>

The purpose of this bill is to clarify the definition of the practice of medicine to provide uniformity of practice for both medical and osteopathic physicians.

Ms. Quiogue informed the Board members that Senator Baker agreed to introduce this bill on behalf of the Board, and the bill must be assigned a bill number. She went on to say that she provided copies of the legislative proposal to representatives from the Hawaii Medical Associations, Kaiser Permanente, and Hawaii Pacific Health.

Ms. Quiogue also noted that the definition of medicine was last amended in 2008, and the definition of allopathic medicine was last amended in 1800's.

## B. <u>H.B. 1627, H.D. 3, S.D. 2, Relating to Medical Investigations by the Regulated Industries Complaints Office</u>

The purpose of this bill is to require the Regulated Industries Complaints Office ("RICO") to establish a division that specializes in the investigation of medical cases involving regulated professions and occupations. Appropriates funds from the Compliance Resolution Fund for field investigators and a staff attorney who specialize in medical cases.

Ms. Quiogue informed the Board that this bill was originally introduced in 2016, in response to the Star Advertiser's 3-part series on the Board. She went on to say that the Hawaii Medical Association has requested that it be reintroduced this legislative session.

Dr. Jaffe asked why the effective date of this bill is dated July 2050.

DAG Wong explained that this is referred to as a defective date, which allows the assigned legislative committees to discuss the bill further. She went on to say that this date will be changed when the bill has passed out of its final legislative committee.

Vice-Chair Halford asked whether RICO has any designated staff members to investigate medical related cases, only.

Ms. Quiogue responded in the negative and explained that RICO uses its Medical Advisory Committee members, which the Board appoints, to review practice specialty specific cases. As a reminder, the Board appoints Hawaii-licensed physicians, physician assistants, podiatrists, and emergency medical personnel to serve on RICO's Medical Advisory Committee.

Dr. Mun asked whether the Board will testify on this bill if it is introduced.

Ms. Quiogue stated that RICO is the lead on this bill, and that the Board will have to defer to their position.
