- CLARB Virtual Regional Meeting – February 26, 2020

CLARB held their regional meeting virtually on February 26, 2020. Primarily the CLARB executives and staff addressed their strategic priorities, evolving governance, increasing diversity and inclusion, advocacy of landscape architecture licensure and updates on the LARE.

EO Matsushima and Joel Kurokawa participated in this virtual meeting. EO Matsushima provided the Hawaii report. She reported on the board’s composition, and the number of landscape architects in Hawaii (154) and the total number of licensees under this board (10,520). Also, reported on the current legislation and status of the bills that may impact the board.

Correspondence: EO Matsushima shared correspondence from PE Dilip Khatri requesting

the board to review his file and amend the reciprocal action taken under ENG-2017-10-L in the settlement agreement and that his disciplinary action from California be expunged from his record.

Executive Officer's  
Report:

➤ Legislative Bills

HB 1933 RELATING TO THE STATE BUILDING CODE COUNCIL.

This measure repeals the state building code council. Takes effect on 1/1/2021.

This bill was heard and moved on to a HD1. There was a hearing on the HD1 version on February 20, 2020, and the committee deferred the measure.

HB 1877 RELATING TO LAND RECORDATION

This bill clarifies the data requirements for land recordation on land deregistered by the land court other than fee simple time share interests.

This bill is moving and is now an HD-1 and is ready to cross over to the Senate. The last hearing was on February 28, 2020.

SB 2128 RELATING TO FIRE PROTECTION (companion HB 1754)

These measures require the builders of new dwellings to provide buyers with information on the benefits and costs associated with installing and maintaining a residential fire sprinkler system. Requires the Department of Commerce and Consumer Affairs Professional and Vocational Licensing

Division to develop a standard form for this purpose. This would take effect on July 1, 2025.

Both bills are identical/companions and both have crossed over and are moving.

SB 2130 RELATING TO THE STATE FIRE CODE (companion HB 1756)

This bill repeals section 46-19.8, Hawaii Revised Statutes, thereby allowing counties to regulate installation of residential fire protection sprinkler systems.

This bill is SD-1, its companion is HD-1 and both are moving. Both bills are identical/companions and both have crossed over.

SB 2172 RELATING TO HOUSING DEVELOPMENT (companion HB 1716)

Provides to each county legislative body the ability to review and approve land use district boundary amendments for affordable housing projects on 15 acres or less.

Both bills are identical/companions and both have died.
