Call to Order:

The agenda for this meeting was filed with the Office of the Lieutenant Governor, as required by section 92-7(b), Hawaii Revised Statutes ("HRS").

There being a quorum, the Chair called the meeting to order at 9:00 a.m.

Executive Session:

At 9:00 a.m., upon a motion by Ms. Tokumaru, seconded by Ms. Cross, it was voted on and unanimously carried to move into Executive Session in accordance with HRS, 92-5(a) (1), "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities".

At 9:15 a.m., upon a motion by Ms. Keefe, seconded by Ms. Tokumaru, it was voted on and unanimously carried to move out of executive session.

Applications:

Ratification Lists

Upon a motion by Ms. Keefe, seconded by Ms. Tokumaru, it was voted on and unanimously carried to approve the ratification list(s).

Miscellaneous Permit(s)

Upon a motion by Ms. Cross, seconded by Ms. Keefe, it was voted on and unanimously carried to approve the following applications for Miscellaneous Permit as an out-of-state pharmacy:

Upon a motion by the Chair, seconded by Ms. Tokumaru, it was voted on and unanimously carried to approve the following application for Miscellaneous Permit as an out-of-state pharmacy, however, pursuant to HRS §436B-19(13) and HAR §16-95-110(a)(12) the approval **does not** include pharmacist Christopher Past. Mr. Past **shall not** adjudicate prescriptions, dispense into or contact any person residing in this State as part of the practice of pharmacy.

Chair's Report:

Announcements and Introductions

The Chair asked the audience to introduce themselves.

Approval of the Previous Minutes – January 23, 2020 Meeting

The Chair called for a motion regarding the minutes of the January 23, 2020 meeting.

Upon a motion by Ms. Keefe, seconded by Ms. Tokumaru, it was voted on and unanimously carried to approve the minutes of the January 23, 2020 as circulated.

Executive Officer's Report:

Conferences/Seminars/Meetings

<u>2020 NABP Interactive Member Forum, January 28-29, 2020, Mount Prospect, IL</u> The Chair reported on the topics discussed at the Interactive Member Forum she attended:

- Technician Registration/Certification
- Workload
- Compounding
- USP changes

These will be discussed in more detail at the Working Group Meeting.

2020 Legislature

The Board discussed the following bills:

SB 30, SD1 – Relating to Health (Requires pharmacies to provide written notice to patients advising them of certain risks associated with not properly disposing of unwanted or expired drugs, make available certain drug disposal options, and provide written informational materials concerning available drug disposal options. (SD1))

The EO reported that when this bill was heard before the Senate Committee on Commerce, Consumer Protection and Health, testimony submitted that the Chair, Senator Baker did not agree with.

The Chair stated that she would support the intent of the bill but also amend to require that all prescription drugs, not only controlled substances, be included.

Ms. Tokumaru stated that she agreed with the Chair's comments but wasn't sure what the bill was trying to achieve.

Ms. Keefe stated that she also supports the intent of the bill but does not agree that this should be mandatory.

Ms. Cross stated that from a public perspective, she supports the intent and wasn't sure the information on how to dispose of drugs was readily available for pharmacies to provide the information and that she wasn't sure it should be in the laws or rules.

Mr. Edwards stated that the DOH Hazardous Waste Branch has guidelines for special handling of disposal of certain drugs, i.e. chemo, on their web page.

Mr. Uyemoto of Times stated he supported the intent and execution of the bill and also added that perhaps the Hawaii Opioid Task Force could assist in developing the information sheet, but that he would have to check if that was okay.

Mr. Takara of Kaiser stated that they proactively give out information when a patient is discharged and the prescriber also provides information when prescribing medication and that there is an administrative fee.

The Chair stated that she would be concerned for the independent/community pharmacies having the resources to comply with this bill.

Ms. Cross stated that perhaps a pharmacy could post a sign.

Dean Ma stated that there are self-destruction methods consumers can utilize.

One of the students commented that also there are disposal bins in the State, there is insufficient information on where they are exactly located and what drugs or items can be placed in these bins.

The DAG stated that the intent of the bill seems like a good idea and based on the discussion and it appears there is information out there.

Ms. Noguchi stated that perhaps a delayed implementation should be considered in order to gather information on how to dispose of drugs safely.

The EO stated that it was in the Board's testimony to have the Pharmacy Working Group work on this issue and develop language with other stakeholders, but Senator Baker questioned whether the Board was aware that these disposal bins exist.

After further discussion, it was the consensus of the Board to:

- support the intent of the bill;
- comment to consider the law be applied to all prescription drugs and not only to controlled substances;
- concerns that this mandate would have unintended results for pharmacies;
- recommend further discussion including but not limited to the Pharmacy Working Group; and
- start working on an information sheet to be posted on the Board's web page and encourage pharmacies to start providing information to their customers on how/where to safely dispose of the drugs they receive.

SB 2919 – Relating to Electronic Prescription Accountability System (Amends section 329-101(b) and (d), Hawaii Revised Statutes, to require that the dispensing of a pharmacist-prescribed opioid antagonist be reported to the State's Electronic Prescription Accountability System.)

The EO stated that this bill would require any pharmacist in this State who is prescribing/dispensing an opioid antagonist to report it to the State's EPAS. She explained that this was an issue during the discussion on the bill to authorize pharmacists to prescribe/dispense opioid antagonist. The DOH wanted to collect data on who/where pharmacists prescribed/dispensed opioid antagonist and it was recommended that pharmacists report to the State's EPAS, however, the EPAS was only for controlled substances so that law had to be amended. She stated that this bill does not address DOH's authorization to access the information.

It was the consensus of the Board to support the intent of the bill but defer to the NED in regard to any recommendations.

The EO reported on the current status of the following bills that she was tracking:

<u>HB 1608, HD1 – Relating to Prescription Drugs</u> (Authorizes the Department of Health to implement a program for wholesale importation of prescription drugs. Effective 7/1/2050. (HD1))

HB 1804, HD1 – Relating to Pharmaceutical Representatives (Requires pharmaceutical representatives to register with DCCA. Creates a program within DCCA for the administration and enforcement of pharmaceutical representative registrations. Appropriates funds. Effective 7/1/2050. (HD1))

<u>HB 1659, HD1 – Relating to Health</u> (Authorizes a pharmacy to provide a customized patient medication package to any patient of an institutional facility or any member of the general public upon consent, with a valid prescription, and in compliance with labeling and dispensing requirements. Takes effect 07/01/3000. (HD1))

SB 2444 – Relating to Canadian Prescription Drug Importation Program (Establishes the Canadian Prescription Drug Importation Program to be implemented and administered by the department of health. Requires the department of health to obtain federal approval, make reports, and adopt rules. Appropriates funds)

SB 2917 – Relating to the Electronic Prescription Accountability System (Updates section 329-104(c), Hawaii Revised Statutes, to clarify who may access information stored in the electronic prescription accountability system.)

HB 2363 – Relating to Electronic Prescription Accountability System (Amends section 329-101(b) and (d), Hawaii Revised Statutes, to require that the dispensing of a pharmacist-prescribed opioid antagonist be reported to the State's Electronic Prescription Accountability System.)

Pilot Project Application(s)

The EO reported that she received 2 pilot project applications:

 Compounding for Office Use RBendazole Capsules for Rat Lung Disease – Pat Adams of Malama Compounding Pharmacy The Board discussed a request for a pilot project to supply a versatile dose of worm medicine to Hilo Medical Center to assist in the prevention of rat lung worm which they allege they are unable to obtain.

The Chair stated that it appears they are asking to be allowed to "compound" for smaller doses and that she didn't believe that a pilot project was necessary if the pharmacy receives a patient specific prescription.

Dean Ma stated that the latest information was that taking pin worm medication may be sufficient to prevent but should also be followed up with a physician.

Ms. Tokumaru stated it wasn't clear if there is a confirmed diagnosis and if this was for emergency or preventive measures?

Ms. Keefe stated that she believes that the FDA regulations on compounding prohibits the compounding of products that are already made.

The Chair stated that perhaps the dose is not available.

The EO stated that she doesn't understand why Hilo Medical Center's pharmacy does not order the drugs for the hospital?

After further discussion, it was the consensus of the Board to defer this for more clarifying information regarding the following:

- ✓ Is the drug needed for emergency or for preventive purposes?
- ✓ Why can't the practitioner write a patient specific prescription for the dose required?
- ✓ What "drug" will be "compounded"?
- ✓ Why can't hospital pharmacy provide RBendazole?
- ✓ What specific state laws/rules is this referring to?

Upon receipt of more information, the Board will re-review this request for a pilot project.

Pharmacy Technicians Scope of Practice – Kaiser

The Board discussed a request for a pilot project to allow a pharmacy technician to work at a Kaiser clinic that does not have an on-site pharmacy and/or pharmacist and who will be providing the following functions:

- Counting/inspection of inventory medication and remove/segregate expired or not properly stored medications;
- ✓ Ordering medications:
- ✓ Receive medications;
- ✓ Deliver and replenish medication;
- ✓ Stock emergency kits; and
- ✓ Remote order entry.

Kaiser is requesting a "waiver" to allow pharmacy technicians, performing noncompounding functions of non-controlled substances without immediate supervision by a pharmacist.

The Chair clarified that they are proposing to allow a pharmacy technician, unsupervised by a pharmacist and not working in a pharmacy, to perform activities that appear to be included in HAR §16-95-86 Scope of practice of a pharmacy technician, and that it appears that their "system" will act as a check and balances.

Ms. Keefe clarified that it appears the pharmacy technician will be stocking the ekits and also performing remote order entry.

After further discussion, upon a motion by the Chair, seconded by Ms. Tokumaru, it was voted on and unanimously carried to approve the pilot project effective immediately and approved for 6 months after which time Kaiser shall submit a written report on the results of the pilot project including report of any incidents.

Report on Pharmacy Working Group's January 23, 2020 Meeting

The EO reported on the January 23, 2020 meeting of the PWG at which time the following topics were discussed:

- ✓ 2020 Legislation (SB 2237 and SB 2919);
- ✓ Mandatory e-prescribing for controlled substances;
- ✓ Development of FAQs for USP <795>, <797> and <800>:
- Regulation of Pharmacy Technicians and Addressing Pharmacists Workload;
 and
- ✓ Discussion of HRS Chapter 328 with the DOH on pharmacist and pharmacy related functions.

Correspondence: Questions Regarding Hawaii Compounding Regulations

The Chair asked Ms. Keefe to lead the discussion on the following emailed inquiry:

"Can you provide me some information on your state board of pharmacy's position on:

1. Enforcing USP 800

- 2. Allowing CBD compounding
- 3. Regulating Veterinary Compounding
- 4. Allowing Compounding of commercially available products"

Ms. Keefe's responses were as follows:

- 1. Enforcing USP 800 USP 800 is informational only and not enforceable according to the FDA
- 2. Allowing CBD compounding No
- 3. Regulating Veterinary Compounding No
- 4. Allowing Compounding of commercially available products FDA prohibits the compounding of commercially available products

It was the consensus of the Board that they agreed with Ms. Keefe's responses.

NYTimes Article: How Chaos at Chain Pharmacies Is Putting Patients at Risk

The Chair asked Ms. Cross to summarize the article that describes the hazards of understaffed and chaotic workplaces and how that results in misfills where in some cases death occurred when a patient received the incorrect medication.

Telepharmacy Question

The Chair asked Ms. Tokumaru to lead the discussion on the following emailed inquiry:

"I am a pharmacist here on the Big Island and I have a group interested in establishing a pharmacy to meet the needs of the rural community of South Kona. With the closure of Oshima Pharmacy, patient access to their medications has been a challenging at best. I am wondering what the board's position is on telepharmacy? I see that there are some guidelines in regards to out-of-state telepharmacy but what about pharmacies already established on the island. For example, could a clinic pharmacy open up a satellite pharmacy in South Kona where it can be manned by a certified technician and overseen by a pharmacist remotely? This would greatly enhance services and increase access."

Ms. Tokumaru stated that HRS § 461-9 requires that a pharmacist be in personal and immediate charge in the pharmacy so if there is no pharmacist present in the pharmacy, no prescriptions may be filled, compounded or received and no drugs shall be sold.

It was the consensus of the Board that they agreed with Ms. Tokumaru's responses.

Finger Prick Blood Test for Lead and Heavy Metals by Pharmacist

The Board discussed the following emailed inquiry:

"My organization is introducing a new finger prick blood test for lead and heavy metals. The product is geared towards the pharmacy market as the pharmacy will administer the finger prick and send the results to our certified lab. Then our organization will follow up with the consumer. We are hoping you can help us with an understanding of

state regulations and compliance we need to adhere to begin this project. Any help or guidance will be greatly appreciated."

The Board reviewed the following statutes:

§ 461-1 Definitions.

"Practice of pharmacy" means: (partial definition)

- (1) The interpretation and evaluation of prescription orders; the compounding, dispensing, and labeling of drugs and devices (except labeling by a manufacturer, packer, or distributor of nonprescription drugs and commercially legend drugs and devices); the participation in drug selection and drug utilization reviews; the proper and safe storage of drugs and devices and the maintenance of proper records therefor; the responsibility for advising when necessary or where regulated, of therapeutic values, content, hazards, and use of drugs and devices; and the interpretation and evaluation of prescription orders to adjust the supply dispensed for purposes of medication synchronization pursuant to section 431:10A-606, 432:1-621, or 432D-30;
- (2) Performing the following procedures or functions as part of the care provided by and in concurrence with a "health care facility" and "health care service" as defined in section 323D-2, or a "pharmacy" or a licensed physician or a licensed advanced practice registered nurse with prescriptive authority, or a "managed care plan" as defined in section 432E-1, in accordance with policies, procedures, or protocols developed collaboratively by health professionals, including physicians and surgeons, pharmacists, and registered nurses, and for which a pharmacist has received appropriate training required by these policies, procedures, or protocols:
 - (A) Ordering or performing routine drug therapy related patient assessment procedures;

The EO asked if this test is considered a "routine drug therapy procedure"?

After further discussion, it was the consensus of the Board that finger pricking blood test for lead and heavy metals was not considered a routine drug therapy assessment procedure.

In accordance with HAR §16-201-90, the above interpretation is for informational and explanatory purposes only and based solely on the information provided. It is not an official opinion or decision and therefore not binding upon the Board.
