Executive Officer's Report:

a. Record of Candidates Examined: For the Examination for Professional Practice in Psychology ("EPPP")

EO Fernandez reported that during the period of February 15, 2020 to October 9, 2020 eight candidates took the EPPP exam; four passed and four failed.

b. <u>DCCA Disciplinary Actions Through July 2020</u>

EO Fernandez said that there were no disciplinary actions.

c. Report on the ASPPB EPPP Registration and Examination Schedule

EO Fernandez stated that at the Board's last meeting, Dr. Oliveira Gray asked what the status of examinations in Hawaii was. In response, he reached out to ASPPB for information and spoke to Candace Ohlmeier the Administrative Assistant for Examination Services and Governance. She said that Pearson Vue's exam facilitator had informed her that the Hawaii sites across the nation are still operating at 50% capacity with implemented social distancing requirements as required by each state's requirements. She also relayed a list of available dates for examination from Pearson Vue, which are as follows:

- 10/22/20 and 10/31/20
- 11/04/20 and 11/23/20
- 12/01/20, 12/07/20, 12/21/20 and 12/28/20
- 01/12/21, 01/20/21, 01/29/21 and 01/30/21

He further stated that the reason why he had contacted ASPPB was because a recent applicant had heard from a colleague that once they were authorized by the board, they could schedule an examination at any time. He was confirming his understanding that examinations were facilitated according to fixed dates, which we now know is correct. Additionally, ASPPB is currently not registering or scheduling exams due their transition into their new registration and scheduling system vendor called Certemy. The blackout period began September 30, 2020 and will end on October 15, 2020. Also, to clarify this will not affect Pearson Vue's facilitation of the examination.

Chair Sutherland-Choy asked if there are any members of the public who would like to provide oral testimony on this agenda item, to which Dr. Yael Gappell and Dr. Kameron Nelson raised their hands respectively.

Ms. Gappell thanked the Board and introduced herself as an applicant and that she would be glad to answer any questions that the Board may

have. She further stated that she has been a psychologist for many years in Israel and received her license in 1991. She has been in education psychology and clinical psychology and taught and supervised in psychotherapy. She was a director of psychological services in the city of Holon which has a population of 200,000 people. She understands that our system is different from Israel. In order to be a psychologist in Israel, you need a masters, which is equivalent to the Ph.D. in Hawaii according to U.H. Manoa's professor after reviewing her documents. She completed her internship in 2013, but it took at least a year to submit the paperwork that was required. She studied in 1980 and these documents were not in their computers. She feels that the education she received is similar to what is happening everywhere, and she has what it takes to be a psychologist.

Chair Sutherland-Choy thanked Dr. Gappell for providing testimony.

EO Fernandez told Dr. Gappell that the Board may call upon her if there are any questions when the Board is reviewing her application.

Dr. Nelson introduced herself and just wanted to say that she is an applicant and if the Board has any questions on her application that she will be available for any questions.

However, the definition of mental health counseling does not specifically include psychological testing, whereas the definition of psychology does. Does this mean that psychologists are permitted to do psychological testing, including the use of established psychological tests to diagnose particular disorders, whereas mental health counselors are not"?
