- Scope:a)E-mail inquiry from the Regulated Industries and Complaints<br/>Office (RICO) asking if an electrician's license and/or<br/>plumber's license is required to perform the work of

> removing an existing on-demand tankless gas water heater and install a new replacement.

> Chair Lucero asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

The Board reviewed the email inquiry and opened this agenda item up for discussion.

Mr. Wong stated that any plumbing equipment needs to be installed by a licensed plumber with a licensed electrician to install any necessary electrical wiring. Ms. Green asked if a tankless water heater connects to the potable water supply. Vice Chair Hiraki explained that a tankless water heater is tied-in directly from the cold/hot water line to potable water supply. Mr. Takara added that since it is a gas water heater it may or may not also have electrical wiring. Vice Chair Hiraki explained that ninety percent of all gas heaters have electrical conduits because they require a solenoid, as well as an electronic igniter. Mr. Wong added that tankless water heaters have a separate display to control the temperature which needs power, for the gas igniter and for the display to function. Also, depending on application, gas water heaters need outdoor ventilation because gases that are not piped correctly could be hazerdous. Chair Lucero agreed and stated that when electrical work is needed to install or remove the tankless water heater, a licensed electrician is required to perform the work.

Mr. Takahashi raised his hand and was recognized by Chair Lucero to present oral testimony.

Mr. Takahashi, Hawaii Electricians Market Enhancement Program, introduced himself. He stated that he agrees with the Board's determination. He requested for the Board's response to encompass that any electrical wiring services performed would require a licensed electrician.

Mr. Brady raised his hand and was recognized by Chair Lucero to present oral testimony.

Mr. Brady, Plumbers and Fitters Local 675, introduced himself. He added that he concurs with the Board's determination and discussion. Additionally, he requested for

> the Board's response to include that any fixtures or appliances connected to gas, domestic, or waste piping need to be installed by a licensed plumber.

After discussion, it was the Board's consensus to affirm that a tankless gas water heater requires a licensed plumber for installation and removal, as it connects to fuel systems and potable water-supply systems, as well as a licensed electrician if installation and removal requires electrical work to power the system.

<u>2021 Legislation:</u> a) S.B. 170, Relating to Electricians and Plumbers Establishes license requirements for electrician apprentices and plumber apprentices.

> Chair Lucero asked if any members of the public would like to provide oral testimony on this agenda item.

Mr. Takahashi raised his hand and was recognized by Chair Lucero to present oral testimony.

Mr. Takahashi provided the Board with a brief background on S.B. 170. He stated that he requested for the Senate to hold the bill to allow additional time for discussion. His understanding is that the Senate will not schedule a hearing for this bill. He noted that he is seeking support from the Board for registration licensing for apprentices in this field.

Mr. Brady raised his hand and was recognized by Chair Lucero to present oral testimony.

Mr. Brady added that he agrees in concept with S.B. 170 and is available if the Board has questions.

Chair Lucero stated that he felt that the Board should oppose S.B. 170 to allow additional time for discussion with all industry partners. Vice Chair Hiraki expressed that the Board should put further thought into bill and how it will reflect the future of the industry and how it will be enforced. He does not agree with passing a bill prematurely that cannot be enforced.

It was moved by Mr. Wong, seconded by Vice Chair Hiraki, and unanimously carried to oppose S.B. 170, Relating to Electricians and Plumbers.

b) Legislative Committee

Chair Lucero asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Ms. Green shared that, due to the COVID-19 pandemic and necessary modifications to the Legislative session and virtual hearings, there are strict deadlines in place for hearings and testimony. Bills are being introduced, hearings will be scheduled, and the Board's opinion may be needed before a bill can be discussed at the next Board meeting. She asked the Board if they would like to form a Legislative Committee, consisting of 2 or 3 Board members, in order to obtain the Board's opinion on a bill that may be scheduled for a hearing in the interim between Board meetings.

Mr. Takahashi raised his hand and was recognized by Chair Lucero to present oral testimony.

Mr. Takahashi asked if those in the industry will be allowed to participate in the Legislative Committee discussions to provide input on the bills. Ms. Green explained that there will be no public participation in Legislative Committee meetings. Mr. Takahashi further requested that the Committee should consider reaching out to the industry for input. He explained that the Board's opinion on a matter related to the industry carries a lot of weight with the Legislature and he would like the opportunity to be included in the discussion.
