 Call to Order, Public Notice,

Quorum:

There being a quorum present, Chair Nagashima called the meeting to order at 9:37 a.m. She conducted a roll call of board

members and staff.

Chair Nagashima, Ms. Bath, Ms. Hagerman, EO Doi, and DAG

Leong confirmed that they were present. She noted that today, Mr. Nicosia, Ms. Takahashi, and Ms. Akasaka-Toyama, will be assisting the Board as panelists with technical support for the virtual meeting. Ms. Teraoka will be taking the meeting minutes.

2. Approval of Minutes of the January 29, 2020 & June 18, 2020 Meetings:

Chair Nagashima asked if there were any comments or concerns regarding the Board minutes of the January 29, 2020 meeting.

<u>2020 & June 18</u>, Chair Nagashima requested the following correction to the minutes <u>2020 Meetings:</u> (bracketed material to be deleted, underlined material to be added):

On Page 5 under "a. Formation of Applications Review Committee," the last sentence of the second paragraph should read, "She informed the Board that a previous member, Samantha Meehan-Vandike did submit an application to be on the Board but recently had to withdraw her application as she <u>was</u> leaving Hawaii."

On Page 14, the time of the motion moving into executive session should read, "At [3:05 p.m.] 1:05 p.m., it was moved by Vice Chair Behnken, seconded by Ms. Bath, and unanimously carried to move out of Executive Session."

Chair Nagashima asked if there were any other comments or concerns regarding the Executive Session minutes of the January 29, 2020 meeting. There were none.

There being no further discussion or amendments to the minutes, upon a motion by Ms. Hagerman, seconded by Ms. Bath, it was voted on and unanimously carried to approve the Minutes of the January 29, 2020 as amended and the Executive Session Minutes as circulated.

Chair Nagashima asked if there were any comments or concerns regarding the Board minutes of the June 18, 2020 meeting.

Chair Nagashima requested the following corrections to the minutes.

On Page 5, fourth paragraph, the first sentence should read, "Vice Chair Behnken [said] stated that she believes that Dr. Olson is also asking for a policy for going forward and what the Board will accept in the long term for starting new programs."

On Page 15, twelfth paragraph, the second sentence should read, "The way she teaches is that she does the protocol and her

students watch her, then the students replicate the protocol and she observes them."

On Page 16, tenth paragraph, the second sentence should read, "In an apprenticeship program, [the instructor] sponsoring therapist can only teach a maximum of 10 apprentices."

On Page 20, twelfth paragraph, the second sentence should read, "For re-certifications, they must do an online class and do an inperson practical test using a monitor that measures depth and [temple] tempo."

Chair Nagashima asked if there were any other comments or concerns regarding the Board minutes of the June 18, 2020 meeting. There were none.

There being no further discussion or amendments to the minutes, upon a motion by Ms. Bath, seconded by Ms. Hagerman, it was voted on and unanimously carried to approve the Minutes of the June 18, 2020 as amended.

The Board moved out of order to agenda item 6a, New Business.

6. <u>New</u> <u>Business</u>:

a. <u>Email inquiry from Marisa Watanabe: Can massage students from UH Maui complete practical training hours in a lomilomi clinic?</u>

Chair Nagashima reviewed Ms. Watanabe's email inquiry and opened it up for discussion. Chair Nagashima noted that Ms. Watanabe included sections of Native Hawaiian Health Care Systems act in her email. DAG Leong clarified that this is a federal statute which allows native Hawaiian health care systems to operate. Provisions of these services are through direct contracts and grants through the federal government.

Chair Nagashima recalled this act coming about in the late 90's or early 2000's but thought it was limited to practitioners, students, and apprentices of the Hawaiian decent. She did not think it was open to those outside of the Hawaiian community. Chair Nagashima referenced page 12 of the PDF which states:

§ 11711. Definitions (10) Traditional Native Hawaiian Healer

The term "traditional Native Hawaiian healer" means a practitioner –

(A) who -

- (i) is of Hawaiian ancestry, and
- (ii) has the knowledge, skills, and experience in direct personal health care of individuals, and
- (B) whose knowledge, skills, and experience are based on demonstrative learning of Native Hawaiian healing practices acquired by
 - (i) direct practical association with Native Hawaiian elders, and
 - (ii) oral traditions transmitted from generation to generation.

Chair Nagashima wanted further clarification if this request is strictly for students of the Hawaiian decent who are completing their practical hours at Hui No Ke Ola Pono.

Chair Nagashima asked if there were any comments from the Board members or attendees.

Ms. Bath asked if the Board has previously taken a stance on this act requiring that the practicing massage therapist be licensed within the State?

DAG Leong stated that the practitioner is still required to be a licensed massage therapist with the State. He further clarified that there is a section in this federal act that states that it does not affect the ability of the State to require that the practitioner to still be licensed according to State law. The practitioner would still need to be a licensed massage therapist even though the provisions of the health services are directly coordinated with the federal government and through these health centers.

Ms. Bath asked for additional clarification if the massage therapists need to abide by State laws and be licensed?

DAG Leong affirmed that they need to be State licensed massage therapists.

Ms. Bath stated that there needs to be consistency in the requirements to follow to become a massage therapist and they should abide by the same requirements of other licensees.

DAG Leong reaffirmed that in order to practice as a massage therapist, regardless of this act, they would need to be licensed and that the federal act does not interfere with the State requirements.

EO Doi stated that the Ms. Watanabe's email explains that due to the pandemic the regular student clinic at the UH Maui College campus is unavailable. She is requesting to allow students to complete some of their practical hours at Hui No Ke Ola Pono's lomilomi clinic.

Chair Nagashima clarified that only the location of the clinic is changing. Ms. Watanabe is the Project Director of Kealaho'imai and is also affiliated with Hui No Ke Ola Pono. She is requesting the temporary exception to allow students to complete their hours at the lomilomi clinic since the UH Maui College's student clinic is unavailable at this time.

EO Doi stated that Ms. Watanabe's email is requesting for a permanent exception.

Chair Nagashima confirmed that the original request was for a temporary exception but now changed to a permanent location exception request.

Arlene Estrella, licensed massage therapist, introduced herself. She stated that she does not see a concern if the new permanent location abides by the massage establishment requirements and the Department of Health's sanitation rules. These rules are set in place to protect the community.

Chair Nagashima stated that according to this act, they are not required to have a massage establishment license.

Ms. Estrella expressed concern that the location could possibly be an outside venue with no running water.

Ms. Hagerman explained that Ms. Watanabe provided a description of clinic and what the facilities look like, which seem to be compliant.

Chair Nagashima does not want to grant a permanent exception but is willing to consider a temporary exception during pandemic until the Board can obtain legal advice and take a closer look into this act. She would like to review the entire statute and implications as this appears to be a comprehensive act.

Ms. Bath stated that she believes that the Board has previously discussed this topic. She feels that the training at the lomilomi clinic should be sufficient as long as the facility is clean and is

following the training guidelines outside of the fixed location of the massage therapy establishment. Ms. Bath feels that if the Board approved for an instructor or sponsor of an apprentice to work directly one-on-one at a residence, they should not have a problem with this request. She feels that this is a safer option than going onto a college campus full of students. Ms. Bath stated that she thinks this exception should apply this to anyone who is training during the pandemic.

Chair Nagashima stated that the Board previously approved to partially accept practical hours if the bulk of the foundational training was completed, which deemed to be about 70%. The 100 hours of the initial foundational training needed to be competed face-to-face.

EO Doi added that the rules state that practical hours are required to be completed in a classroom setting. However, due to the pandemic the student clinic at UH Maui College is not available, so Ms. Watanabe is requesting if they can complete their school training hours at the lomilomi clinic. EO Doi mentioned that the Board's stance from a previous discussion was that training for apprenticeships should be at a licensed massage establishment. The lomilomi clinic is not licensed so the Board should consider that as well.

Chair Nagashima stated that the June 18, 2020 minutes reflect that during the pandemic, the Board will accept up to 90 hours of virtual training which includes practical training provided that the student has learned the basic fundamental foundations of massage therapy. Chair Nagashima reiterated that she is not ready to accept this change on a permanent basis.

Ms. Estrella agreed with Chair Nagashima that this exception should only be allowed temporarily due to the pandemic. She asked if Ms. Watanabe explored other locations within the UH Maui campus to hold this clinic. She feels that the college campus is a safer venue for the students.

Chair Nagashima stated that the UH Maui College does not plan to re-open their student clinic to the public which is another reason why Ms. Watanabe wants to move the training to the lomilomi location because this would allow more access for the public to complete their practical training hours.

Chair Nagashima asked if there was any further discussion or

comments before the Board makes a motion.

Ms. Bath made a motion to allow Ms. Watanabe to work out of Hui No Ke Ola Pono on a temporary basis during the pandemic and to allow this exception for any other student in the future who presents a similar request to the Board.

Ms. Hagerman clarified that Ms. Watanabe not student. She is trying to request an exception for her massage therapy students.

Chair Nagashima stated that according to the June 18, 2020 minutes, the Board limited the number of practical hours that could be completed during the pandemic. She questioned whether Ms. Bath's motion is now opening up the number of practical hours with no limit?

Ms. Hagerman agreed that the Board had previously approved that students were to have completed 70% of their foundational training.

Chair Nagashima added that Board previously approved online didactic classes with the additional 90 hours of practical training during the pandemic and if Ms. Bath could put her motion in line with the previous determination.

Ms. Bath stated that she understood what the Board previously agreed to and asked for clarification if the Board is not willing to allow the training at the lomilomi clinic.

Chair Nagashima stated that the Board is willing to allow the training at the lomilomi clinic on a temporary basis.

Chair Nagashima asked if Ms. Bath has a definite motion or if not, she will present the motion.

Upon a motion by Chair Nagashima motion, seconded by Ms. Bath, it was voted on and unanimously carried to approve Ms. Watanabe's request to allow UH Maui College's students in massage therapy to perform practical training, up to 90 hours provided that they have competed at least 70% their foundation hours, at Hui No Ke Ola Pono during the pandemic only and this is not a permanent exception. Didactic hours for lessons will also be accepted for the current massage therapy students during the pandemic.

> Chair Nagashima noted that the email inquiry does not clarify how many training hours the existing students currently have. In order to do the practical hands-on training, the bulk of the 310 hours will be supervised hands-on practical training. The 90 hours allowed will only comprise about 30% of their training.

In accordance with HAR §16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision, and therefore is not to be viewed as binding on the Board or the Department of Commerce and Consumer Affairs.

The Board moved back to agenda item 3, Chapter 91, HRS Adjudicatory Matters.

3. Chapter 91, HRS – Adjudicatory Matters: At 10:29 a.m., Chair Nagashima recessed the Board's meeting to discuss and deliberate on the following adjudicatory matters, pursuant to Chapter 91, HRS:

 a. In the Matter of the Massage Establishment License of 123 Spa, LLC dba Waikiki Massage 123 Spa (MAS 2020-7-L) –

Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order

After discussion, it was moved by Chair Nagashima, seconded by Ms. Bath, and voted on and unanimously carried to approve the above-referenced settlement agreement.

At 10:33 a.m., the Board moved out of Chapter 91, HRS, and returned to its regular order of business.

Chair Nagashima conducted a roll call of board members and staff.

Chair Nagashima, Ms. Bath, Ms. Hagerman, EO Doi, and DAG Leong confirmed that they were present.

Chair Nagashima asked if any of the attendees would like to speak before the Board moves into Executive Session.

Laura Embleton, National Government Relations Director for Associated Body Work and Massage Professionals introduced herself. She stated that they currently have 1,300 members in Hawaii. She added that they have a lot of information to share in regard to what other Boards in other States are doing with their laws and rules and can be of assistance if needed.

Christine Hoober, American Massage Therapy Association introduced herself. She stated that she is happy to attend this meeting to see how things are done in Hawaii.

4. Applications

Executive Session:

At 10:38 a.m., it was moved by Chair Nagashima, seconded by Ms. Hagerman, and unanimously carried to move into Executive Session in accordance with HRS § 92-5(a)(1), "To consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section 26-9 or both".

At 11:36 a.m., it was moved by Chair Nagashima, seconded by Ms. Hagerman, and unanimously carried to move out of Executive Session

Chair Nagashima conducted a roll call of board members and staff.

Chair Nagashima, Ms. Bath, Ms. Hagerman, EO Doi, and DAG Leong confirmed that they were present.

a. Ratifications

Upon a motion by Chair Nagashima, seconded by Ms. Hagerman, it was voted on and unanimously carried to approve the attached ratification list.

b. Applications

1) Jason Appel

Upon a motion by Chair Nagashima, seconded by Ms. Hagerman, it was voted on and unanimously carried to approve Mr. Appel to sit for the Hawaii Massage Therapy Examination.

2) Fire Palace Inc.

Upon a motion by Chair Nagashima, seconded by Ms. Bath, it was voted on and unanimously carried to deny Fire Palace Inc.'s application for licensure pursuant to HRS §452-24(a)(9); §436B-19(5); and §436B-19(12).

HRS §452-24 (a), provides that:

In addition to any other actions authorized by the law, the board may take disciplinary action against any licensee, including, but not limited to, revocation, suspension, fine, or a combination thereof, or may refuse to grant or renew a license for any cause authorized by law, including but not limited to the following:

(9) Making a false statement on any document submitted or required to be filed by this chapter.

HRS §436B-19, provides that:

In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore, or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

- (5) Procuring a license through fraud, misrepresentation, or deceit; and
- (12) Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license.

3) Jessica Christensen

Upon a motion by Chair Nagashima, seconded by Ms. Bath, it was voted on and unanimously carried to approve Ms. Christensen to sit for the Hawaii Massage Therapy Examination.

4) Apollo Harris

Upon a motion by Chair Nagashima, seconded by Ms. Bath, it was voted on and unanimously carried to approve Mr. Harris to sit for the Hawaii Massage Therapy Examination.

5) Kela Pease

Upon a motion by Chair Nagashima, seconded by Ms. Bath, it was voted on and unanimously carried to approve Ms. Pease to sit for the Hawaii Massage Therapy Examination.

5. <u>Unfinished</u> Business:

a. Rule Revisions – Title 16, Chapter 84, Hawaii Administrative Rules: The Board will discuss revisions, including sanitation rules for massage therapists and massage therapy establishments.

Chair Nagashima stated that Senate bill no. 2878, Relating to Massage Therapy, was approved by the Legislature and presented to the Governor for signature. This bill will go into effect on September 15, 2020. She explained that the Board is now tasked with ensuring that proper sanitation guidelines are in place to support the new law.

Chair Nagashima opened this agenda item up for discussion. Ms. Hagerman felt that the draft was good and that it included everything that was previously discussed. Ms. Bath suggested to delete 2B and 3B which state:

- (2B) The massage therapy establishment shall be kept clean and in good repair, properly lighted and ventilated;
- (3C) The off-site location must be properly lighted and ventilated;

Ms. Bath suggested combining 2B and 3C as a new item, 1C. The Board agreed that the language was redundant and will remove 2B and 3B and replace it with the following amended language:

- (a) Toilet facilities shall be provided within 200 feet of any massage therapy establishment;
- (b) Cleaned and sanitized linens and instruments shall be used for all clients then sanitized again prior to use on another client; and
- (c) The massage therapy establishment shall be kept clean and in good repair, properly lighted and ventilated.

Ms. Bath expressed concerns regarding 1A which states:

(a) Toilet facilities shall be provided within 200 feet of any massage therapy establishment.

Her concern was if massage therapy establishments could ensure that toilet facilities are cleaned and sanitized properly when they are shared by multiple businesses. Chair Nagashima stated that they are not inclined to provide toilet facilities within their massage therapy establishments. However, they are inclined to provide hand washing facilities within the treatment areas. The massage therapy establishment should have their own procedures in place, should a client need to use the restroom. The massage therapy establishment is responsible to protect what occurs within their establishment, not outside. Toilet facilities were added to the sanitation rules as an extra layer of compliance.

Chair Nagashima added that the Board submitted their reopening guidelines to the Governor to be included in the supplemental order to allow massage therapists to safely reopen during the pandemic. They were advised to follow guidelines from the Center for Disease Control and Prevention ("CDC") and other national organizations that oversee the massage profession.

Ms. Hagerman asked if because of the pandemic is it a CDC requirement that when you enter an establishment, you need to be provided hand sanitizer? Chair Nagashima explained that requirement is not in CDC guidelines, it's in the American Massage Therapy Association ("AMTA's") guidelines and is a recommendation, not a mandate. Ms. Bath suggested adding the hand sanitizer requirement to the sanitation rules, however, Chair Nagashima expressed that would be too much of a restriction. DAG Leong added that the sanitation rules will become a part of standard administrative rule making process going forward, and should be general, not based off of the current pandemic. Chair Nagashima felt that they should not put further restrictions on the toilet facilities other than that they are available for use. She further stated that she has never heard of a problem with this and is inclined to keep as is since these are general guidelines.

Ms. Bath suggested amending 1A to state that:

(a) Toilet facilities shall be provided within 200 feet of any massage therapy establishment for massage therapy establishment clients.

Chair Nagashima disagreed with Ms. Bath's suggestion and stated that this language is not feasible to those who work in older buildings and are not able to install a toilet within their facility. Ms. Bath feels that a toilet should be provided, especially for those who

cater to older clients or clients with health conditions. Chair Nagashima reiterated that providing a toilet facility within 200 feet is reasonable and that the Board cannot require establishments to have a toilet within their facility. Inserting Ms. Bath's suggested language restricts the use of the toilet facility. The toilet facility should be open for use by other people in the building. Ms. Bath agreed and withdrew her suggestion. DAG Leong also agreed that the current language is better the way it is written rather than with Ms. Bath's suggestion. Chair Nagashima added that the rules need to be general and cannot be too restrictive.

Laura Embleton stated that most States have a requirement that a bathroom must be available within the vicinity but does not have to be provided within the massage establishment facility. She shared that Arkansas has incorporated some of its COVID guidelines into their regular rules such as: changing linens and washing hands between each client and keeping clean and dirty linens in separate receptacles. However, they are currently the only State that added COVID guidelines into their rules. Ms. Embleton agreed with Chair Nagashima that the bathroom must be located somewhere nearby, but not in the actual establishment.

Upon a motion by Chair Nagashima, seconded by Ms. Hagerman, it was voted on and unanimously carried to approve the sanitation guidelines as amended.
