Agenda: The agenda for this meeting was filed with the Office of the

Lieutenant Governor, as required by Hawaii Revised Statutes

("HRS") section 92-7(b).

A brief video was played to explain procedures for this virtual meeting and how members of the public can participate and

interact with the Board during the meeting.

Call to Order: Chairperson Komo welcomed everyone to the meeting and

proceeded with a roll call of the Board members. All Board members confirmed they were present with the exception of Mr.

Uemori and Mr. Aratani who were excused.

There being a quorum present, Chairperson Komo called the meeting to order at 8:32 a.m.

Chairperson Komo provided verbal instructions to attendees on how to connect to the meeting via internet or through phone access. He reminded attendees that all microphones will be muted. If anyone would like to speak, they should raise their hand and when called upon they will be limited to five minutes of testimony per agenda item.

Newly appointed Board member, Mr. Arbles, introduced himself to Board members and staff.

Chairperson Komo announced an amendment to the agenda, as follows: (with new material underscored in bold and repealed material bracketed and stricken through)

Approval of the Minutes of the April 30, 2021 Board Meeting:

Chairperson Komo asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

After discussion, it was moved by Mr. Punua, seconded by Vice-Chairperson Miyashiro, and unanimously carried to approve the April 30, 2021 meeting minutes, with the following amendments (with new material underscored in bold and repealed material bracketed and stricken through):

On page 4, tenth paragraph, first sentence:

"Mr. Roberts added there may be implications <u>regarding</u> <u>possible</u> activity. With respect to whether the report is acceptable, the matter would have to be referred to the Commissioner.

On page 7, first paragraph, first sentence:

"Mr. Aratani reported that the Senate Bill 1103, HD1 was passed by the [Legislator] Legislature and is now enrolled to the Governor's office to be reviewed. He added that during the Conference Committee meeting, the defective date has been changed to "upon approval"."

At 8:43 a.m., it was moved by Mr. Roberts, seconded by Vice-Chairperson Miyashiro, and unanimously carried to enter into Executive Session to consider and evaluate personal information

relating to individuals applying for licensure in accordance with HRS section 92-5(a)(1), and to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities in accordance with HRS section 92-5(a)(4). (Note: Board and staff moved to Teams.)

#### **EXECUTIVE SESSION**

At 8:52 a.m., it was moved by Mr. Punua, seconded by Vice-Chairperson Miyashiro, and unanimously carried for the Board to move out of Executive Session.

#### B. Ratification of Individual CPA Permit to Practice

Mr. Roberts left the meeting at 8:55 a.m., and returned shortly thereafter at 8:56 a.m.

After discussion, it was moved by Mr. Punua, seconded by Vice-Chairperson Miyashiro, and unanimously carried, noting Mr. Lee recused from discussion and voting on this application, to ratify the following permit to practice:

#### Old Business:

Chairperson Komo asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

## A. <u>Inquiry from Mike Ching – Audit Reports Provided to the</u> Hawaii Insurance Division

Chairperson Komo briefed the Board regarding Mr. Ching's inquiry that was discussed at its last meeting.

DAG Leong further looked into the matter and stated that he is of the opinion there is no conflict between the administrative rules of the Board and the Insurance Division as previously suggested.

Chairperson Komo concurred with DAG Leong's comment that the Board will stand its previous ruling: in the case of reports presented to the Commissioner, there needs to be a Hawaii-licensed CPA for the firm that is issuing the audit report or responsible for signing the report.

Mr. Roberts brought forward a matter regarding reports that were already issued that may not have been signed by a Hawaii-licensed CPA; however, he noted this matter is not unique to the insurance industry.

Mr. Robert suggested further coordination in the Department of Commerce and Consumer Affairs to make known there are two areas of compliance, the requirements of the Insurance Division, and of the Board. EO Kleinhans responded that he will reach out to the Insurance Division.

Chairperson Komo asked DAG Leong whether the Board can provide guidance to other divisions. DAG Leong responded that it is not the within the Board's authority to opine on filings with the Insurance Division.

Ms. Ito indicated that if the Board has copy of the filings, and deemed that there may be possible unauthorized practice of accountancy, the matter may be referred to Regulated Industries Complaints Office ("RICO") for investigation.

After discussion, the Board asked that EO Kleinhans reach out to the Commissioner regarding the possible conflict of both rules, and possibly sending out informational notice to other divisions.

Chairperson Komo asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

# A. <u>Contractor Licensing Board Requirement of Signed Financial Statement</u>

Chairperson Komo briefed the Board on an inquiry where a company had applied for a contractor license, but the financial statement was not accepted because the signature of the CPA did not match the financial statement filed separately by the CPA firm.

Acting Supervising EO Ito who is the Executive Officer of the Contractor Licensing Board was present at the meeting and indicated that what Chairperson Komo described is acceptable by the Contractor Licensing Board.
