1. Call to Order,

Public Notice, Quorum: There being quorum present, Chair Nagashima called the

meeting to order at 9:34 a.m. She conducted a roll call of Board

members and staff, all were present.

Chair Nagashima asked if anyone from the public would like to introduce themselves. Chair Nagashima recognized Laura Embleton, the national government relations director for Associated Bodywork

and Massage Professionals.

Chair Nagashima recognized Derek Gill, who stated he is attending

the meeting to support his application.

Chair Nagashima asked if there were any comments or concerns regarding the minutes of the January 27, 2021 meeting.

Upon a motion by Ms. Bath, seconded by Vice Chair Hagerman, it was voted on and unanimously carried to approve the open session minutes of the January 27, 2021 meeting as is.

a. In the Matter of the Massage Therapist's License of George W. Payne (MAS-2019-54-L) – Hearings Officer's Findings of Facts Conclusions of Law, and Recommended Order Final Order

Chair Nagashima asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Upon a motion made by Chair Nagashima, seconded by Ms. Bath, it was voted on and unanimously carried to defer this item until the April 6, 2021 meeting.

Recess:

At 9:42 a.m. a recess was called to discuss Chapter 91 Adjudicatory Matters.

Reconvened:

At 10:06 a.m., Chair Nagashima conducted a roll call. All board members were present.

4. Applications:

Chair Nagashima asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

## a. Ratifications

Upon a motion by Chair Nagashima, seconded by Vice Chair Hagerman, it was voted on and unanimously carried to approve the ratification list.

Executive Session:

At 10:10 a.m., upon a motion by Chair Nagashima, seconded by Ms. Bath, it was voted on and unanimously carried to move into Executive Session in accordance with HRS § 92-5(a)(1), "To consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section 26-9 or both".

At 10:50 a.m. the Board moved back into open session.

Chair Nagashima conducted a roll call and all members were present.

2. Approval of Executive Session Minutes

of the January 27, 2021 Meeting: Upon a motion by Chair Nagashima, seconded by Ms. Bath, it was voted on and unanimously carried to approve the Executive Session minutes of the January 27, 2021 meeting as is.

Chair Nagashima returned to agenda item 4, Applications.

# 4. Applications: b. Applications

## 1) Maui Academy of Healing Arts

Upon a motion by Chair Nagashima, seconded by Vice Chair Hagerman, it was voted on and unanimously carried to defer Maui Academy of Healing Arts application pending additional information.

#### 2) Lomino Hawaii Massage School

Upon a motion by Chair Nagashima, seconded by Vice Chair Hagerman, it was voted on and unanimously carried to defer Lomino Hawaii Massage School application for the breakdown and clarification of 480 hours provided in curriculum.

#### 3) Shiloh Burrows

Upon a motion by Chair Nagashima, seconded by Ms. Bath, it was voted on and unanimously carried to approve the CPR certification and exam waiver for Ms. Burrows.

#### 4) Derek Gill

Chair Nagashima recognized Derek Gill.

Mr. Gill introduced himself to the Board, asking if members had questions about his application.

Chair Nagashima asked when the applicant graduated from the Rolf Institute.

Mr. Gill stated he initially graduated from the Rolf Institute in 2007 and completed advanced training courses in 2011.

Chair Nagashima asked Mr. Gill if he has been active in the massage profession.

Mr. Gill responded in the affirmative. Mr. Gill stated that he started a school of Structural Integrators. Mr. Gill also serves on the committee for the International Association for Structural Integrators.

Mr. Gill stated that he and other students who graduated from Rolf Institute do not have permission to use the name; therefore, they are called Structural Integrators.

Chair Nagashima asked what type of courses one takes to become an instructor of Structural Integration.

Mr. Gill stated for those who would like to open a Structural Integration Institute, applicants would be required to have seven years of practical experience and 300 hours of continuing education and prior teaching experience. However, the teaching experience does not need to be in Structural Integration.

Chair Nagashima asked if there were any other comments. There were none.

Upon a motion by Chair Nagashima, seconded by Vice Chair Hagerman, it was voted on and unanimously carried to approve Mr. Gill's application.

## 5) Tracy Ash

Upon a motion by Chair Nagashima, seconded by Ms. Bath, it was voted on and unanimously carried to approve Ms. Ash's application.

# 6) Christi Lippman

Upon a motion by Chair Nagashima, seconded by Vice Chair Hagerman, it was voted on and unanimously carried to defer Ms. Lippman's application pending additional documentation of 170 practical hours.

#### 5. Executive Officer's Report

Chair Nagashima asked if any members of the public would like to

provide oral testimony on this agenda item. There were none.

- a) HB 223, HD 1, Relating to Massage Therapists. Beginning July 1, 2022, requires massage therapy licensees to complete twelve hours of continuing education within the two-year period preceding the license renewal date, of which two hours shall include first aid, cardiopulmonary resuscitation, or emergency related courses. Effective 1/1/2050. (HD1)
- b) SB 599, SD 1, Relating to Massage Therapists. Beginning July 1, 2024, requires massage therapy licensees to complete twelve hours of continuing education within the two-year period preceding the renewal date, two hours of which shall include first aid, cardiopulmonary resuscitation, or emergency related courses. (SD1)

EO Doi stated the Board is tracking bills HD 223 HD1 and SB 599 SD1. The bills both cover CPR requirements for massage therapy. Licensees would be required to complete twelve hours of continuing education within the two-year period preceding the renewal date, two hours of which shall include first aid, cardiopulmonary resuscitation, or emergency related courses. The difference between the bills is HB 233 HD 1's implementation date is July 1, 2022 and SB 599 SD 1's implementation date is July 1, 2024.

#### 6. New Business

a. Email from Dr. Mark Olson: Federation of State Massage Therapy Boards ("FSMTB") Model Massage Therapy Practice Act

Chair Nagashima asked if any members of the public would like to provide oral testimony on this agenda item.

Chair Nagashima recognized Mark Olson.

Mr. Olson introduced himself to the Board, stating he wanted to share information about the Model Massage Therapy Practice Act (MMTPA). He asked if the Board was aware of the Act.

Chair Nagashima responded in the affirmative. Chair Nagashima stated the MMTPA is to create a standard across the nation. States were requiring anywhere from 200 hours to 1,000 hours for requirements. There are many states working on creating a licensing act, however states are currently using the MMTPA as a framework.

Chair Nagashima stated Hawaii follows the MMTPA guidelines with a

few exceptions.

Chair Nagashima mentioned the MMTPA guidelines have a seven (7) member Board, with five (5) practicing therapists and two (2) public members. The Hawaii Board of Massage Therapy has a five (5) member board with three (3) practicing therapists and two (2) public members.

Chair Nagashima brought up Section 302: Qualifications for Licensure by Endorsement, which allows applicants who are licensed in another state to go to another state and get a license without having to submit an additional application.

Chair Nagashima mentioned that the American Massage Therapy Association ("AMTA") has a chapter in every state and all chapters are aware of the MMTPA. She mentioned states use the MMTPA as a guideline to licensure.

Chair Nagashima asked Mr. Olson for his feedback on the Massage Practice Act and if there was something that the state of Hawaii is not following.

Mr. Olson stated that he was satisfied with the overview and information provided by Chair Nagashima.

Chair Nagashima stated that she does not know when all 50 states will come to an agreement on requirements.

Ms. Bath asked Mr. Olson if he had anything he wanted to present to the Board regarding the MMTPA.

Mr. Olson stated he wanted to make the Board aware of the information and hear comments. Additionally, he said he is trying to create a program curriculum that is accepted across all states.

Mr. Olson expressed concern about Hawaii apprenticeship training hours being accepted at other schools.

Chair Nagashima shared that Hawaii is the only state with an apprenticeship program. The program allows Native Hawaiian practitioners to share knowledge and alleviate financial hardship of massage schools.

Chair Nagashima mentioned a bill was introduced by the Kupuna

Council which proposed that lomilomi practitioners be recognized separately from the apprenticeship program.

Chair Nagashima recognized Derek Gill.

Mr. Gill stated that Florida has an apprenticeship program.

Chair Nagashima recognized Mr. Olson.

Mr. Olson commented that Hawaii and Florida are the only two states with an apprenticeship program. He asked if it could be a requirement for Hawaii apprenticeship sponsors to make apprentices aware that hours completed in a Hawaii apprenticeship will not be accepted in other states.

DAG Leong noted that reminders would be the best way.

Due to time constraints Chair Nagashima ended the discussion stating further comments or concerns can be directed to EO Doi.

## 7.<u>Unfinished</u> Business:

a. Rule Revisions – Title 16, Chapter 84, Hawaii Administrative Rules: The Board will discuss revisions, including sanitation rules for massage therapists and massage therapy establishments (bracketed material to be deleted, underlined material to be added):

Chair Nagashima asked if any members would like to provide testimony on this agenda item. There were none.

Chair Nagashima reviewed Subchapter 3, which covers training and exam requirements of licensure in the State of Hawaii.

Chair Nagashima reviewed the Hawaii's 570 hours of education required for licensure, which consists of 50 hours of anatomy, physiology and kinesiology; 100 hours of theory and demonstration; and 420 hours of practical massage training, which may be obtained through apprenticeship. The practical massage training in an apprenticeship consists of 110 hours of office procedures, including 70 hours of clinical operation, 40 hours of advanced techniques including observation and patient consultation, as well as 310 hours of supervised massage.

Chair Nagashima shared that she researched other states and compared education requirements. She also looked at the Massage and Bodywork Licensing Examination ("MBLEX") 500 hours program and the National Certification Board for Therapeutic Massage and

Bodywork ("NCBTMB") 625-hour program.

Chair Nagashima stated she would like to review the hands-on and applied science hours.

Chair Nagashima noted Hawaii does not include CPR in the curriculum, however, other states include CPR as a part of the professionalism and ethics hours.

Chair Nagashima mentioned she has been reviewing the category requirements and noticed that Hawaii's naming classifications are different.

Chair Nagashima gave an overview of the NCBTMB 625-hour program requirements. She provided a breakdown stating 20 percent in modalities, techniques, and manual forces equaling 125 hours, 25 percent covers applied sciences (anatomy, physiology and kinesiology) which consist of 156.25 hours; 15 percent covers communication and documentation 93.75 hours; 10 percent in professionalism and ethics equaling 62.5 hours; 5 percent in laws and business practices equals 31.25 hours; 25 percent in client assessment and treatment which equals 156.25 hours.

Chair Nagashima asked for comments.

Ms. Bath commented that she would like to have continuity of language when making revisions.

Chair Nagashima stated she would like to decrease the hands-on hours and increase the hours required for applied science.
