8. Request for CE Program

Dr. Au mentioned that the continuing education ("CE") for 2018 AKOA Annual Conference listed by index #19-010 is from 2018. It was noted that this CE course was submitted by Dr. Christopher Caudwell for credit. He had taken the course and was checking if had been previously approved.

Regional and national optometry associations are automatically approved and so EO Fernandez questioned if it was necessary to go through the approval process for these associations that are automatically approved. Dr. Au stated that practice management and diagnostic courses do not count as TPA courses.

Dr. Shoji concurred that even though these associations pay and the CEs are automatically approved, the Board must determine how many hours qualify for TPA. He questioned if the process should be looked at. The subject was deferred and may be considered at a future meeting.

Regarding #19-011: Vision Expo and Conference East 2019, Dr. Chin request more time to review the submission. He noted that the submission packet was large and would require more time to address.

After due consideration of the information received for each course for review, and upon a motion by Dr. Loo, seconded by Dr. Shibayama, the Board unanimously carried to approve courses #19-009; #19-010; #19-012, and to defer #19-011: Vision Expo and Conference East 2019 pending full review at the Board's next publicly noticed meeting.
