a. <u>Discussion of "Qualifications" of Continuing Competence Unit ("CCU")</u> Presenters

Chair Tamayo noted that when she reviews requests from CCU Presenters, sometimes it's very clear what their training and the expectations would be, but the Board does not have a clear-cut qualification for the instructors.

Mr. Turner noted that generally the course instructor provides a biography (i.e. degree, background certification) and suggested that the instructor provides a CV or resume.

Chair Tamayo informed members that other state boards of physical therapy hire an outside agency that reviews the courses.

Mr. Turner read the following from the Board's:

c. Be developed and presented by qualified individuals (the provider or agency shall provide evidence of the individual's experience, education, and training to competently teach the activity).

Mr. Turner suggested that the criteria for the applicant should include: How many years of experience, in what type of setting, education (i.e. degree), and what specific training does the instructor has to competently teach the activity.

Mr. Turner suggested that the Board set up a sub-committee to establish the criteria.

Chair Tamayo volunteered and will contact third party groups and bring her findings to the next Board meeting.
