1. Call to Order: There being a quorum present, Chair Nagashima called the meeting to

order at 9:34 a.m.

2. Approval of Minutes of the May 5, 2021

Meeting:

Chair Nagashima asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Upon a motion by Ms. Okura, seconded by Vice Chair Hagerman, it was voted on and unanimously carried to approve the minutes of the

May 5, 2021 meeting as circulated.

Chair Nagashima asked if there were any comments or concerns regarding the Executive Session minutes of the May 5, 2021 meeting.

There were none.

Upon a motion by Chair Nagashima, seconded by Ms. Bath, it was voted on and unanimously carried to approve the Executive Session minutes of the May 5, 2021 meeting as circulated.

#### 3. Applications:

Chair Nagashima asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

## a. Ratifications (see attached Addendum)

Upon a motion by Chair Nagashima, seconded by Vice Chair Hagerman, it was voted on and unanimously carried to approve the attached ratification list.

#### b. Applications

## Executive Session:

At 9:39 a.m., it was moved by Chair Nagashima, seconded by Ms. Bath, and unanimously carried to move into Executive Session in accordance with HRS, § 92-5(a)(1) and (4), "To consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section 26-9 or both;" and "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities."

At 10:08 a.m., it was moved by Chair Nagashima, seconded by Ms. Okura, and unanimously carried to move out of Executive Session.

#### 1) Michelle Daniel

Upon a motion by Chair Nagashima, seconded by Ms. Okura, it was voted on and unanimously carried to approve Ms. Daniel to sit for the Hawaii Massage Therapy examination.

#### 2) Quantum School of Massage & Holistic Health

Upon a motion by Chair Nagashima, seconded by Vice Chair Hagerman, it was voted on and unanimously carried that based on the review of Quantum School of Massage & Holistic Health's application and supporting documents, the school's curriculum meets the Board's minimum education and training hours required for an applicant to obtain a license in massage therapy. The Board directed the EO to issue an approval letter valid through the DOE licensure period from September 1,

2021 through August 31, 2023.

## 3) IBS School of Cosmetology and Massage

Upon a motion by Chair Nagashima, seconded by Ms. Okura, it was voted on and unanimously carried that based on the review of IBS School of Cosmetology and Massage's application and supporting documents, the school's curriculum meets the Board's minimum education and training hours required for an applicant to obtain a license in massage therapy. The Board directed the EO to issue an approval letter valid through the DOE licensure period from September 1, 2021 through August 31, 2023.

#### 4) Institute of Clinical Acupuncture and Oriental Medicine

Upon a motion by Chair Nagashima, seconded by Vice Chair Hagerman, it was voted on and unanimously carried that based on the review of the Institute of Clinical Acupuncture and Oriental Medicine's application and supporting documents, the school's curriculum meets the Board's minimum education and training hours required for an applicant to obtain a license in massage therapy. The Board directed the EO to issue an approval letter valid through the DOE licensure period from September 1, 2021 through August 31, 2023.

#### 5) Healing Touch Massage Institute

Upon a motion by Chair Nagashima, seconded by Vice Chair Hagerman, it was voted on and unanimously carried that based on the review of Healing Touch Massage Institute's application and supporting documents, the school's curriculum meets the Board's minimum education and training hours required for an applicant to obtain a license in massage therapy. The Board directed the EO to issue an approval letter valid through the DOE licensure period from September 1, 2021 through August 31, 2023.

#### 6) Hawaii Massage Academy

Upon a motion by Chair Nagashima, seconded by Ms. Okura, it was voted on and unanimously carried that based on the review of Hawaii Massage Academy's application and supporting documents, the school's curriculum meets the

Board's minimum education and training hours required for an applicant to obtain a license in massage therapy. The Board directed the EO to issue an approval letter valid through the DOE licensure period from September 1, 2021 through August 31, 2023.

## 7) Aisen Shiatsu School

Upon a motion by Chair Nagashima, seconded by Vice Chair Hagerman, it was voted on and unanimously carried that based on the review Aisen Shiatsu School's application and supporting documents, the school's curriculum meets the Board's minimum education and training hours required for an applicant to obtain a license in massage therapy. The Board directed the EO to issue an approval letter valid through the DOE licensure period from September 1, 2021 through August 31, 2023.

## 8) Elite Massage Academy

Upon a motion by Chair Nagashima, seconded by Ms. Okura, it was voted on and unanimously carried that based on the review of Elite Massage Academy's application and supporting documents, the school's curriculum meets the Board's minimum education and training hours required for an applicant to obtain a license in massage therapy. The Board directed the EO to issue an approval letter valid through the DOE licensure period from September 1, 2021 through August 31, 2023.

#### 4. Executive Officer's

Report:

a. <u>Appreciation of Jodi Hagerman's service to the Board of Massage</u> Therapy

Chair Nagashima asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

EO Doi extended gratitude to Ms. Hagerman on behalf of the Board and DCCA. EO Doi mentioned two public member positions are open on the Board. Those interested can apply on the Office of the Governor's website.

# 5. New Business:

a. Discussion of Continuing Education ("CE") rulemaking

Chair Nagashima asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

EO Doi shared an example of the Board of Dentistry's continuing education rules.

EO Doi explained that beginning on the July 1, 2024 renewal cycle, massage therapy licensees will be required to complete twelve hours of continuing education within the two-year period preceding the renewal date, of which two hours shall include first aid, cardiopulmonary resuscitation, or emergency related courses.

Chair Nagashima asked if a notice of the new requirement will be posted to the Board's website.

EO Doi responded in the affirmative.

Chair Nagashima asked if the licensee is required to turn in documentation of CE courses at the time of renewal.

EO Doi stated the licensee will attest to completing the required CE credits, however, if randomly audited the licensee will need to provide proof of documentation. If documentation cannot be provided, the licensee is in violation of the rules and the Regulated Industries Complaints Office ("RICO") will be notified.

Board members discussed ideas for CE rule revisions. Ms. Bath noted that the guidelines for acceptable CE courses should be broad and flexible as each massage therapist specializes in various techniques. Chair Nagashima stated that professional development and ethics courses could be options. Ms. Okura noted that the courses should aim to enhance the skills of the massage therapist and that practice-building business courses not be accepted. Chair Nagashima noted that the course should be at least 50 minutes. Ms. Okura suggested that online CE courses should be accepted. Ms. Okura noted that if the licensee takes more than two hours of first aid, CPR, or emergency related courses, only two of those hours should be counted towards the renewal requirement. Chair Nagashima explained that the CPR course should be consistent to what is in the existing massage rules. EO Doi agreed to provide a draft of CE rule revisions based on the suggestions that were discussed.

# 6. <u>Unfinished</u> Business:

# a. Rule Revisions – Title 16, Chapter 84, Hawaii Administrative Rules

Chair Nagashima asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Chair Nagashima reviewed the course breakdowns provided by the Board members. She stated that the breakdowns followed what was discussed at past Board meetings, which proposed increasing the required education and training hours to 625 hours.

Chair Nagashima noted Ms. Bath's suggestion that theory such as Five Elements be added to Massage Theory & Practice section.

Chair Nagashima stated the Board will be moving forward with the rule revisions.

Chair Nagashima asked for input on Subchapter 4, Definitions.

EO Doi asked the Board to review the definitions for Principal Massage Therapist ("PMT") and Responsible Principal Massage Therapist.

Ms. Bath stated when the rule revision discussions previously took place, she was opposed to having a PMT, stating individual licensees should be held accountable for their own actions, not the PMT. The only exception would be when an apprentice is studying under a sponsoring massage therapist.

Ms. Bath concluded she would like the definitions of "principal massage therapist" and "responsible principal massage therapist" to be removed from the rule revisions draft.

Ms. Okura agreed with Ms. Bath's statement, stating individual licensees should be held accountable for their own actions, regardless if working under a massage therapy establishment.

Chair Nagashima stated the Board will need to look at the statutes and rules if the PMT definition is removed.

The Board agreed to review the rule revisions for further discussion at the next Board meeting.

Due to schedule conflicts, the July 22, 2021 Board meeting has been cancelled. The Board's next meeting will be held August 11, 2021. The public is advised to check the Board's website for meeting updates.
