Call to Order: There being a quorum present, the meeting was called to order at

Approval of the **Board Minutes:**  It was moved by Chair Denis, seconded by Mr. Collins, and unanimously carried to approve the open session and executive session minutes of the June 12, 2021 meeting.

#### B. Guard Employees

#### 1. Rodney Wong

After due consideration of the information received, it was moved by Mr. Collins, seconded by Chair Denis and unanimously carried to approve Rodney Wong's application for licensure subject to certain conditions.

The Board based its decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and files of Mr. Wong's application:

#### HRS §436B-19 provides that:

In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore, or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

(14) Criminal conviction, whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions, or duties of the licensed profession or vocation.

For reasons contained in the records and files of Rodney Wong's application, the Board placed the following conditions on his conditional license:

- 1) Mr. Wong shall comply with all of the terms and conditions of his probation.
  - a. Mr. Wong shall provide the Board with semiannual progress reports from his probation officer. The progress reports shall indicate whether he is complying with the terms and conditions of his probation
- 2) Upon completion of his terms, submit proof of discharge to the Board. If Mr. Wong's probation is amended in any way or is revoked:
  - a. Mr. Wong shall report any such amendment or revocation to the Board within (30) calendar days of the amendment or revocation; and
  - If Mr. Wong fails to timely notify the Board of such amendment or revocation, his conditional registration shall be automatically revoked without a hearing on the 30<sup>th</sup> day after the date of the amendment or the date his probation/parole was revoked, as applicable; and
- 3) Mr. Wong shall submit an annual FBI national criminal history record check and State of Hawaii criminal history record check from the Hawaii Criminal Justice Data Center ("criminal abstracts") to the Board.

- These criminal abstracts shall be due on January 31<sup>st</sup> of each year and shall cover the periods of January to December.
- In order to obtain these criminal abstracts, Mr.
   Wong shall be fingerprinted electronically at Fieldprint Inc. at his own cost and expense;
   and
- 4) Mr. Wong shall refrain from any actions that may result in his arrest or conviction for any crimes against persons or property (including, but not limited to: theft, burglary, assault, etc.)
  - a. Mr. Wong shall report any such arrests or convictions to the Board within thirty (30) calendar days of the arrests or convictions; and
  - b. If Mr. Wong fails to timely notify the Board of such arrests or convictions, his conditional registration shall be automatically revoked without a hearing on the 30<sup>th</sup> day after the date of the arrests or convictions.
