Agenda: The agenda for this meeting was filed with the Office of the Lieutenant

Call to Order: The meeting was called to order at 12:06 p.m. by Chairperson Severson,

at which time a quorum was established.

Chairperson Severson proceeded with roll call. All Board members

confirmed that they were present.

Minutes of the

Board Meeting:

It was moved by Vice-Chairperson Williams, seconded by Mr. Murata, September 28, 2021 and unanimously carried to approve the minutes of the September 28,

2021 meeting as circulated.

Chairperson Severson asked if any members of the public would like to <u>Licensing:</u>

provide oral testimony on this agenda item. There were none.

At 12:08 p.m., it was moved by Mr. Murata, seconded by Vice-Chairperson Williams, and unanimously carried for the Board to enter into Executive Session to consider and evaluate personal information relating to individuals applying for licensure in accordance with HRS section 92-5(a)(1), and to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities in accordance with HRS section 92-5(a)(4). (Note: Board members and staff entered into Microsoft Teams).

EXECUTIVE SESSION

At 12:20 p.m., it was moved by Vice-Chairperson Williams, seconded by Chairperson Severson, and unanimously carried for the Board to move out of Executive Session. Board members and staff returned to the Zoom meeting.

A. <u>Application for Exam & License</u>

i. Barber – Woessner, Heide

Vice-Chairperson Williams stated that she knows the applicant but is capable of voting fairly and objectively.

It was moved by Ms. Hall, seconded by Mr. Murata, and unanimously carried to approve the barber application for exam and license of Heidi Woessner.

B. Application for License

i. Beauty Shop – Beauty by Jasmine LLC

It was moved by Vice-Chairperson Williams, seconded by Ms. Hall, and unanimously carried to approve the beauty shop application for license of Beauty by Jasmine LLC.

C. Ratification of Issued Licenses

It was moved by Chairperson Severson, seconded by Mr. Murata, and unanimously carried to ratify the list of issued licenses attached (see, attached list).

Executive Officer's Report:

Executive Officer Yam asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

A. Results of the State NIC Examination Administered September 2021

Executive Officer Yam provided the following results:

B. 2021 Renewal

Executive Officer Yam stated that the Board of Barbering and Cosmetology's renewal deadline is December 31, 2021. Renewal postcard reminder will be mailed out on November 5, 2021. Online and hardcopy renewals will be accepted from November 8, 2021 to December 31, 2021.

C. Status on the Proposed Administrative Bill

Executive Officer Yam reported that the legislative proposal is still being reviewed by multiple agencies. Several concerns were raised, such as:

1) Barber Student Definition

Executive Officer Yam stated that the barber student definition was not included in the legislative proposal. The following definition was added to § -2:

"Barber student" means a person enrolled in a barber school who is engaged in learning to be a barber and while learning assists in the practice of barbering.

2) Education Equivalent to the Completion of High School

Executive Officer Yam stated that concerns were raised regarding § -6(i), which provides that:

The board may consider barber and beauty training obtained in another jurisdiction by an applicant to determine satisfaction of an education equivalent to the completion of high school. The board shall make a determination as to whether or not to recognize the training by evaluating the type and duration of the training.

For background information, Executive Officer Yam stated that the Board previously received inquiries from students who completed home school or online school and asked whether it would be considered equivalent to the completion of high school. During the permitted interaction group ("PIG") meetings, members noted that the Board's position is that a high school diploma or a GED is required to satisfy the education requirement and in the past the Board required applicants that completed home school or online school to provide verification that their education program is recognized by the United States Department of Education ("US DOE") or the Hawaii State Department of Education. Members proposed that § -6(i) be added to the draft of the legislative proposal during the PIG discussion and noted that the intent was to provide the Board latitude to consider applicants that may have adequate training but did not complete education equivalent to the completion of high school.

Concerns were raised regarding the language of § - 6(i), as it may create an unfair advantage for out-of-state applicants to be able to use their barber or beauty training to satisfy the minimum education requirement, while Hawaii applicants must have an education equivalent to the completion of high school.

The Board may consider removing § -6(i) entirely or consider amending the language to address the concern.

Executive Officer Yam noted that Hawaii Administrative Rules ("HAR") §16-78-20(b), provides that:

Beauty operator applicants shall have an education equivalent to the completion of high school. One year of experience as a licensed beauty operator in another jurisdiction shall satisfy the high school education requirement. (Emphasis added)

The Board may consider amending § -6(i) as:

One year of experience as a licensed barber, beauty operator, or instructor in another jurisdiction shall satisfy the high school education requirement.

After discussion, the Board agreed by consensus to remove § -6(i) and will further clarify the rules on what is considered equivalent to the completion of high school in the future.

Executive Officer Yam reported the Board discussed the following in the previous meeting:

1) Age Requirement

Concerns were raised that a sixteen-year-old would not be able to obtain a high school diploma or an education equivalent to the completion of high school and the age of majority is eighteen years old pursuant to HRS §577-1.

The Board would prefer seventeen years old if it is required to raise the minimum age requirement in the legislative proposal; however, the Board does not oppose to raising the minimum age requirement to eighteen years of old.

2) Medical Clearance

Concerns were raised that the legislative proposal did not include a similar medical clearance provision as HRS §§ 438-8.5 and 439-12.5.

The Board did not oppose adding similar medical clearance language to the legislative proposal if it is required; however, based on the prior discussions regarding HAR §§16-75-56 and 16-78-78 relating to medical clearance, the Board reaffirmed its position that the Department of Health, County offices, the Office of the Governor, and federal government agencies such as the Centers for Disease Control and Prevention ("CDC") would

> be more appropriate to determine whether a medical clearance certificate should be required to protect the public health.

3) Powers and Duties of Board

The following language was added to § -5(a) for clarity and to give the Board authority to effectuate the purpose of the chapter:

In addition to any other powers and duties authorized by law, the board shall have all the powers necessary to effectuate the purpose of this chapter; may approve examinations for licensure to practice barbering and cosmetology...

4) Barber Apprenticeship

The following language was added as § -7(c) for uniformity in the apprenticeship permit term:

Apprentices shall have forty-two months from the date of registration to complete training at the minimum of twenty hours per week.

It was moved by Vice-Chairperson Williams, seconded by Ms. Hall, and unanimously carried to approve all the aforementioned amendments to the legislative proposal.
