### Chair Sutherland-Choy recessed the meeting at 2:58 p.m. and reconvened at 3:01 p.m.

It was motioned by Dr. Spira, seconded by Vice Chair Oliphant, and by roll call vote of all members present, unanimously carried to approve the changes to the forms.

EO Fernandez then informed the Board that while it had approved a delegation for him to approve certain examination and examination waiver applications that are deemed ministerial (see meeting minutes for December 2020), it did not provide the same delegation for temporary permits. He stated that since the end of the exemptions for psychologist in the Governor's Emergency Proclamations on August 6, 2021, he has seen an increase of questions regarding temporary permits by out-of-state practitioners who are not licensed in Hawaii. EO Fernandez asked the Board if they would also authorize a delegation for the approval of certain temporary permits. This would allow those practitioners whose applications would be considered ministerial to not have to wait until a Board meeting for approval.

After due consideration of the circumstances and information presented by EO Fernandez, with regards to the approval of Temporary Permits, and pursuant to the authority provided by HRS §436B-8, Dr. Pedro made a motion to delegate to the Executive Officer the non-discretionary decision to approve said applications when the summary of duties attached to the Internship Verification and the Postdoctoral Experience Verification Forms clearly indicates the internship and postdoctoral experience were completed in the field of psychology. The Motion was seconded by Vice Chair Oliphant, and unanimously approved by all members present in a roll call vote.

b. The Board will begin planning and preparing for rule revisions for Hawaii Administrative Rules ("HAR") §16-98.

After a brief discussion, the Board acknowledged that due to the need to update rules within HAR §16-98, and the limited time during meetings for such complex conversations, that it should create a permitted interaction group or ("PIG") to allow up to 3 members of the Board to meet outside of meetings to discuss and develop amendments to HAR §16-98. The motion was made by Vice Chair Oliphant to create a PIG, pursuant to HRS §92-2.5(b), and to have the following Board members assigned to the group:
