Call to Order:	There being a quorum present, Chair Tamayo called the meeting to order at 9:04 a.m.	
Agenda:	The agenda for this meeting was filed with the Office of the Lieutenant Govern as required by section 92-7(b), Hawaii Revised Statutes ("HRS").	
Approval of Board Meeting and Executive Session Meeting Minutes of July 13, 2021:	Chair Tamayo asked if there were any comments or concerns regarding the Board minutes of the July 13, 2021, meeting. There were none.	
	There being no further discussion or amendments to the minutes, upon a motion by Chair Tamayo, seconded by Ms. Wakabayashi, it was voted on and unanimously carried to approve the Board Meeting and Executive Session Meeting Minutes of July 13, 2021, as circulated.	
<u>New Business</u> :	a. <u>Hawaii to start Alternative Approval Process (AAP) effective October 1.</u> 2021	

The process that takes place under AAP, which only applies to applicants who are graduates of CAPTE accredited programs:

No sooner than 150 days before graduation, the school's program director validates that the student is on track to graduate. After the school "validates graduation," the student can register for the NPTE and is permitted to register for any exam date that is within 90 days of graduation pursuant to the NPTE policies. Once the student completed the registration, they will receive their authorization to test information and can then schedule an appointment with Prometric. Scores will be sent to the Board after the student completes the test. Once the Board received a passing NPTE score and had determined that the applicant met all other licensure requirements (including proof that they actually completed the PT/PTA program), the Board issues the license.

b. FSBPT to pilot two-day testing window in 2022 NPTE testing

In response to the COVID-19 pandemic, FSBPT added testing windows to all fixed date exams in 2020 and 2021. These windows gave candidates the needed flexibility in scheduling appointments in the midst of social distancing, site closures, and other issues brought on by the global pandemic.

Looking ahead to 2022, FSBPT is going to pilot two-day testing windows for all exam administrations rather than returning to single-day events. FSBPT's goal is to provide candidates with flexibility in scheduling while maintaining the security of the exam. Updated exam schedule is available on FSBPT's website.

FSBPT will continue to monitor the security of all exam administrations as well as further developments with the pandemic and will make modifications to the exam schedule if necessary.
