September 14, 2021:

Chair Tamayo asked if there were any comments or concerns regarding the Board minutes of the September 14, 2021, meeting. There were none.

There being no further discussion or amendments to the minutes, upon a motion

by Chair Tamayo, seconded by Ms. Wakabayashi, it was voted on and

unanimously carried to approve the Board Meeting and Executive Session

Meeting Minutes of September 14, 2021, as circulated.

New Business: a. Chairperson's report on the FSBPT Delegate Assembly

Chair Tamayo stated that due to the pandemic, the Delegate Assembly was held virtually in October. She went on to say that because it was held virtually, you do lose out on the side bar conversations with other state boards seeing how they do things, problems that they have and problem solving together.

The following motions were passed:

Revisions to the By-Laws in which States, due to the pandemic, must be more flexible in the way business is conducted. This motion was to update the by-laws and the roles of the delegates clarified across both the LIF (Leadership Issues Forum), the Annual Meeting and the Delegate Assembly. The Annual Elections can be held on-line and the submission of the reports is annually; but not requiring the reports to be submitted in connection to the Annual Meeting. This motion was approved by a 2/3 majority.

A proposed change on the Areas of Focus that will advance was to not require the Delegate Assembly vote on the Areas of Focus each year if there were no changes.

The final motion was to increase the stipend to the Board of Directors. The same stipend has been in place since its inception in 1998. The increase was \$16,000 for the President and \$8,000 for the members. This motion was approved.

The President did a review of what FSBPT has been up to.

The Hawaii Board received recognition for moving towards the Alternative Approval Process (AAP).

Education was discussed and Ms. Wakabayashi was recognized for being on the Education Committee. A positive of virtual meetings is that it opens up a lot more opportunities for education. FSBPT held virtual regulatory based webinars and publications with emphasis in education. FSBPT has been working on diversity, equity and belonging. The leadership forum which is an important aspect of FSBPT is working in collaboration with APTA on the opiate problem and multi-disciplinary task force on workforce data and disciplinary actions to have a better integrated system. Disciplinary issues are shared to make it easier for state boards to identify potential problems.

Chair Tamayo stated that Ms. Wakabayashi became the Chairperson for the Education Committee and that Hawaii is well represented.
