It was moved by Vice-Chairperson Nishimoto, seconded by Dr. Lam, and unanimously carried to approve the veterinarian application for exam and license of Shane B. Dennis.

Continuing Education Approval Request:

Chairperson Lee Loy asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

A. American College of Zoological Medicine (ACZM)

Chairperson Lee Loy noted that the ACZM is a registered veterinary specialty college by the AVMA for sponsoring of continuing education credits. She stated that the AVMA recognizes the veterinary sports specialty organization of the ACZM.

After discussion, it was moved by Vice-Chairperson Nishimoto, seconded by Dr. Lam, and unanimously carried to recognize the American College of Zoological Medicine as an approved continuing education sponsor.

A. <u>January 4, 2022 Email – Can a temporary permittee hold permits to work for more than one entity?</u>

At 11:12 a.m., Ms. Chock made the motion, seconded by Dr. Lam, and unanimously carried to enter into Executive Session to consider and evaluate personal information relating to individuals applying for professional or vocational licenses, or to consult with the board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities in accordance with HRS sections 92-5(a)(1) and (4).

EXECUTIVE SESSION

At 11:28 a.m., the Board returned to public session.

The Board reviewed and discussed an email inquiry received on January 4, 2022 regarding whether a temporary permittee be allowed to hold more than one permit to practice at multiple entities.

Executive Officer Shahan cited Hawaii Administrative Rules ("HAR") §16-101-30 which states:

The temporary permit shall be issued subject to the following conditions: (1) The temporary permittee shall practice veterinary medicine only under the supervision of a veterinarian licensed to practice in Hawaii. At all times when the temporary permittee is engaged in the practice of veterinarian medicine, the licensed veterinarian shall be physically present on the same island as the temporary permittee and must be available on a daily basis for consultation with the permittee; (2) Only one permit, which shall be nonrenewable, shall be issued to an applicant;

DAG Wong recommended the Board reaffirm its prior practice of one temporary permit issued to one permittee under the supervision of a veterinarian licensed to practice in Hawaii.

After discussion, it was moved by Dr. Lam, seconded by Vice-Chairperson Nishimoto, and unanimously carried to deny the issuance of more than one temporary permit to an individual applicant pursuant to HAR §16-101-30.

C. <u>Combining of Visiting Veterinarians, Telemedicine & PAVE</u> Certification

Executive Officer Shahan noted that HVMA provided the Board a revised draft of the proposed bill after the meeting agenda was filed. Per, Sunshine Law, the Board cannot discuss or vote on the revisions made to the proposed bill after the meeting agenda has been filed and documents made available to the public.

Chairperson Lee Loy asked if any members of the public would like to provide oral testimony on this agenda item.

Chairperson Lee Loy recognized Dr. Odani and advised her that she may provide oral testimony on this agenda item.

Dr. Odani introduced herself and reported on the added language made to the proposed bill by the HVMA to HRS §471-19 telemedicine portion which states:

(h) Nothing in this statute is intended to override federal requirements and standards for issuing Certificates of Veterinary Inspection or health certificates.

After discussion, it was moved by Vice-Chairperson Nishimoto, seconded by Ms. Chock, and unanimously carried for the Board to support the intent of the bill for an act circulated by the HVMA which included revisions to combine out-of-State veterinarians, telemedicine, and PAVE certification.

On-line Testing:

Chairperson Lee Loy asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Executive Officer Shahan stated that the Board discussed cost analysis of online testing in a previous meeting, however no vote was taken to approve online testing for the Hawaii state examination.

It was moved by Dr. Lam, seconded by Ms. Chock, and unanimously carried for the Board to allow online testing for the Hawaii state examination.

Executive Officer's Report:

Chairperson Lee Loy asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

A. Continuing Education Information for Website

The Board reviewed the draft language of the bulletin to be posted on the Board's website regarding the continuing education requirements prior to the 2022 renewal.

Vice-Chairperson Nishimoto noted to add the American College of Zoological Medicine (ACZM) under the Board approved organizations section of the bulletin.

After discussion, the Board agreed by consensus to approve the bulletin with the aforementioned revision and post on the Board's website.

B. Two open Board positions (licensed members)

Executive Officer Shahan reiterated from the last meeting that there are two licensed Board member positions open for neighbor islands. She stated that there is a veterinarian on Hawaii island that has expressed interest in serving on the Board. Vice-Chairperson Nishimoto stated that the veterinarian is a large animal veterinarian.
