	A short video was played to explain procedures for this virtual meeting and how members of the public can participate and interact with the Board during the meeting.	
	All Board members were present.	
Call to Order:	There being a quorum present, Chair Tamayo called the meeting to order at 9:07 a.m.	
<u>Agenda</u> :	The agenda for this meeting was filed with the Office of the Lieutenant Governor, as required by section 92-7(b), Hawaii Revised Statutes ("HRS").	
<u>Approval of</u> <u>Board Meeting</u> <u>Minutes of</u> <u>November 9, 2021</u> :	Chair Tamayo asked if there were any comments or concerns regarding the Board minutes of the November 9, 2021, meeting. There were none.	
	There being no further discussion or amendments to the minutes, upon a motion by Chair Tamayo, seconded by Ms. Wakabayashi, it was voted on and unanimously carried to approve the Board Meeting Minutes of November 9, 2021, as circulated.	
New Business:	a. <u>Scope of Practice Question</u> :	
	Under §461J-1 Definitions (1) it states "the care or treatment given by a physical	

Under §461J-1 Definitions (1) it states "the care or treatment given by a physical therapist or physical therapist assistant contravene treatment diagnosed or

prescribed by a medical doctor, osteopath, or as determined by the board."

I am inquiring to see if the board has determined that ARPNs are able to prescribe PT services for their patients.

If the APRN can write an order (prescription) to the physical therapist for physical therapy treatment to be performed by the physical therapist.

Chair Tamayo asked if there were any comments or concerns from any public attendee regarding the Scope of Practice Question. There were none.

Ms. Wakabayashi asked if this inquiry was made by only this one APRN or made on behalf of the APRN association. The Board noted that it is an issue with insurers. Certain insurers would not make payment if the orders came from an APRN.

Ms. Zazzera noted that at Queens, they often get referrals from APRN's and never had any issues. They haven't had any issues of denials and have been getting reimbursed for services.

Members noted some insurers have payment issues as the Board's Hawaii Administrative Rules doesn't specifically state that APRN's can write an order.

Ms. Keliinoi noted that it may be that car insurance or workers compensation companies are sometimes a little bit more strict with who the referrals comes from. She stated that at Kapiolani APRN's in-patient are writing referrals and that's really different from out-patient. Often times she found that car insurance companies do not pay for referrals like other insurance companies such as HMSA.

Ms. Wakabayashi asked how would insurance companies know what is considered "as determined by the board". DAG Leong stated that the Board would make a determination, come to a consensus and make an actual vote and motion on what the policy is going to be that would be the Board's policy as determined by the Board. The Board determination would be stated in its meeting minutes.

Ms. Zazzera noted that EO Araki received an answer from the inquirer if the Hawaii Board of Nursing laws and/or rules state if an APRN can prescribe such order. The inquirer noted that pursuant to Chapter 457 Nurses, Hawaii Revised Statutes section 457-8.6 **Prescriptive authority for advanced practice registered nurses.** ... Only qualified advanced practice nurses authorized to diagnose, prescribe, and institute therapy or referrals of patients in health care agencies, health care providers, and community resources ..." She felt that this would include physical therapy.

Chair Tamayo noted that rural areas may only have APRN's and if the Board does not allow APRN's to prescribe therapy treatment then the Board would restrict care in those rural areas.

Upon a motion by Ms. Wakabayashi, seconded by Vice Chair Turner, it was the Board's consensus to include licensed APRN's in Hawaii to prescribe to their patient(s) physical therapy treatment to be performed by the Physical Therapist.
