Virtual Meeting Instructions:

A short video regarding virtual meetings was played for attendees.

The Chair provided information on internet and phone access for today's virtual meeting and announced that today's meeting was being recorded and that the recording will be

posted on the Board's web page.

Call to Order: The Chair took roll call of the Board members and excused Mr. Duldulao and Dr.

Napoleon from today's meeting.

After taking roll, quorum was established and she called the meeting to order at 9:04 a.m.

Chair's Report:

Announcements

The Chair stated that she and EO Fukunaga will be attending the NSCBN's virtual midyear meeting this week and noted that due to the time difference, the meetings start at 3:30 a.m. Hawaii time.

She announced that the next agenda item was approval of the minutes of the February 3, 2022 meeting.

Approval of the Minutes of the February 3, 2022 Meeting

The Chair noted there is a typo on the agenda in regard to the date of the minutes, it should be February 3, 2022, not 2021 and asked the members if there was any discussion in regard to the minutes.

There being no discussion or corrections, the Chair called for a motion in regard to the minutes of the February 3, 2022 meeting.

Upon a motion by Ms. Boyer, seconded by Ms. Daub, it was voted on with the Chair, Vice Chair, Ms. Boyer, Ms. Daub, Ms. Kodama and Ms. Stone Murai voting "yes" and Mr. Ramos abstaining, to approve the minutes as circulated. The motion carried.

The Chair announced the next agenda item was the Executive Officer's Report.

Executive Officer's Report:

2022 Legislative Session - Status on latest version of the following bills

EO Fukunaga reported on the status of the following bills:

HB 1594, HD1/SB 2274, SD1 Relating to the Center for Nursing

Report Title: Center for Nursing; Workforce Supply Survey; License Fees; Increase **Description**: Requires all nursing license applicants to respond to the center for

nursing workforce supply survey in conjunction with license renewal; provided that failure to respond to the workforce supply survey shall not impact license renewal or result in encumbrance of the license.

Increases the center for nursing fee from \$40 to \$60 per license

biennium. Effective 7/1/2060. (HD1)

Description: Requires all nursing license applicants to respond to the center for

nursing workforce supply survey in conjunction with license renewal,

provided that the license renewal shall not be contingent upon responding to the workforce supply survey and failure to respond to the workforce supply survey shall not result in encumbrance of the nurse's license. Increases the center for nursing fee from \$40 to \$60 per license

biennium. (SD1)

HB 1594 was deferred because the senate version was moving.

SB 2274 was heard by WAM who amended the bill by:

- (1) Clarifying that the failure of a nursing license applicant to properly complete the Hawaii Center for Nursing's supply survey will not result in the forfeiture of the applicant's nursing license;
- (2) Changing the effective date to July 1, 2050, to facilitate further discussion on the measure; and
- (3) Making technical nonsubstantive changes for purposes of clarity, consistency, and style.

HB 1823, HD1/SB 2680, SD1 Relating to Health

Report Title: Our Care, Our Choice Act; Advanced Practice Registered Nurses;

Mandatory Waiting Period

Description: Authorizes advanced practice registered nurses and physician

assistants to practice medical aid in dying in accordance with their scope of practice and prescribing authority. Authorizes advanced practice registered nurses with psychiatric or clinical nurse specializations and physician assistants to provide counseling to a

specializations and physician assistants to provide counseling to a qualified patient. Reduces the mandatory waiting period between oral requests from twenty days to fifteen days. Reduces the mandatory waiting period between the initial oral request and the provision of a prescription from fifteen days to ten days if more than ten business days have passed between the initial oral request and an appraisal of the patient by the attending provider or counseling provider. Waives the mandatory waiting period for qualified patients not expected to survive the mandatory waiting period. Prohibits the disclosure or discovery of information collected or retained pursuant to incidental or routine communication between the department of health and qualified patients

or providers. Effective 7/1/2060. (HD1)

Description: Authorizes advanced practice registered nurses, in addition to

physicians, to practice medical-aid-in-dying in accordance with their scope of practice and prescribing authority. Authorizes licensed psychiatric mental health nurse practitioners, clinical nurse specialists, and marriage and family therapists, in addition to psychiatrists, psychologists, and clinical social workers, to provide counseling to a qualified patient. Strengthens nondisclosure protections. Reduces the mandatory waiting period between oral requests from twenty days to fifteen days. Waives the mandatory waiting period for those terminally ill individuals not expected to survive the mandatory waiting period.

Effective 1/1/2050. (SD1)

SB 2680 - Received from Senate but not scheduled for hearing

HB 1823 - Heard by JHA who passed with amendments:

- (1) Deleting language that would have reduced the mandatory waiting period between a qualified patient's initial oral request and the provision of a prescription from fifteen days to ten days if more than ten business days passed between the initial oral request and an appraisal of the patient by the attending provider or consulting provider;
- (2) Deleting the savings clause; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

3/10/2022 – Received from House 3/11/2022 Referred to HTH, CPN/JDC

HB 1758, HD2/SB 2460, SD1 Relating to Nurses

Report Title: Nurses; Registered Nurses; Licensed Practical Nurses; License;

Endorsement; Temporary Permits

Description: Allows for temporary permits to be issued to registered nurses and

licensed practical nurses from a territory or foreign country that are seeking a state license by endorsement. Effective 1/1/2050. (**HD2**).

SB 2282, SD1 Relating to Abortion Care

Report Title: Abortion Care; Advanced Practice Registered Nurses; Transgender;

Gender Non-Binary

Description: Clarifies that access to abortion care is inclusive of all pregnant people

in the State. Repeals a criminal penalty for violations of certain abortion provisions. Clarifies that advanced practice registered nurses may

provide abortion care. (SD1)

Reports:

Hawai'i State Center for Nursing - Laura Reichhardt, Executive Director

Ms. Reichhardt reported on the following:

- Evidence Based-Practice in-person workshop this week for nurse educators both academia and clinical practice;
- LPN situation, extreme shortage, 2019 HSCFN researcher alarmed and alerted
 the State and since then the situation has exasperated due to shifts or changes
 to enrollment as well as increased demand and it looks like a diminished LPN
 population overall and we need to start thinking about solutions;
- Continuing faculty shortage, HB 2220, that will increase the structure lines for faculty across the UH system so we have more nursing instructor needs than before due to changes in ratio, so that contributes to the nursing shortage address nursing shortage;
- Continued work on APRN scope of practice and removing existing barriers. Rep. Kitagawa calling for the need for a holistic approach, inter-professional working group to identify and address barriers.
- New graduate hiring, continuing to see new grad hiring, 2017-present, 10% reported they moved to mainland, remaining 90% remained in the islands, but this is pre-COVID data. Vast majority of new grads who move to the mainland for acute care job opportunities whereas only about 50% of new grads who remain in the islands obtain acute care job positions so they may be seeking a career opportunity that isn't here; and
- New graduate report may not accurately reflect current perspective.

Ms. Daub stated that she had one comment and one question and thanked Ms. Reichhardt for her report and the wealth of information she provides to the Board and that the information she provided on the LPN shortage is fascinating and her question is related to upcoming to evidence-based practice live presentation, is the total end virtual and live?

The Chair called on Ms. Beechinor.

Hawai'i American Nurses Association – Linda Beechinor, Executive Director and Vice President

Ms. Beechinor reported on the following:

- 23 new members, over 400 members RN, plan to increase to 500;
- HISA conference support, student nurses committee, membership with HANA;
- Mentorship program starting in May;
- Advocacy committee active in legislative bills targeting nursing; and
- Support HSCFN evidence-based event and offered scholarships.

The Chair asked if there were any questions for Ms. Beechinor.

There were none.
