A. <u>State Boards of Accountancy Executive Directors</u> Conference Call on March 8, 2022

EO Kleinhans reported his attendance to the State Boards of Accountancy Executive Directors Conference Call on March 8, 2022. He provided the Board with highlights from the conference call:

- Discussed the history of the Uniform CPA Exam, and the new CPA Evolution-aligned Exam expected to launch in 2024.
- The American Institute of Certified Public Accountants ("AICPA") and the National Association of State Boards of Accountancy ("NASBA") anticipate that state boards will receive inquiries from exam candidates regarding the changes to the examination. In the next several months, AICPA will be providing additional information on changes to the exam content and processes, as well as its infrastructure, administration, and justification of the changes.
- Discussed the pipeline of candidates currently decreasing.
   College enrollment has significantly dropped from prepandemic levels, and AICPA and NASBA will evaluate these statistics throughout the CPA evolution process.
