2022 Proposed Legislation:	A. <u>HB2109 / SB3077 Relating to the Barbering and Cosmetology</u> Licensing Act
	The Board discussed the above bills.
	The purposes of these bills are to: (1) add and update definitions to satisfy current industry practice needs; (2) align and remedy inconsistencies between Hawaii Revised Statutes ("HRS") chapters 438 and 439; (3) remove the five-year license requirement for barber and beauty operator Board member seats currently required by HRS section 438-3; (4) raise fees for penalties and disciplinary actions; and (5) remove the medical clearance requirements currently required by HRS sections 439-12.5 and 438-8.5.
	Executive Officer Yam informed the Board that a hearing for HB2109 was held on February 2, 2022, at 2:00 p.m., before the House Committee on Consumer Protection & Commerce. The Committee recommended the measure be passed with amendments: (1) Change the effective date to January 1, 2050, to encourage further discussion; and (2) Making technical, nonsubstantive amendments for the purpose of clarity, consistency, and style. Executive Officer Yam stated that HB2109, HD1, is posted on the Capitol website and the bill is referred to the House Committee on Judiciary & Hawaiian Affairs.
	Executive Officer Yam informed the Board that a hearing for SB3077 was scheduled on February 11, 2022, at 10 a.m., before the Senate Committee on Commerce and Consumer Protection.
	It was moved by Vice-Chairperson Williams, seconded by Ms. Hall, and unanimously carried that the Board continues to support these bills.
<u>Legislative</u> <u>Committee:</u>	The Board considered establishing a Legislative Committee for the 2022 legislative session.
	After discussion, it was moved by Mr. Yap, seconded by Chairperson Severson, and unanimously carried to appoint Vice-Chairperson Williams, Ms. Hall, and Mr. Murata to serve on the legislative committee.
Public Comment:	Chairperson Severson stated that she will resign from the Board effective March 1, 2022.
