Call to Order: Chair Sutherland-Choy provided instructions for public participation during

the meeting including providing testimony, which will be limited to five

minutes per testifier per agenda item.

Chair Sutherland-Choy confirmed by roll call that she, Vice Chair Oliphant, Drs. Oliveira Cabbab, Spira and Ching were present with Dr. Pedro excused. Chair Sutherland-Choy then brought the meeting to

order at 12:52 p.m.

Review and Approval

of Board Meeting

Minutes: It was moved by Vice Chair Oliphant, seconded by Dr. Spira, and

unanimously carried by roll-call vote to approve the open session minutes

of the February 4, 2022 and February 22, 2022 meetings as is.

Legislative Matters: The Board will review and may form positions for 2022 Legislative

Session bills and resolutions related to the practice of psychology. The

Executive Officer will also report on the status of bills.

a) SB2281 - RELATING TO PSYCHOLOGY

Establishes interim licensure requirements for school psychologists to be administered by the Board of Psychology. Requires all school psychologists to be licensed by January 1, 2023. Increases the composition of the Board of Psychology to include two school psychologists. Requires the Board of Psychology and the Department of Education to collaborate to determine a permanent licensing scheme for school psychologists in the State and to submit a report of their findings and recommendations to the Legislature. (SD2)

EO Fernandez updated the board on the status of this bill stating that the bill was heard by the House committee on Consumer Protection and Commerce ("CPC") the day before (3/31/22). At the hearing the bill was recommended for passage with a substantial amendment. He explained that in his HD2 draft, CPC Chair Johanson removed all language in the bill (see above description) referring to school psychologists being licensed under the board and replaced it with language that requires the State Auditor to conduct a sunrise analysis. He suggested the Board consider supporting the HD2 draft as this will be important if the bill moves on to conference.

Dr. Oliveira Cabbab asked EO Fernandez if in the meetings that he had with Department of Education representatives this session, were they against a sunrise analysis? EO Fernandez responded that they were actually in support of it.

After a brief discussion, it was motioned by Dr. Ching, seconded by Dr. Oliveira Cabbab and unanimously carried to support SB2281 SD2 HD2.

b) SCR156

REQUESTING THE DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS TO CONVENE A TASK FORCE TO PROVIDE RECOMMENDATIONS FOR A PILOT PROGRAM THAT GRANTS PRESCRIPTIVE AUTHORITY TO QUALIFIED PSYCHOLOGISTS IN THE COUNTIES OF KAUA'I, MAUI, AND HAWAI'I.

EO Fernandez updated the board on the status of this measure. He stated that SCR156 was recommended for approval by the Senate committee on Commerce and Consumer Protection at its 3/24/22 hearing and now is awaiting a floor vote.

It was motioned by It Dr. Oliveira Cabbab, seconded by Dr. Spira, and unanimously carried to support this measure.

c) <u>SCR122</u>

EO Fernandez updated the board on the status of this bill. He informed members that the measure was recommended for passage by the Senate committees Commerce and Consumer Protection, and Health with non-substantive amendments the day before (3/31/22).

Dr. Oliveira Cabbab suggested to amend the date to 2024 to be in unison with the effective date of SB2281 SD2 HD2.

It was motioned by Dr. Ching, seconded by Vice Chair Oliphant, and unanimously carried to support this measure with the suggestion to amend the date to 2024.

The Practice of Psychology and Exemptions:

The Board to review the following:

Teresa Kono, Interim Program Officer with the University of Hawaii at Manoa, asks whether the University's Counseling Center would require a Hawaii licensed Psychologist to act as "a neutral third party [to] serve as a sort of consultant" to provide a licensed Psychologist with additional training on the center's policies and procedures, as well as "sitting in on some sessions and providing recommendations and feedback".

EO Fernandez briefed the board that according to Ms. Kono's letter dated October 29, 2021, a consultant was being brought into the Counseling Center at UH Manoa to provide an employee additional training on the center's policies and procedures.

After discussing the matter, it was motioned by Dr. Spira, seconded by Dr. Oliveira Cabbab, and unanimously carried to have EO Fernandez draft a response letter to Ms. Kono informing her that delivering psychological services, and providing supervision require a license. However, in this instance, if the consultant does not provide supervision nor deliver professional services considered to be psychological services defined in HRS §465 and Hawaii Administrative Rules §16-98, a license may not be needed.

Election of Board Officers:

Pursuant to HRS §436B-6(a), the Board will hold its annual election of Chairperson and Vice Chairperson.

After a brief discussion, it was motioned by Vice Chair Oliphant, seconded by Dr. Oliveira Cabbab, and unanimously carried to keep the current positions of officers until June 30, 2022.
