Agenda: The agenda for this meeting was filed with the Office of the Lieutenant Governor as required by Hawaii Revised Statutes ("HRS") section 92-7.

Call to Order: There being a quorum present, the meeting was called to order at 10:30 a.m. by Chair Denis.

Vice-Chair Inouye, Chief Ferreira, Mr. Collins, Mr. Chu and Chair Denis confirmed they were present.

Approval of the Board Minutes: Chair Denis asked if there were any corrections to the March 9, 2022 open session minutes and executive session minutes.

It was moved by Mr. Collins, seconded by Vice Chair Inouye, and unanimously carried to approve the open session and executive session minutes of the March 9, 2022 meeting.

Executive Session: At 10:32 a.m., it was moved by Vice Chair Inouye, seconded by Mr. Collins, and unanimously carried to move into executive session pursuant to HRS §92-5 to consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section HRS §26-9 or both, and to consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities, as provided in HRS §92-5(a)(1) and (4).

#### EXECUTIVE SESSION

At 10:42 a.m., it was moved by the Vice-Chair Inouye seconded by Mr. Collins and unanimously carried to move out of executive session.

Applications: A. Guard Employees

1. Angelo Buswell-Garcia

After due consideration of the information received, it was moved by Mr. Collins, seconded by Vice-Chair Inouye and unanimously carried to approve Angelo Buswell-Garcia's application for licensure subject to certain conditions:

The Board based its decision on the following citation of the Hawaii Revised Statutes ("HRS"), which finds factual support in the records and files of Mr. Buswell-Garcia's application:

HRS section 436B-19 provides that:

In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore, or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

\* \* \*

- (14) Criminal conviction, whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions, or duties of the licensed profession or vocation.

For reasons contained in the records and files of Mr. Buswell-Garcia's application, the Board placed the following conditions of his conditional license:

- 1) Mr. Buswell-Garcia shall provide the Board with semiannual progress reports from his therapist until June 30, 2024. For the semiannual periods of January to June; and July to December; the progress reports shall be due on or before July 31<sup>st</sup> and January 31<sup>st</sup> respectively.
- 2) Mr. Buswell-Garcia shall submit an annual FBI national criminal history record check and State of Hawaii criminal history record check from the Hawaii Criminal Justice Data Center (“**criminal abstracts**”) to the Board until 2024.
  - a. These criminal abstracts shall be due on January 31 of each year and shall cover the periods of January to December.
  - b. In order to obtain these criminal abstracts, Mr. Buswell-Garcia shall be fingerprinted electronically at Fieldprint Inc. at his own cost and expense, and
- 3) Mr. Buswell-Garcia shall refrain from any actions that may result in his arrest or conviction for any crimes against persons or property (including but not limited to theft, burglary, assault, etc.) or any other act that is directly related to the guard profession.
  - a. Mr. Buswell-Garcia shall report any such arrests or convictions to the Board within thirty (30) calendar days of the arrests or convictions, and
  - b. If Mr. Buswell-Garcia fails to timely notify the Board of such arrests or convictions, this conditional registration shall be automatically revoked without a hearing on the 30<sup>th</sup> day after the date of the arrests or convictions.

2. Sene Leilua

After due consideration of the information received, it was moved by Mr. Collins, seconded by Vice-Chair Inouye and unanimously carried to approve Sene Leilua’s application for licensure subject to certain conditions:

The Board based its decision on the following citation of the Hawaii Revised Statutes (“HRS”), which finds factual support in the records and files of Mr. Leilua’s application:

HRS section 436B-19 provides that;

In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore, or may deny revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee of the applicant thereof:

- (14) Criminal conviction, whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions, or duties of the licensed profession or vocation;

For reasons contained in the records and files of Mr. Leilua's application, the Board placed the following conditions on his conditional licenses:

- 1) Mr. Leilua shall comply with all of the terms and conditions of his probation.
  - a. Mr. Leilua shall provide the Board with semiannual progress reports from his probation officer. For the semiannual periods of January to June; and July to December; the progress report shall be due on or before July 31<sup>st</sup> and January 31<sup>st</sup> respectively. The progress reports shall indicate whether Mr. Leilua is complying with the terms and conditions of his probation.
  - b. Upon completion of his terms, Mr. Leilua shall submit proof of discharge to the Board; and if his probation is amended in any way or is revoked:
  - c. Mr. Leilua shall report any such amendment or revocation to the Board within thirty (30) calendar days of the amendment or revocation; and
  - d. If Mr. Leilua fails to timely notify the Board of such amendment or revocation, this conditional registration shall be automatically revoked without a hearing on the 30<sup>th</sup> day after the date

of the amendment or the date his probation was revoked, as applicable;

- 2) Mr. Leilua shall submit an annual FBI national criminal history record check and State of Hawaii criminal history record check from the Hawaii Criminal Justice Data Center (“**criminal abstracts**”) to the Board.
  - a. These criminal abstracts shall be due on January 31 of each year and shall cover the periods of January to December.
  - b. In order to obtain these criminal abstracts, Mr. Leilua shall be fingerprinted electronically at Fieldprint Inc. at his own cost and expense, and
- 3) Mr. Leilua shall refrain from any actions that may result in his arrest or conviction for any crimes against persons or property (including but not limited to theft, burglary, assault, etc.) or any other act that is directly related to the guard profession.
  - a. Mr. Leilua shall report any such arrests or convictions to the Board within thirty (30) calendar days of the arrests or convictions, and
  - b. If Mr. Leilua fail to timely notify the Board of such arrests or convictions, this conditional registration shall be automatically revoked without a hearing on the 30<sup>th</sup> day after the date of the arrests or convictions.
