Summary of events:

6/16/2015: Board Meeting

The Board reviewed the Hearings Officer's Findings of Fact, Conclusions of Law, and Recommended Order; Respondent Angel Santiago's Written Exception to Hearing Officer's Recommended Order. The Board voted to accept the Hearings Officer's Findings of Fact and Conclusions of Laws; however, determined that it would modify the Hearings Officer's Recommended Order.

6/28/2016: Board Meeting

The Board voted to adopt the action taken by the Board at the June 16, 2015 meeting, and issue the Board's Proposed Final Order.

6/19/2018: Board meeting

The Board voted to approve the Board's Proposed Final Order. It was noted that the Board members signed the Proposed Final Order instead of issuing and signing a Final Order. A copy of the Proposed Final Order was transmitted to the Regulated Industries Complaints Office ("RICO") and the Respondent(s); however, there is no record of the issuance of a Board's Final Order. This matter remained unresolved.

After discussion, it was moved by Vice-Chairperson Chow, seconded by Mr. Hansen, and unanimously carried to accept the Hearings Officer's Findings of Fact, Conclusions of Law, and approve the Board's Proposed Final Order as its Final Order.

Following the Board's review, deliberation, and decision on these matters pursuant to Chapter 91, HRS, Chairperson De Luz announced that the Board reconvene to its Chapter 92, HRS, meeting at 9:49 a.m. Board members and staff returned to the Zoom meeting.

Licensing:

It was moved by Mr. Wong, seconded by Mr. Uekawa, and unanimously carried to enter into executive session at 9:51 a.m., pursuant to HRS §92-5(a)(1), to consider and evaluate personal information relating to individuals applying for professional licenses cited in section HRS §26-9, and pursuant to HRS §92-5(a)(4), to consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities. EXECUTIVE SESSION

At 10:10 a.m., it moved by Ms. Wong, seconded by Vice-Chairperson Chow, and unanimously carried to return to the open session meeting. Board members and staff returned to the Zoom meeting.

A. Consumer Consultant Application

i. Cameron James Hines

After due consideration of the information received, it was moved by Mr. Hansen, seconded by Mr. Uekawa, and unanimously carried to defer Mr. Hines's consumer consultant application, and ask the applicant to appear before the Board at the next Board meeting.

B. Ratifications:

It was moved by Mr. Wong, seconded by Vice-Chairperson Chow, and unanimously carried to ratify the licenses attached (see, attached list).

Application Review Committee:

EO Yam stated that Mr. Sherman Takao will be the new Executive Officer of the Motor Vehicle Industry Licensing Board effective June 17, 2022.

She stated that the Board may consider establishing an application review committee ("ARC"), consisting of 2-3 board members (less than quorum), to assist the Executive Officer to determine applicants' qualifications for licensure. Any existing Board delegations to the Executive Officer regarding applications will remain the same, and anything that is beyond the Executive Officer's delegatory authority will be brought to the Board for review.

Chairperson De Luz asked DAG Leong if an ARC would be permitted by the Sunshine Law.

DAG Leong informed members that since the ARC is less than quorum it is not subject to the Sunshine Law. He went on to say that an ARC is a mechanism to be used to allow administrative staff the ability to make inquiries of members in between meetings. The EO may contact one (1) or more of the members of the ARC for guidance.

DAG Leong suggested that, at a minimum, two of the ARC members should be industry members.

It was moved by Vice-Chairperson Chow, seconded by Mr. Hansen and unanimously carried to establish an application review committee comprised of three Board members, including:

John Uekawa, Industry Member; Russell Wong, Industry Member; and Marie Weite, Public member.

Executive Officer's Report:

A. <u>Update on Rule Revisions – Title 16, Chapter 86, Hawaii</u> <u>Administrative Rules</u>

EO Yam stated that the Board approved the proposed draft amendments at its December 7, 2021 meeting. She stated that she is currently drafting a memorandum that outlines each proposed change, which will be sent with the proposed draft amendments to DAG Leong for review soon.

B. <u>2022 Renewals</u>

EO Yam stated that the renewal deadline is June 30, 2022 and advised licensees to renew (online or via mail) at their earliest convenience. She also advised licensees that are experiencing technical issues using the MyPVL portal may email the Board for assistance.
