INSTRUCTIONS & INFORMATION

- 1. This form is to be used by a developer for renewal of the registration of the developer's time share plan on or before December 31, 2022.
- 2. This application will not be received by the Director unless every statement in the application has been completed by the applicant and the application is accompanied by the documents specified in Section 514E-10(f), Hawaii Revised Statutes (HRS), Time Sharing Plans.

The certified statement required under section 514E-10(f)(2) shall identify:

For interval/weeks based time share plans:

- (a) All of the time share units in the time share plan registered pursuant to this chapter,
- (b) The total number of time share interests registered for sale in each unit pursuant to this chapter, and
- (c) The total number of time share interests that have not yet been sold <u>in each unit</u> as of the date specified in the developer's certification, which date shall not be more than sixty days prior to the date of the developer's certification.

For points based time share plans:

- (a) Each property in the time share plan registered pursuant to this chapter,
- (b) The total number of points registered for sale in each property pursuant to this chapter, and
- (c) The total number of points in the time share plan that have not yet been sold as of the date specified in the developer's certification, which date shall not be more than sixty days prior to the date of the developer's certification.
- 3. The Director will act upon this application within 60 days after receipt of a complete application.
- 4. Fees: Please attach the following application fees. Payment shall be in the form of a check made payable to: "Department of Commerce and Consumer Affairs". Check must be in U.S. dollars and be from a U.S. financial institution.

5. Failure, neglect or refusal by the applicant to pay the renewal and CRF fees or to submit the documents required by Section 514E-10(f), HRS, shall constitute a forfeiture of the applicant's time share plan registration. Any registration which has been forfeited may be restored within 90 days upon written application and payment to the Department of the delinquent fees and a penalty fee of \$400, provided that the registration meets all of the requirements for renewal specified in Section 514E-10(f), HRS. The applicant shall not engage in any time share activities in connection with the forfeited registration until the registration has been restored.

Section 514E-10(f), Hawaii Revised Statutes

- (f) An application for renewal of a developer registration shall be on a form prescribed by the director and shall include:
- (1) A current disclosure statement that meets the requirements of section 514E-9 and section 16-106-3, Hawaii Administrative Rules, if not already on file;
- (2) A statement that is certified by the developer to be true and correct in all respects and that identifies, as appropriate:
 - (A) The time share units in the time share plan registered pursuant to this chapter; the total number of time share interests registered for sale in each unit pursuant to this chapter; and the total number of time share interests that have not yet been sold as of the date specified in the developer's certification, which date shall not be more than sixty days prior to the date of the developer's certification; or
 - (B) The property in the time share plan registered pursuant to this chapter; the total number of points registered for sale in each property pursuant to this chapter; and the total number of points in the time share plan that have not yet been sold as of the date specified in the developer's certification, which date shall not be more than sixty days prior to the date of the developer's certification;
- (3) If the developer is a corporation, partnership, joint venture, limited liability company, or limited liability partnership, an original certificate of good standing issued by the business registration division of the department of commerce and consumer affairs not more than forty-five days before the date of submission of the renewal application; and

(4) The biennial renewal fee.
