with Esther Brown: Executive Officer Araki advised the Board that Esther Brown is unable

to attend the meeting. This agenda item will be deferred.

Scope of Practice
Question from
Dr. Dermody:

Chair Pleiss read Dr. Dermody's scope of practice question:
I have gotten some mixed messages within the chiropractic community about liability with using different types of pregnancy pillows for adjusting the pregnant patient. In the state of Hawaii- do I need to use a professionally made pregnancy pillow designed with a patent like ChiroLux or can I make my own and still be covered? I spoke to my malpractice today and they said this falls under a scope of practice umbrella which is determined by the state.

Chair Pleiss does not have any recommendation but advises Dr. Dermody to use his professional judgement in making the determination on what pillow to use for his patients. The Board of Chiropractic's laws and rules does not state any specific pillow to use to adjust their patients. Vice Chair Klein and Dr. Ogawa concurs with Chair Pleiss.

The Board recessed at 12:20 p.m. and returned to open session at 12:35 p.m.

Chapter 91, HRS, Adjudicatory Matters:

(A) In the Matter of the License to Practice Chiropractic of AARIES T. ODA, D.C.; CHI 2020-14-L

It was moved by Vice Chair Klein, seconded by Chair Pleiss, and unanimously carried to approve the settlement agreement, CHI 2020-14-L.

Executive Session:

At 12:39 p.m., it was moved by Chair Pleiss, seconded by Vice Chair Klein, and unanimously carried to enter into Executive Session pursuant to HRS §92-5(a)(1), "To consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section 26-9 or both", and HRS §92-5(a)(4), "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities.

At 2:22 p.m., it was moved by Chair Pleiss, seconded by Vice Chair Klein, unanimously carried to exit Executive Session and reconvene to the Board's regular order of business.

Applications for

Chiropractic License: Chair Pleiss asked if there were any members of the public who would like to provide oral testimony on this agenda item, to which there were none.

(A) Chiropractor License

(1) **Duane Walker**

After due consideration of the information received, it was moved by Vice Chair Klein, seconded by Chair Pleiss, and unanimously carried to approve the chiropractic license application of Dr. Walker.

(2) Leonard Wong

After due consideration of the information received, it was moved by Vice Chair Klein, seconded by Chair Pleiss, and unanimously carried to approve the chiropractic license application of Dr. Wong.

(3) Caleb Craig

After due consideration of the information received, it was moved by Vice Chair Klein, seconded by Chair Pleiss, and unanimously carried to deny Dr. Craig's application for licensure.

The Board based its decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and information of Dr. Craig's application.

HRS section 436B-19 provides that:

In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore, or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

- Failure to maintain a record or history of competency, trustworthiness, fair dealing, and financial integrity;
- (13)Revocation, suspension, or other disciplinary action by another state or federal agency against a licensee or

applicant for any reason provided by the licensing laws or this section.

It was moved by Chair Pleiss, seconded by Dr. Ogawa, and unanimously carried to ratify the above issued licenses.

Tech Support advised the Board that Caleb Craig raised his hand. Chair Pleiss recognized Dr. Craig to speak.

Dr. Craig thanked the Board and stated that he understands the Board denied his application. He asked why the Board denied his application. He stated that he is a good chiropractor and asked "what is so bad about the infractions in the other states" to which he added that it was only a "miscommunication and not filling in the right circle."

Executive Officer Araki advised Dr. Craig that the Board based their decision on Hawaii Revised Statue Sections 436B-19(13) and 436B-19(8). Dr. Craig responded and said that he prescribed a DME unit one (1) day before he was licensed and did not fill in the right circle on a questionnaire.

Chair Pleiss advised Dr. Craig that they are in an open public session and asked if he would rather discuss in executive session – unless he would like to continue in open public session. Dr. Craig responded and asked again for an explanation as to what is so significant on his infractions that his application for licensure is denied. He added that he does not see anything significant on his infractions and that there is nothing significant such as a sexual misconduct, that he would be denied a license.

DAG Cole advised Dr. Craig that the Board cited the statute that the decision was based on when the motion was made. He added that the Board deliberated for quite a while and that their decision was based on what they thought is best for the public of Hawaii. DAG Cole advised Dr. Craig that there is a process to follow if he does not agree with the Board's decision.

Dr. Craig responded and said that he does not see anything on his license record that should prevent him from successfully practicing as a doctor in Hawaii.

DAG Cole advised Dr. Craig again that the Board made their decision and that there is a process to appeal the Board's decision.

Dr. Craig asked again "what have I done that is so bad" that he is being denied licensure.

DAG Cole repeatedly advised Dr. Craig that the Board made their decision based on the statutes that were cited in the motion and that there is a process to appeal the Board's decision.

Dr. Craig is adamant and is repeatedly asking for an explanation on why he is being denied a licensure.

DAG Cole kept on advising Dr. Craig that the Board made their decision and that there is a process to appeal the Board's decision.

Dr. Craig once again asked "what have I done so wrong" that he cannot practice in Hawaii.

Dr. Craig also stated that he does not care about the Board Staff and that he only cares about what his fellow chiropractors in the Board say.

He then added that he has equipment coming and a space ready to lease.

Dr. Craig is misunderstanding the Board Meeting to be an appeals hearing. DAG Cole and Executive Officer Araki repeatedly explained that it is not an appeals hearing but Dr. Craig is insistent in saying that he had appealed his case multiple times.

Dr. Craig kept on asking the Board to give him an explanation on why he was denied licensure because he had nothing significant on his license record.

Dr. Craig stated that he is frustrated and said "Good thing I didn't fly over there today, or we would have all sorts of problems."

DAG Cole advised Dr. Craig that there is a process to appeal.

Executive Officer Araki advised Dr. Craig that a letter will be sent and will include information on how to appeal the Board's decision.

Executive Officer Araki thanked Dr. Craig for his testimony to which Dr. Craig said, "thanks for ruining my day."

The exchange with Dr. Craig lasted approximately 19 minutes.
