Agenda: The agenda for this meeting was posted on the State electronic calendar

as required by HRS section 92-7(b).

A brief video was played to explain procedures for this virtual meeting and how members of the public can participate and interact with the Board

during the meeting.

Call to Order: The meeting was called to order at 12:12 p.m. by Chairperson Williams,

at which time a quorum was established.

Chairperson Williams proceeded with roll call. All Board members

confirmed that they were present and alone.

#### Election of Chairperson and Vice-Chairperson:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

The floor was opened for the election of the Chairperson. Vice-Chairperson Hall nominated Ms. Margaret Williams as the Chairperson.

It was moved by Ms. Hall, seconded by Mr. Murata, and unanimously carried to elect Ms. Williams as the Board's Chairperson.

The floor was opened for the election of the Vice-Chairperson. Mr. Murata nominated Ms. Raynette Hall as the Vice-Chairperson.

It was moved by Mr. Murata, seconded by Chairperson Williams, and unanimously carried to elect Ms. Hall as the Board's Vice-Chairperson.

# Approval of the April 26, 2022 Minutes:

It was moved by Mr. Murata, seconded by Vice-Chairperson Hall, and unanimously carried to approve the meeting minutes of the open session and the meeting minutes of the executive session of the April 26, 2022 meeting as circulated.

## Adjudicatory Matters:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Chairperson Williams called for a recess from the meeting at 12:18 p.m., to discuss and deliberate on the following adjudicatory matters pursuant to Chapter 91, HRS (Note: Board members and staff entered the Microsoft Teams meeting).

A. <u>In the Matter of the Beauty Operator's License of WILLIAM J.</u>

QUEBIDO; BAR 2021-10-L; Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order

After discussion, it was moved by Chairperson Williams, seconded by Vice-Chairperson Hall, and unanimously carried to approve the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

Following the Board's review, deliberation, and decision on these matters pursuant to Chapter 91, HRS, Chairperson Williams announced that the Board reconvenes to its regular Chapter 92, HRS, meeting at 12:31 p.m. Board members and staff returned to the Zoom meeting.

## Executive Officer's Report:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

## B. <u>Hawaii State Ethics Commission – Ethics Training for State Board and Commission Members</u>

Executive Officer Green reminded Board members that beginning January 1, 2023, all state legislators, state employees, and members of state boards and commissions are required to take ethics training on a periodic basis. She stated if Board members attended ethics training between January 1, 2020 and January 1, 2023, the initial training requirement has been met.

#### 2022 Legislation:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

## A. <u>SB3077, SD1, HD2, CD1 Relating to the Barbering and</u> Cosmetology Licensing Act

The Board reviewed Governor's Message No. 1173 stating that bill SB3077, SD1, HD2, CD1 was signed into law on June 17, 2022.

Executive Officer Green stated that it has not yet been assigned a Hawaii Revised Statutes chapter number so it will be referred to as ACT 073, SLH 2022, until a chapter number is assigned.

The Board discussed and briefly reviewed ACT 073, SLH 2022.

Executive Officer Green briefed the Board with the following information:

Section 1 is the new chapter added to the Hawaii Revised Statutes;

Section 2 states Section 26-14.6 of Hawaii Revised Statutes has been amended;

Section 3 states Section 92-28 of Hawaii Revised Statutes has been

amended;

Section 4 states Chapters 438 and 439, Hawaii Revised Statutes, are repealed;

Section 5 clarifies the jurisdiction, functions, powers, duties, and authority exercised by the board of barbering and cosmetology pursuant to chapters 438 and 439, Hawaii Revised Statutes, are being transferred to ACT 073, SLH 2022;

Section 6 states each member of the board of barbering and cosmetology shall be constituted a member of the board of barbering and cosmetology according to ACT 073, SLH 2022;

Section 7 states ACT 073, SLH 2022, "shall be liberally construed in order to accomplish the purposes set forth herein. If any provision of this Act, or the application thereof to any person or circumstances is held invalid, the invalidity does not affect other provisions or applications of the Act that can be given effect without the invalid provision or application, and to this end the provisions of the Act are severable.":

Section 8 states "any holder of a barber apprentice permit in effect before July 1, 2023, who files an application for a barber's license before July 1, 2024, may satisfy the training requirement by having one thousand five hundred hours of barber training in a barber shop or beauty shop.";

Licensing:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

#### A. ACT 073, SLH 2022

i. § 14(c) – A license that has not been renewed shall be considered forfeited. A forfeited license shall be restored upon payment of all delinquent fees and a penalty fee is application is made within three years after the license is forfeited. Thereafter, the person shall apply as a new applicant and the Board may require the person to take and pass the examination.

Executive Officer Green cited § 14(c) of ACT 073, SLH 2022, which states:

"A license that has not been renewed shall be considered forfeited. A forfeited license shall be restored upon payment of all delinquent fees and a penalty fee is application is made within three years after the license is forfeited. Thereafter, the person shall apply as a new applicant and the Board may require the

person to take and pass the examination."

Executive Officer Green stated that, pursuant to that section, the Board may require the forfeited licensee applicant to take and pass the examination, but that section does not specify what would be required in order for the Board to make that determination. In the past, the Board allowed an unlimited time period for restoration of a forfeited license. She stated that, for this newly enacted section, the Board could discuss the requirements upon which they would base that decision. For example, effective March 24, 2020, the Board requires that applicants for licensure take and pass the NIC (National-Interstate Council of State Boards of Cosmetology) examination so, the Board could consider the specific examination that an applicant had passed to previously in order to qualify for licensure.

Vice-Chairperson Hall opined that individuals who have forfeited their license for more than three (3) years should be required to take and pass the NIC examination for licensure, which is the current requirement for licensure in the State, effective March 24, 2020.

Executive Officer Green asked Vice-Chairperson Hall to clarify if this would apply to everyone, including individuals who have already taken and passed the NIC examination in another jurisdiction.

Vice-Chairperson Hall responded that she would be okay with accepting the NIC examination results from individuals who have taken and passed the NIC examination in another jurisdiction, and not require them to retake the NIC examination. However, those who were licensed by passing the previous Hawaii state laws and rules examination or another state board examination, should be required to take the current NIC examination.

Executive Officer Green asked if the exam waiver would apply to an individual who has taken and passed the NIC examination at any time or would they require the individual to have taken and passed the NIC examination within a specific timeframe.

Chairperson Williams opined that the three (3) years should be extended. She stated that she does not think it would be fair to require an individual to take and pass the NIC examination if they have already taken and passed the Hawaii state laws and rules examination in Hawaii.

Vice-Chairperson Hall responded that the reason the Board should require an individual to take and pass the NIC examination is because policies change over time, and it is important to be knowledgeable in the current policies.

Executive Officer Green stated that extending the three (3) years would not be possible, as it is codified in Act 078, SLH 2022. She noted that, while the Board doesn't need to require that a forfeited licensee applicant has previously taken and passed the NIC examination as requirement for eligibility for an exam waiver, they are aware that part of the Board's responsibilities includes consumer protection. As the Board does not require continued education, she questioned how the Board would measure if a forfeited licensee applicant can appropriately practice in the trade and ensure the consumers would be protected.

Mr. Murata opined that individuals who have forfeited their license after three (3) years should be required to take and pass the NIC examination for licensure. He asked if the NIC examination requires both theory and practical sections. The licensed members responded that Hawaii only requires the NIC theory examination. Executive Officer Shahan stated that the NIC examination does not have the Hawaii state laws and rules incorporated within the examination. Vice-Chairperson Hall and Mr. Murata both expressed their interest in incorporating the Hawaii state laws and rules within the NIC theory portion of the examination.

Discussion ensued regarding an individual who was licensed in the State but the license was forfeited, and if the individual would be allowed to apply for an apprenticeship training program in the same license category in which they were previously licensed.

DAG Suzuka stated that she does not recall anything specifically prohibiting an individual from applying for an apprenticeship training program for this particular situation but does not think that was the intent of the rules.

Executive Officer Green stated that ACT 073, SLH 2022, supersedes Hawaii Administrative Rules sections 16-73-48(b)(4) and 16-78-5.5, which refer to restoration after forfeiture, and the rules will need to be updated to support the updates in ACT 073, SLH 2022.

Upon a motion by Vice-Chairperson Hall, seconded by Chairperson Williams, it was voted on by Chairperson Williams, Vice-Chairperson Hall, Mr. Basta, and Mr. Murata to approve the Board's position on § 14(c) of ACT 073, SLH 2022, as the following:

If a license has been forfeited for three (3) or more years, but less than five (5) years, the Board may allow an exam waiver to a forfeited licensee provided that the Board receives and considers: 1) a new application; 2) statement(s) from the applicant regarding the circumstances surrounding the forfeiture; and 3) letters of recommendation.

Mr. Yap recused himself from voting on this matter.

#### B. Applications for Exam and License:

At 1:24 p.m., it was moved by Chairperson Williams, seconded by Vice-Chairperson Hall, and unanimously carried for the Board to enter into Executive Session to consider and evaluate personal information relating to individuals applying for licensure in accordance with HRS section 92-5(a)(1), and to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities in accordance with HRS section 92-5(a)(4). (Note: Board members and staff entered into Microsoft Teams).

#### **EXECUTIVE SESSION**

At 2:20 p.m., it was moved by Chairperson Williams, seconded by Vice-Chairperson Hall, and unanimously carried for the Board to move out of Executive Session. Board members and staff returned to the Zoom meeting.

i. Desiree A.R. Roache (Barber Examination & License)

It was moved by Vice-Chairperson Hall, seconded by Chairperson Williams, and unanimously carried to defer Ms. Roache's barber application and request additional information.

ii. Kylie H.K. Kuhns (Beauty Operator Examination & License – Esthetician)

It was moved by Vice-Chairperson Hall, seconded by Chairperson Williams, and unanimously carried to approve Ms. Kuhns' beauty operator application and the issuance of a non-disciplinary letter of education to the respective licensees.

iii. Rhonda Leigh Sauer(Beauty Operator Examination & License – Cosmetologist)

It was moved by Vice-Chairperson Hall, seconded by Chairperson Williams, and unanimously carried to approve Ms. Sauer's beauty operator application.

#### C. Beauty School Application

i. Pacific Esthetics Institute LLC

It was moved by Vice-Chairperson Hall, seconded by

Chairperson Williams, and unanimously carried to approve the beauty school application of Pacific Esthetics Institute, LLC, for Esthetician and Instructor, pending submission of additional documentation.

#### D. Ratification List (see attached list)

It was moved by Vice-Chairperson Hall, seconded by Chairperson Williams, and unanimously carried to ratify the list of issued licenses attached (see attached list).

#### Old Business:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

#### A. Licensed Schools and Instruction Provided via Distance Learning

Executive Officer Shahan stated that at its December 22, 2020, meeting, the Board approved licensed schools and instruction provided via distance learning during the period of the COVID-19 pandemic, provided that schools comply with standards from the May 22, 2017, meeting. She further stated that the Board previously approved practical curriculum via distance learning and its May 22, 2017, meeting, with the following standards:

- Instructors provide information and demonstrations either via live video or uploaded videos;
- Students are required to take still photos of their work ("before" and "after");
- Students are required to take a video of their work, with the camera panning from their face to their hands; and
- Instructors provide feedback of submissions.

Executive Officer Green asked if there was a specific date by which the Board would stop accepting distance learning or would it be when an appropriate governing body issues a statement regarding the end of the COVID-19 pandemic.

By consensus, this agenda item was tabled for discussion at the next meeting.

#### New Business:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

A. <u>Can apprenticeships receive "distance learning" hours for the theory portion of their hour requirement?</u>

Chairperson Williams stated that she is opposed to distance learning hours for the theory portion of an apprenticeship program.

Mr. Basta stated that he does not see a problem with distance learning hours for the theory portion of an apprenticeship program.

Vice-Chairperson Hall agreed with Mr. Basta. She stated that distance learning for the theory portion should be an option that is allowed for the licensed shops and supervisors who have access and ability to do so.

By consensus, this agenda item was tabled for discussion at the next meeting.

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Executive Officer Green stated that the Board may consider delegating authority to a committee to review applications for examination subject to Board ratification prior to licensure or to approve an application which was previously reviewed by the Board and approved pending the Applications Review Committee review of additional information.

By consensus, the Board established an Applications Review Committee and designated the following three (3) individuals:

- One (1) licensed barber of the Board;
- One (1) licensed beauty operator of the Board; and
- One (1) any member of the Board.

#### Meeting Schedule:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Executive Officer Green stated that due to being incredibly short-staffed in the Department of Commerce and Consumer Affairs, Professional and Vocational Licensing Division, the Executive Officers and Secretaries have taken on additional responsibilities. She stated that the Board will hold one more meeting for the 2022 year and requested that the Board consider adjusting the meeting schedule, to meet quarterly starting 2023.

By consensus, the Board agreed to a quarterly meeting schedule starting
