Executive Officer's The Nurse Practitioner Journal – Request for Updates

EO Fukunaga reported that the Nurse Practitioner Journal is creating it's 35th Legislative Update for 2023 and is currently seeking feedback. Please notify the Board's staff if you would like more information.

Article, "Hospitals Seek State Emergency Order" – Additional Distribution

EO Fukunaga reported that Hawaii hospitals are seeking an emergency order to suspend licensure to alleviate the shortage in healthcare workers.

Article, "Elected Officials, Health Care Companies Seek Solutions to Nurse Shortage – 2022 NSI National Health Care Retention and RN Staffing Report

EO Fukunaga reported that the shortage of nurses is not just specific to Hawaii; there is currently a nationwide shortage of nurses. The article explores other States solutions to solve the nursing shortage.

Article, "Despite Mounting Hardships at Hospitals, Hawaii Nursing Programs See Rise in Interest" – Additional Distribution

EO Fukunaga reported that despite the shortage of nurses, there is a rise in interest in enrollment in local nursing programs. The article highlights the balance Hawaii Nursing Programs must navigate in order to meet the demand for enrollment while dealing with faculty shortages.

Op-Ed, "Health Worker Shortage Preventable"

EO Fukunaga explained that this article shed a different light on the causes of the current health worker shortage from the perspective of the President of the Hawaii Nurses' Association.

Reports: Hawai'i State Center for Nursing – Laura Reichhardt, Executive Director

Ms. Reichhardt reported on the following:

- Ms. Reichhardt thanked the Board for all of their hard work.
- The Education Capacity report for Academic Year 2020-2021 was released

- For the first time, HSCN asked questions from the NCSBN Guidelines for Pre-Licensure Program approval
- In addition to the known challenges in engaging in nursing education, the NCSBN guideline findings helped us see that finding nurses with MQs in education as well as access to continuing professional development for nursing faculty are challenges for most schools
- In Academic Year 2020-2021, BSN programs offered admission to MANY more qualified applicants before they were able to fill a cohort than in prior years. There are a lot of options as to why this may have happened but we don't have data to indicate any one cause.
- Faculty (Difficulty filling full-time faculty positions, Lack of funding for new faculty lines or raises) and Clinical Capacity (Insufficient number of preceptors for clinical training experiences, Insufficient number of clinical training sites) are the major barriers to nursing education today.
- As a result of the challenges, 75% of schools responded that they reduced admission cohort sizes.

Nursing Professional Development

 We are working to develop a 3 webinar series on nursing wellbeing, from the researcher, nurse, and employer perspectives. We will launch it in September. We are also jointly providing 2 additional activities in September, the Health Workforce Summit and Suicide Prevention 101. All activities in September are

free! Events are marketed on our website under the Continuing Competency page.

- We are also co-hosting a virtual EBP workshop for nurse educators in November. The save the date is on our website and the event dates are Nob 16-17. We are working through registration details and will post registration soon.
- We re-launched our Success Pays program which provides nurses interested in pursuing initial certification through ANCC. To date we have 42 nurses interested, with 11 starting the process with ANCC to take the exam, and 1 nurse newly certified by ANCC!
- At this time these programs are being supported by every team member at HSCN, who keep the machine oiled, maintained, and ready to run!

Recruitment and Retention

- The Nurse Residency Program continues to thrive. We are currently finishing the work on an Opioid grant through the DOH ADAD. From June 2021 to June 2022, we supported 255 nurses trained as preceptors, 374 new graduate nurses who were entered into residency programs, expanded to all counties, and increased partnership to 13 facilities across the state.
- The clinical placement coordination for Oahu and Kauai continues to thrive. Partners are committed to engaging and innovating clinical placement strategies for nurses. We are also actively working to expand support to neighbor islands and additional settings.
- Bri Kuwabara is the lead for these programs and excels in her community engagement and project management.

Hawai'i Association of Professional Nurses – Bradley Kuo, Legislative Coordinator

Mr. Kuo reported on the following:

- Active with the Hawaii Island Physician Workforce Taskforce. Inclusive to APRNs. Doing statewide research in healthcare workforce
- The CMS or Medicare reimbursement is decreasing, impacting the APRNs. Further decline is impactful on all businesses
- Beginning work on the next legislative session
- Educating new legislators on APRN policy and practice.

Hawai'i American Nurses Association – Linda Beechinor, Executive Director and Vice President

Ms. Beechinor reported on the following:

- On October 22, 2022, a statewide hybrid conference at the Hilton Hawaiian Village in the Kona Room will be held. The theme will be "Together We Can." HANA is reaching out to all nursing organizations in the State and to all licensed nurses through newsletter to encourage attendance. There will be both national and local guest speakers, the offering of CEs, and stakeholder sponsors.
- Small award luncheon of mentorship program for people who have finished the program.
- The conference will support the RNs delivery of care and health equity for vulnerable patient populations by enabling every nurse to participate in health care policy making and the legislative process.
- Promoting mentorship program. Experienced nurses meet once a month with senior students and new graduates.
