EO Shahan stated that California Veterinary Medical Association would be added to the list of Board approved continuing education sponsors.

C. State Veterinary Medical Associations Continuing Education

EO Shahan inquired if the Board would be inclined to accept the state veterinary medical associations continuing education coursework that is not state specific.

Chair Lee Loy and Vice-Chair Chock stated that Washington D.C. and Puerto Rico should be included.

DAG Wong requested for an amendment on agenda item #4.C.:

"C. State Veterinary Medical Associations <u>Including Washington D.C. and</u> Puerto Rico Continuing Education"

It was moved by Chair Lee Loy, seconded by Ms. Wada, and unanimously carried to approve the changes to the agenda, with the aforementioned amendment (with new material underscored in bold).

After discussion, it was moved by Chair Lee Loy, seconded by Vice-Chair Chock, and unanimously carried to approve state veterinary medical associations continuing education from the fifty (50) states including Washington D.C. and Puerto Rico.

A. May 16, 2022 – Examination Candidate Review

The Board was provided with a copy of a letter from an examination candidate who challenged one question from the State written examination.

After discussion, it was moved by Dr. Lam, seconded by Vice-Chair Chock, and unanimously carried to deny the answer to Question #22 queried by the examination candidate from the State written examination and to uphold the Board's exam question and answer.

B. HRS § 471-3 (Board Member Requirements)

Chair Lee Loy cited the Hawaii board of veterinary medicine member requirements which states:

"Five of the members of the board shall be veterinarians who have been licensed to practice for at least five years and shall be actively engaged in the practice of veterinary medicine or, if not active at the time of appointment, shall have been previously so engaged for ten years..."

EO Shahan reiterated Board discussion at the July 8, 2022 meeting to consider allowing veterinarians that are not in active practice but an educator of veterinary medicine to qualify as a licensed board member.

Chair Lee Loy inquired if the Board would be inclined to update the Board's rules and statutes for a future legislation session. The Board will review the statutes at a later date and determine if a committee will be formed to review the statute for possible legislative action.

C. HAR § 16-101 Rules Revision

EO Shahan stated that she will be submitting the rule amendments to the Administrative Services Office ("ASO") before sending to DAG Wong for final review.

New Business:

Chair Lee Loy asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

A. Applications Committee

EO Shahan stated that the Board may consider delegating authority to a committee to review the experience portion of the applications for examination subject to Board ratification prior to licensure or to approve an application which was previously reviewed by the Board and approved pending the Applications Committee review of additional information.

C. PSI Services/State Examination

EO Shahan stated that the Department of Commerce and Consumer Affairs ("DCCA") entered a contract with PSI, the testing agency that administers the examination. The State examination will be available online at all PSI testing centers in Hawaii and nationwide. The new electronic examination is administered on dates scheduled by applicants their selves. This contrasts with the current schedule of specific testing dates. The current cost of the State examination will not increase until the statutes can be updated. The Examination Branch is currently working with PSI for a start date. The tentative start date with PSI is January 2023.

D. Subject Matter Experts

EO Shahan stated that the Examination Branch will provide PSI with the current bank of State examination questions. The Board would need to establish a "Subject Matter Experts" team to work with PSI to develop additional test questions.

Dr. Lam volunteered to be a part the "Subject Matters Experts" team.

Chair Lee Loy stated that any licensed individuals who are interested in being a part of the "Subject Matters Experts" team should reach out to EO Shahan by September 16, 2022.

Executive Officer's Chair Lee Loy asked if any members of the public would like to Report: provide oral testimony on this agenda item. There were none.

A. Ethics Training

EO Shahan reminded Board members that beginning January 1, 2023, all state legislators, state employees, and members of state boards and commissions are required to take ethics training on a periodic basis. She stated if Board members attended ethics training between January 1, 2020 and January 1, 2023, the initial training requirement has been met.
