<u>Call to Order</u>: There being a quorum present, the meeting was called to order by

Chair Pleiss at 10:09 a.m.

Approval of Meeting Minutes:

Minutes of the August 29, 2022 Board Meeting

The following amendments to the August 29, 2022 open minutes were requested by Vice-Chair Klein (underlined material added, while bracketed material is to be deleted):

Page 4, 5th paragraph

Dr. Craig thanked the Board and stated that he understands the Board denied his application. He asked why the Board denied his application. He stated that he is a good chiropractor and asked "what is so bad about the infractions in the other states" to which he added that it was [only] a "miscommunication and not filling in the right circle."

Page 4, 7th paragraph

Chair Pleiss advised Dr. Craig that they are in an open public session and asked if he would rather discuss in executive session – unless he would like to continue in open public session. Dr. Craig responded and asked again for an explanation as to what is so significant [on] about his

infractions that his application for licensure is denied. He added that he does not see anything significant [on] <u>about</u> his infractions and that there is nothing significant such as a sexual misconduct, that he would be denied a license.

- Page 5, 6th paragraph
 Dr. Craig [is] was adamant and is repeatedly asking for an explanation on why he [is] was being denied a licensure.
- Page 5, 9th paragraph
 Dr. Craig also stated [that he does not care about the Board Staff and that he only cares about what his fellow chiropractors in the Board say] <u>"I don't care what you guys say there, I care about what my fellow chiropractors say there."</u>
- Page 5, 11th paragraph
 Dr. Craig [is misunderstanding] <u>appears to misunderstand</u> the Board Meeting to be an appeals hearing. DAG Cole and Executive Officer Araki repeatedly explained that it is not an appeals hearing but Dr. Craig [is insistent in saying] <u>insisted</u> that he had appealed his case multiple times.
- Page 5, 12th paragraph
 Dr. Craig [kept on asking] <u>repeatedly asked</u> the Board to give him an explanation [on] <u>of</u> why he was denied licensure because he had nothing significant on his license record.
- Page 5, 14th paragraph DAG Cole advised Dr. Craig that there is a process to appeal the decision.
- Page 6, 1st paragraph
 Executive Officer Araki advised Dr. Craig that a letter will be sent to him and will include information on how to appeal the Board's decision.

It was moved by Vice-Chair Klein, seconded by Dr. Ogawa and unanimously carried to approve the open minutes of August 29, 2022 with the amendments.

Draft Rule Amendments

The Board will review its prior draft rule amendments and a proposed fifth draft of amendments to HAR Chapter 76 for discussion and consideration.

Revised: 16-76-2 Objective

There was no further discussion by the Board.

Revised: 16-76-4 Definitions

Hawaii Board of Chiropractic - Minutes October 10, 2022 Page 5

Adding the abbreviation CCE to The Council on Chiropractic Education for clarity:

"Chiropractic Intern" means a chiropractic student actively enrolled in a school accredited by The Council on Chiropractic Education ("CCE") who works under the direct and active supervision of a preceptor.

Clarifying the definition for Direct and Active Supervision:

"Direct and Active Supervision" means the licensed chiropractor shall be in the same immediate building or complex as the [preceptor] intern or resident receiving the supervision.

There was no further discussion by the Board on the definition of distance education.

Correcting the definition for "preceptor":

"Preceptor" means a doctor of chiropractic who is a licensed chiropractor in the State of Hawaii and approved to supervise chiropractic interns and residents [through a board approved preceptorship program] by the Board.

The Board will discuss a preceptor approval process at their next meeting.

New Section: 16-76-10 Chiropractic Information Network/
Board Action Databank

Providing further clarification of the self-query report/background check:

(b) Applicants for chiropractic licensure shall submit a self-query report from the Chiropractic Information
Network/Board Action Databank. If the Chiropractic
Information Network/Board Action Databank self-query
report is no longer issued, the Board may require a selfquery report from [the National Practitioner Data Bank]
another board approved licensing or background databank
services. By applying for chiropractic licensure, applicants
agree to a background check from the Federation of
Chiropractic Licensing Boards or National Practitioner Data
Bank, or another board approved licensing or background
databank services.

Revised: 16-76-20 License required to practice chiropractic

Providing further clarification of the license exemption for a chiropractic intern or resident:

Any person who is found practicing chiropractic before receiving a license from the board may be denied licensure; provided, that nothing in this chapter prevents or prohibits a [preceptor] chiropractic intern or chiropractic resident from engaging in the practice of chiropractic under the direct and active supervision of a preceptor.

Revised: 16-76-21.01 Inactive license

Chair Pleiss recommended revising the requirements for an inactive license:

(a) A licensee who has an unencumbered active license [in another state] and who does not intend to practice chiropractic in Hawaii may request inactive status at any time during the biennium by writing to the board, or by indicating so on the license renewal form.

Revised: 16-76-21.02 Reactivation of inactive license

Chair Pleiss recommended revising the requirements to reactivate an inactive license:

(2) [Has a current, active chiropractic license in at least one other state throughout the period in which the license was inactive in the State] Provide a certificate of completion of at least thirty hours in continuing education programs approved by the board which had been completed within the last twenty-four months prior to reactivation; and

The Board will review inactive, reactive and restoration application for licensed chiropractic.

Revised: 16-76-38 Basic requirements for renewal

There was no further discussion by the Board.

Revised: 16-76-39 Qualifications for continuing education credit

Chair Pleiss deferred 16-76-39(b) and 16-76-39(f) for future meeting.

There was no further discussion on 16-76-39(g) by the Board.

Revised: 16-76-41 Requirements for approved programs

There was no further discussion on 16-76-41(a) to 16-76-41(d).

The Board would like to provide clarification on 16-76-41(f):

(f) Any board member, or board designee shall have the right to inspect or audit any [approved chiropractic course in progress] course that is approved or being considered for approval.
