Call to Order: The meeting was called to order at 1:08 p.m., at which time quorum was established.

Chair Takanishi welcomed everyone to the meeting and proceeded with a roll call of the Board members. All Board members confirmed that they were present and alone with the exception of Dr. Fujimoto who was

having technical difficulties and was not able to log on.

Chair Takanishi welcomed the newest members, Ronald Fujimoto, D.O., and Elizabeth Ignacio, M.D., to the Board.

Minutes:

It was moved by Mr. Belcher, seconded by Dr. Sawai, and carried unanimously, to approve the meeting minutes of the open session of the November 10, 2022, meeting and December 8, 2022, meeting, as circulated, and the executive session meeting minutes of the November 10, 2022, meeting with amendments, and the December 8, 2022, meeting as circulated.

Chair Takanishi asked if anyone from the public would like to provide oral testimony on this agenda item. There was none.

Chair Takanishi called for a recess from the meeting at 1:12 p.m., to discuss and deliberate on the following adjudicatory matters pursuant to Chapter 91, HRS (Note: Board members and staff entered the Microsoft Teams meeting).

Chair Takanishi proceeded with a roll call of the Board members in Microsoft Teams. All Board members confirmed that they were present and alone.

After due consideration of the information received, it was moved by Dr. Fong, seconded by Dr. Fujimoto, and unanimously carried, to approve the aforementioned Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

B. Shannon P. Calhoun, D.O.; MED 2022-158-L; Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order; Exhibits "1" – "2".

After due consideration of the information received, it was moved by Dr. Sawai, seconded by Dr. Fong, and unanimously carried, to approve the aforementioned Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

Following the Board's review, deliberation, and decision on these matters pursuant to Chapter 91, HRS, Chair Takanishi announced that the Board reconvenes to its Chapter 92, HRS, meeting at 1:33 p.m. Board members and staff returned to the Zoom meeting.

Chair Takanishi proceeded with a roll call of the Board members. All Board members confirmed that they were present and alone with the exception of Dr. Fujimoto who was having technical

difficulties.

It was moved by Mr. Belcher seconded by Dr. Young, and unanimously carried to enter into executive session at 1:37 p.m., pursuant to HRS §92-5(a)(1), to consider and evaluate personal information relating to individuals applying for professional licenses cited in HRS §26-9 and, pursuant to HRS §92-5(a)(4), to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities and liabilities. (Note: Board members and staff entered into Microsoft Teams). Chair Takanishi proceeded with a roll call of the Board members in Microsoft Teams. All Board members confirmed that they were present and alone, including Dr. Fujimoto.

It was moved by Dr. Sawai, seconded by Mr. Belcher, and unanimously carried to return to the open session meeting at 2:14 p.m. Board members and staff returned to the Zoom meeting. All Board members confirmed that they were present and alone.

It was moved Dr. Young, seconded by Dr. Fong, and unanimously carried to ratify the attached list of individuals for licensure or certification from January 19, 2023.

Chair Takanishi asked if anyone from the public would like to provide oral testimony on this agenda item. There was none.

2023  
Legislation:

A. DRAFT BILL: RELATING TO EDUCATIONAL HEALTH Services

The Board discussed this draft bill.

The purposes of this bill are to: allow the administration of medication to public school students by health assistants with the approval of a licensed healthcare professional within the Department of Education, Department of Health, or a healthcare organization per a written agreement with the Department of Education; and replace the term “school health aides” with “school health assistants” to reflect recent changes to the job title. This bill would make student care more efficient, accessible, and safe if medication approval can be done by a qualified and licensed health care official who is already on campus or part of the school community.

Ms. Quiogue brought to the attention of the Board members that page 4 of the bill, reads:

- (b) for the purposes of this section, a “health care professional” means physicians, surgeons, and others licensed pursuant to chapter 453 and nurses licensed pursuant to chapter 457.

Chair Takanishi stated that HRS chapter 453 regulates, physicians (MD/DO), podiatrists, physician assistants, and emergency medical personnel. Based on this information, he did not believe podiatrists or emergency medical personnel should be included.

Mr. Belcher agreed with Dr. Takanishi.

Dr. Lisa Ann Ignacio asked whether the Board should provide suggested language regarding this bill.

Chair Takanishi confirmed that the Board can provide testimony and suggested language to revise the bill.

Mr. Mun commented that the Department of Education is likely trying to ease their daily operations by enabling a non-licensed professional to dispense aspirin, anti-acid, or Tylenol. He found it to be a good bill that is trying to assist schools’ daily operations.

Chair Takanishi stated that it would be very important for the bill to clarify what types of roles are best suited to serve in this capacity, and went on to say that it is the Board’s duty to perform its due diligence in providing that commentary.

B. S.B. 1 RELATING TO HEALTH CARE

The Board discussed this bill.

The purposes of this bill are to authorize licensed physician assistants to perform certain abortions; declare a law of another state that authorizes a person to bring a civil action against a person who: terminates or seeks to terminate a pregnancy; performs or induces the termination of a pregnancy; knowingly engages in conduct that aids or abets the performance or inducement of the termination of a pregnancy; or attempts or intends to engage in the conduct, as contrary to the public policy of this State and shall not be enforceable in any court of the State and shall not afford any basis for the granting if legal of equitable relief by any court of the State; and prohibit the State from engaging in certain actions with regard to civil and criminal actions from another state.

Chair Takanishi added that two testimonies were included in the packet that had been made on behalf of the Hawaii Medical Board. The first testimony, dated Wednesday, February 17, 2021, states:

The Board appreciates the bill's intent to authorize PAs to perform certain abortions to provide greater access to health care for all Hawaii residents, especially those who reside in rural areas or on the neighbor islands. However, the Board must ensure that PAs continue adhering to best practices and therefore requests that the Committee consider the following:

- (1) Ensure that the PA is an authorized agent of the PA's supervising physician, and that the supervising physician shall authorize and/or delegate the performance of aspiration abortions to the PA;
- (2) Perform aspiration abortions only in a hospital licensed by the Department of Health or the federal government, to ensure that appropriate teams are in place to provide assistance if required;
- (3) Delete section 2 in its entirety because the Board does not regulate APRNs, placing statutes regulating APRNs in HRS chapter 453 would not be appropriate. Instead, it would be more appropriate to create a new section regarding APRNs performing aspiration abortions in HRS chapter 457 (Nursing); and
- (4) Delete page 5, lines 17 through 19 of the bill.

The second testimony dated Tuesday, March 1, 2022, provides in relevant part, that:

The Board appreciates the intent of this bill as it allows greater access to abortion care and recognizes all people in Hawaii by deleting the term “female” and replacing that term with “person.” This bill also repeals a criminal penalty with respect to physician providers engaging in and providing safe care.

Chair Takanishi asked the Board members for their position regarding this bill.

Dr. Sawai expressed her support of this measure, and recommended that page 2, line 5, be amended to change the word “female” to “person”.

By consensus, members appreciated the intent of this measure and directed the Executive Officer to provide comments and suggested amendments.

C. DRAFT HOUSE BILL RELATING TO REPRODUCTIVE HEALTH CARE

The Board discussed this bill.

The purposes of this bill are to: prohibit a covered entity from disclosing communication or information relating to reproductive health care services; prohibit the issuance of a subpoena in connection with an out-of-state proceeding relating to reproductive health care services legally performed in the State; prohibit agencies from providing information or expending resources in the furtherance of interstate investigations or proceedings relating to reproductive health care services; prohibit the State from penalizing, prosecuting, or otherwise taking adverse action based on pregnancy outcomes or aiding or assisting a pregnant individual with accessing reproductive health care services; require the governor to deny any demand for surrender of a person charged with a crime involving reproductive health care services unless the conduct constitutes a crime in the State; enumerate laws contrary to public policy and prohibits their application as rules of decision in the courts; prohibit the issuance of a summons for persons to testify in another state with regard to lawful reproductive health care services; clarify under various licensing statutes that the provision or assistance in receipt or provision of medical, surgical, pharmaceutical, counseling, or referral services related to the human reproductive system cannot form a basis for disciplinary action; and prohibit the enforcement of a judgment or order arising from a foreign penal civil action or other penal law with respect to reproductive health care services.

Chair Takanishi commented that he had no comments to add and asked if any Board member had any comments to add. There were none.

Ms. Quiogue asked the Board to consider the following regarding this bill:

- Page 4, lines 8 and 9, define the term “person” to include “an individual, a partnership, an association, a limited liability company, or a corporation.

Similarly, HRS section 436B-2 defines “person” to include “an individual, partnership, *joint venture*, corporation, association, *business, trust, or any organized group of persons or legal entity, or any combination thereof.*

Would the Board consider requesting an amendment to align the two definitions?

Members agreed that the definitions of the term “person” should be consistent with one another.

- Page 6, lines 8 to 15: Ms. Quiogue recommended that the Board seek input from the Regulated Industries Complaints Office to determine whether this language was appropriate.

Members expressed their agreement with this recommendation.

- Page 8, line 16 to page 9, line 2 of the bill, Ms. Quiogue asked whether the following subsection needed to be amended:

**Prohibition on state action.** The State shall not penalize, prosecute, or otherwise take adverse action against an individual based on their actual, potential, perceived, or alleged pregnancy outcomes. The State shall not penalize, prosecute, or otherwise take adverse action against a person for aiding or assisting a pregnant individual accessing reproductive health care services in accordance with the law and with the pregnant individual’s voluntary consent.

Ms. Quiogue goes on to question whether, according to the above statement, the State may be prohibited from prosecuting an unlicensed individual who performs an abortion.

Chair Takanishi agreed with Ms. Quiogue.

Mr. Belcher agreed with Chair Takanishi and Ms. Quiogue.

Dr. Lisa Anne Ignacio agreed with Ms. Quiogue and asked if the Board can ask for the word “person” on line 20 on page 8 to be changed to “licensed professional.”

DAG Wong advised the Board to leave the word “person” in line 20, but revise page 9, line 1 by interpreting “in accordance with the law” with “the general statutes for any activities that require a license where a license is required.”

Ms. Quiogue went on to inform the members that pages 16 through 22 amend the HRS chapter 453 directly. These amendments are in line with Governor Ige’s Executive Order 22-5. However, she noted that similar amendments were not made HRS section 453-8.6 as they were to HRS section 457-12.5 and 461-21.5.

By consensus, the members expressed their support of this measure with suggested amendments.

D. DRAFT HOUSE BILL RELATING TO HEALTH CARE

The Board discussed this bill.

The purposes of this bill are to: prohibit the State from denying or interfering with a patient’s right to choose to obtain an abortion or to terminate a pregnancy if the termination is necessary to protect the life or health of the patient; repeal a criminal penalty for violations of certain abortion provisions; clarify that advanced practice registered nurses may provide abortion care; clarify that physicians, osteopathic physicians, and advanced practice registered nurses may administer a medication abortion via telehealth for a patient residing in the State.

Chair Takanishi asked if any one of the Board members had any comments and proceeded to state that the bill sounded reasonable.

Dr. Young stated that she concurred with Chair Takanishi.

By consensus, the Board supports this measure.

E. S.B. 17 RELATING TO MEDICAL INFORMED CONSENT

The Board discussed this bill.



The purposes of this bill are to: require the Board to establish standards for health care providers to ensure that a patient's consent to treatment is an informed consent; require that informed consent for a proposed medical or surgical treatment or a diagnostic or therapeutic procedure shall be obtained prior to the day of that treatment or procedure; and specify that if the treatment or procedure is to occur on the same day it is scheduled, the informed consent shall be obtained at the time the decision is made to schedule that treatment or procedure.

Chair Takanishi explained that the bill had been discussed at the Hawaii Medical Board's February 11, 2021, meeting. At that meeting, the Board had expressed their concerns regarding the extra burden that would be placed on a patient because this bill would require two visits for a single procedure. The bill would be especially burdensome for neighbor island patients who would have to travel twice to Oahu for a single procedure.

Dr. Sawai stated that she shared the Board's concerns on how this bill would disrupt emergency health care. She went on to explain that, as a surgeon, emergency procedures, which require immediate attention would be negatively affected by the bill.

Dr. Lisa Ann Ignacio agreed with Dr. Sawai, and stated that she does not support this bill.

Ms. Quiogue confirmed that she would draft testimony and provide the added comments of Dr. Lisa Ann Ignacio and Dr. Sawai in opposition of the bill.

Dr. Fujimoto asked why such measure was introduced.

Ms. Quiogue stated that she did not know and went on to say that this is a carryover measure from 2018, 2019, and 2021.

F. DC 10 ANNUAL REPORT ON FINDINGS FROM THE HAWAII PHYSICIAN WORKFORCE ASSESSMENT PROJECT

The Board discussed this report from the University of Hawaii dated December 13, 2022, transmitting the Annual Report on Findings from the Hawaii Physician Workforce Assessment Project pursuant to Act 18, Section 5, Special SLH 2009, as amended by Act 186, SLH 2012 as amended by Act 40, SLH 2017.

No position is needed on this measure.

Federation of

A. INTERSTATE MEDICAL LICENSURE COMPACT (IMLC)

State Medical  
Boards, Inc.  
(FSMB):

The Interstate Medical Licensure Compact (“Compact”) is an agreement that allows states to work together to streamline the licensing process for physicians who want to practice in multiple states.

Ms. Quiogue advised the Board members that they would need to provide general comments in support or detailed comments in opposition of the bill.

She explained to the Board members that this measure is a huge undertaking, and that to implement any kind of compact language, the Board would need dedicated staff members, including an executive officer, a secretary, an office assistant, and seed money. She went on to explain that seed money is quintessential to the funding of the program as we would need to make technology changes and fund the positions. She went on to explain that, from the division’s perspective, changes to our current system may be costly; and brought on the example of our vendor who would have to modify and/or create a new license type and its requirements, and we would also be required to transfer data to the Commission.<sup>1</sup>

She clarified to the Board that every legislative change has an impact on the Division.

Chair Takanishi was part of an FSMB taskforce in 2012 to implement this measure. He went on to recount that each state has their own statutes and process in evaluating applications; he added that 70 different Boards, 37 states, the District of Columbia, and Guam belong to the IMCL.

Chair Takanishi explained to the Board members the eligibility requirements for applicants seeking licensure through the IMCL. The information was gathered from the FSMB, IMCL website:

The first requirement of physicians to participate in the Compact is to hold a full, unrestricted medical license in a Compact member-state that can serve as a declared State of Principal License (SPL). In order to designate a state as an SPL, physicians must ensure that at least ONE of the following apply:

- The physician's primary residence is in the SPL
- At least 25% of physician's practice of medicine occurs in the SPL
- The physician is employed to practice medicine by a person, business or organization located in the SPL
- The physician uses the SPL as his or her state of residence for U.S. Federal Income Tax purposes.

The SPL has the authority to determine if a physician meets any/all of the qualifications to be granted a Compact license.

Chair Takanishi agreed with Ms. Quiogue that it would take a lot of financial support to implement the program. He went on to state that the Board had implemented an "application for licensure by endorsement" to facilitate the licensing process but supports the implementation of the IMLC.

Dr. Fujimoto expressed his concerns regarding the cost of the implementation of the program and ultimately that it would be a burden to the licensee. He went on to add that each participating state would have to help subsidize the program.

Chair Takanishi agreed that the program would be costly but stated that the benefits would outweigh the cost.

Dr. Fujimoto questioned the sustainability of the program which would require, amongst other things, ongoing fees.

Mr. Belcher commented that Ms. Quiogue's observations should be taken into consideration but, as a member of the public, supports the implementation of the Compact agreement in light of the recent emergency situation brought on by the Coronavirus pandemic.

Dr. Young agreed with Mr. Belcher, barring the financial burden.

Dr. Lisa Ann Ignacio supports the implementation of the program in light of the critical physician shortage. She went on to state that the safety of the public should always be taken into consideration. Dr. Lisa Ann Ignacio referred to the Board's October 12, 2017 meeting minutes.<sup>2</sup>

Chair Takanishi added that a lot of work is involved in the IMLC, and that the Board would require more manpower to share information with other state boards.

Chair Takanishi agreed with Dr. Fujimoto that the participation in the IMLC would inherently bring on more work for the Board staff initially; however, in the long run participation in the program would not only ease the application process, but would greatly increase the report submission and processing of other documents. He concluded that the number of Board staff would have to increase.

Mr. Belcher concurred.

Ms. Quiogue thanked the Board members for their comments.

Chair Takanishi reported that the Federation would provide financial assistance to attend the yearly meeting. The invitation is open to a senior member of the Board and another member or staff member.

Legislative Liaison:

Chair Takanishi asked the Board members if anyone of the Board members would be interested in serving as the Legislative Liaison for the current session.

Ms. Quiogue explained to the Board members that during the legislative season, bills are introduced and scheduled for hearing within forty-eight-hours of the hearing notice issuance. She explained that she would be working with the Board member in drafting testimonies, going over positions, and if the bill is controversial, the Board member would have to present testimony on behalf of the Board. She went on to say that the Chairperson and up to two additional members may be legislative liaisons.

Dr. Elizabeth Ann Ignacio commented that she would volunteer for the assignment but feared a conflict of interested with another Board she serves on, the Hawaii Medical Association.

Dr. Sawai raised her hand and stated that she would be interested in the position but feared that the forty-eight-hour window would conflict with her scheduled surgeries. She requested clarification if testimonies were to be held in person or virtually.

Ms. Quiogue explained that she would be representing the Board in person and where the presence of a Board member is required, the latter can submit their testimony virtually.

Given there were no volunteers, it was determined that Chair Takanishi would serve as the Board's legislative liaison. This matter would be considered further at a future meeting.

a. Igor Mitreski, M.D.

Dr. Mitreski requested that the Board approve a one-month preceptorship from Drexel University, following the Program's recommendation of an 8 or 12-week program.

It was moved by Chair Takanishi, seconded by Mr. Belcher, and unanimously carried, to delegate Ms. Quiogue to issue a letter to Dr. Mitreski on behalf of the Board, which states that the determination of the length of the preceptorship will be determined by the PLAS of his choosing.
