Agenda: The agenda for this meeting was posted on the State electronic calendar

as required by HRS section 92-7(b).

A brief video was played to explain procedures for this virtual meeting and how members of the public can participate and interact with the Board

during the meeting.

Call to Order: The meeting was called to order at 12:11 p.m. by Chairperson Williams,

at which time a quorum was established.

Chairperson Williams proceeded with roll call. All Board members

confirmed that they were present and alone.

Approval of the August 30, 2022, Minutes:

It was moved by Chairperson Williams, seconded by Vice-Chairperson Hall, and unanimously carried to approve the meeting minutes of the open session and the meeting minutes of the executive session of the August 30, 2022 meeting as circulated.

Adjudicatory Matters:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Chairperson Williams called for a recess from the meeting at 12:13 p.m., to discuss and deliberate on the following adjudicatory matters pursuant to Chapter 91, HRS (Note: Board members and staff entered the Microsoft Teams meeting).

A. In the Matter of the Beauty Shop License of NEZAMLOO AND BESARIO INC., dba LILY'S NAIL SPA AND HAIR SALON, and the Beauty Operator's License of JILL R. BESARIO; BAR 2022-76-L; Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order

After discussion, it was moved by Chairperson Williams, seconded by Vice-Chairperson Hall, and unanimously carried to approve the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

Following the Board's review, deliberation, and decision on these matters pursuant to Chapter 91, HRS, Chairperson Williams announced that the Board reconvenes to its regular Chapter 92, HRS, meeting at 12:26 p.m. Board members and staff returned to the Zoom meeting.

Executive Officer's Report:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Executive Officer Green noted that more scheduled meeting dates may be added, if necessary.

Licensing:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

A. Applications for Exam and License:

At 12:35 p.m., it was moved by Chairperson Williams, seconded by Vice-Chairperson Hall, and unanimously carried for the Board to enter into Executive Session to consider and evaluate personal information relating to individuals applying for licensure in accordance with HRS section 92-5(a)(1), and to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities in accordance with HRS section 92-5(a)(4). (Note: Board members and staff entered into Microsoft Teams).

EXECUTIVE SESSION

At 2:00 p.m., it was moved by Chairperson Williams, seconded by Vice-Chairperson Hall, and unanimously carried for the Board to move out of Executive Session. Board members and staff returned to the Zoom meeting.

i. Alexxis Irene Andaya(Beauty Operator Examination & License – Esthetician)

It was moved by Vice-Chairperson Hall, seconded by Mr. Murata, and unanimously carried to approve Ms. Andaya's beauty operator application.

ii. Candice A. Ennis(Beauty Operator Examination & License – Esthetician)

It was moved by Vice-Chairperson Hall, seconded by Mr. Murata, and unanimously carried to approve Ms. Ennis' beauty operator application, pending submission of additional documentation.

iii. Patrick Hanawahine (Barber Examination & License)

Chairperson Williams recused herself from voting on this matter.

It was moved by Vice-Chairperson Hall, seconded by Mr. Murata, and it was voted on by Vice-Chairperson Hall, Mr. Basta, Mr. Murata, and Mr. Yap to approve Mr. Hanawahine's barber application, pending submission of additional documentation.

Vice-Chairperson Hall noted a typo on the agenda, as follows (with new material underscored in bold and repealed material bracketed and stricken through):

iv. [Louis] Louie C. Lazo, Jr. (Barber Examination & License)

It was moved by Vice-Chairperson Hall, seconded by Mr. Murata, and unanimously carried to approve Mr. Lazo's barber application, with conditions.

v. Yen Thi Nguyen (Beauty Operator Examination & License – Nail Technician)

It was moved by Vice-Chairperson Hall, seconded by Mr. Murata, and unanimously carried to approve Ms. Nguyen's beauty operator application, pending submission of additional documentation.

vi. Desiree Roache (Barber Examination & License)

It was moved by Vice-Chairperson Hall, seconded by Mr. Murata, and unanimously carried to approve Ms. Roache's barber application.

vii. Harrison Stanley-Ham (Barber Examination & License)

It was moved by Vice-Chairperson Hall, seconded by Mr. Murata, and unanimously carried to approve Mr. Stanley-Ham's barber application.

viii. Nicole Zapel (Beauty Operator Examination & License – Esthetician)

It was moved by Vice-Chairperson Hall, seconded by Mr. Murata, and unanimously carried to approve Ms. Zapel's beauty operator application.

B. Shop Application:

i. Wanna RosePIM Facial & Beauty(New: Beauty Shop License)

It was moved by Vice-Chairperson Hall, seconded by Mr. Murata, and unanimously carried to approve the beauty shop application for Wanna Rose, dba PIM Facial & Beauty, pending submission of additional documentation.

Executive Officer Green stated that the beauty shop application will be updated to include requirements from the new ACT 073, SLH 2022.

C. Beauty School Application:

i. Pacific Esthetics Institute(New: Esthetician and Instructor)

It was moved by Vice-Chairperson Hall, seconded by Mr.

Murata, and unanimously carried to approve the beauty school application of Pacific Esthetics Institute LLC, for Esthetician and Instructor.

ii. Paul Mitchell The School Honolulu, LLC (Addition of Curriculum: Esthetician and Nail Technician)

It was moved by Vice-Chairperson Hall, seconded by Mr. Murata, and unanimously carried to approve the beauty school application of Paul Mitchell The School Honolulu LLC, for Esthetician and Nail Technician, pending submission of additional documentation.

D. Ratification List (see attached list)

It was moved by Vice-Chairperson Hall, seconded by Mr. Murata, and unanimously carried to ratify the list of issued licenses attached (see attached list).

Mr. Yap left the meeting at 2:08 p.m.

Chairperson Williams called for a recess from 2:08 p.m. to 2:14 p.m.

Old Business:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

A. Licensed Schools and Instruction Provided via Distance Learning

Executive Officer Green reiterated that at its December 22, 2020, meeting, the Board approved licensed schools and instruction provided via distance learning during the period of the COVID-19 pandemic, provided that schools comply with standards from the May 22, 2017, meeting. She further stated that the Board previously approved practical curriculum via distance learning at its May 22, 2017, meeting, with the following standards:

- Instructors provide information and demonstrations either via live video or uploaded videos;
- Students are required to take still photos of their work ("before" and "after");
- Students are required to take a video of their work, with the camera panning from their face to their hands; and
- Instructors provide feedback of submissions.

Executive Officer Green stated that the Board received an email inquiry from Mr. David Gramlich of Big Island Beauty Academy. The email states that the beauty school is in the process of receiving accreditation through

NACCAS and they are requiring state approval of the distance learning program. Big Island Beauty Academy currently offers 25% distance learning for each program. Mr. Gramlich is asking if the Board has an outline or percentage for distance learning that is Board approved.

Executive Officer Green further stated that the Board approved licensed schools and (all) instruction provided via distance learning during the period of the COVID-19 pandemic, provided that schools comply with standards from the May 22, 2017, meeting.

Chairperson Williams asked if the COVID-19 pandemic was over.

Executive Officer Green replied that there has not been an official statement from any appropriate governing body regarding the end of the COVID-19 pandemic.

Vice-Chairperson Hall opined that the theory training portion should only be allowed and considered for distance learning, as everything else requires hands-on practical application training.

Mr. Murata and Mr. Basta both agreed with Vice-Chairperson Hall.

Mr. Murata expressed concern regarding the practical application training portion for distance learning. He questioned how the instructor would provide hands-on training and guidance to the student via distance learning.

Mr. Basta opined that in the barbering and cosmetology field, the practical application training needs to be hands-on and not through a computer or online.

Chairperson Williams asked if the theory portion allowed for distance learning applies only to the required 200-400 hours of theory training in the barbering and cosmetology curriculums.

Vice-Chairperson Hall stated that the 200-400 hours of theory in the barbering and cosmetology curriculums isn't the only theory portion, but theory also includes everything else that is learned by hands-on practical application theory.

Referring to Mr. Gramlich's email, Vice-Chairperson Hall questioned what exactly the 25% distance learning for each program entails.

Chairperson Williams responded that the 25% probably includes theory training and practical application theory, as the theory training alone is not 25% of the cosmetology curriculum.

Vice-Chairperson opined that practical application theory would be acceptable on a mannequin but should not be done on a human.

Mr. Murata expressed concern regarding the safety and health guidelines of allowing practical application theory to be done on a human via distance learning other than at a licensed beauty or barber school.

By consensus, the Board determined that effective January 1, 2023, up to, but not more than, 25% of the theory curriculum may be taught via distance learning for students starting a program in a beauty school on or after January 1, 2023; and the practical application theory portion must only be performed on mannequins. This determination applies prospectively and does not overturn or otherwise modify prior Board approvals.

Executive Officer Green stated that a bulletin will be posted to the Board's website to inform everyone of the Board's determination regarding licensed schools and instruction via distance learning.

B. <u>Email Inquiry: Can apprenticeships receive "distance learning" hours for the theory portion of their hour requirement?</u>

Chairperson Williams opined that online education for the theory portion would be acceptable, but distance learning for the practical application theory portion cannot be regulated and she foresees the possibility of fraud in apprenticeship hours.

Vice-Chairperson Hall agreed with Chairperson Williams. She stated that an apprenticeship program should be hands-on and taught in-person by a supervising barber or beauty operator. She opined that distance learning would not work for an apprenticeship program, but online education for the theory portion would be acceptable.

Mr. Basta agreed with both Chairperson Williams and Vice-Chairperson Hall.

By consensus, the Board determined that apprentices cannot receive distance learning hours for the theory portion of their hour requirement.

New Business:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

A. <u>Email Inquiry: Can a Barber apply for an Instructors License to Teach Hairdressing in a Beauty School?</u>

Mr. Basta asked what the requirements are for a Hairdresser to be an Instructor at a beauty school.

Executive Officer Shahan responded that the requirements are 600 hours of Instructor training, a current and valid Hawaii Beauty Operator license, and one (1) year of licensed beauty operator experience in Hawaii or in another jurisdiction.

Vice-Chairperson Hall stated that an Instructor should teach in the appropriate category that they are licensed in.

Discussion ensued that a barber license and a beauty operator license in the hairdressing classification are two different license types. The Instructor license allows an individual to train and teach in their appropriate license classification(s).

By consensus, the Board determined that, while there is nothing that precludes an individual from submitting an Instructor application, a barber who does not meet the requirements for an Instructor license, pursuant to Act 073, SLH 2022, and HAR Chapter 16-78, cannot qualify for an Instructor license to teach hairdressing in a beauty school.
