Ms. Doi stated when licensees renew, they will attest to completing the CE requirements. The Board's office will conduct a random audit, at which time the applicant will need to provide proof of CE documentation if selected.

Ms. Doi stated she will be adding edits that the first aid, CPR, or any other emergency related course must have a hands-on training component.

Ms. Frankel asked how applicants will know about the exam provider PSI.

Ms. Doi stated the licensing branch sends exam approval notices with the exam provider contact information and instructions on how to register for the exam.
