	Requests a determination on whether a C-31d Tuckpointing and caulking license is the correct license for a contractor to hold to perform deep structural concrete spall repairs on a condominium spall repair project.
	The Board reviewed the email inquiry and information, including the photos labeled (1) Bldg #4 (7 <sup>th</sup> Floor) Spall #2 54" x 9", (2) Bldg #4 C Stack 41" x 3" and (3) Bldg #4 (5 <sup>th</sup> Floor) 60" x 31" x 3" (60" length x 31" wide x 3" in depth), and the description of the C-31 Masonry classification and its subclassifications.
	<u>Recommendation</u> : Based solely on the information provided, the C-31 Masonry, C-31a Cement concrete, or C-31d Tuckpointing and caulking contractor may perform deep structural concrete spall repairs on the condominium spall repair project.
	It was moved by Mr. Arita, seconded by Mr. Polischeck, and unanimously carried to approve the above scope recommendation.
<u>Chapter 91, HRS,</u> <u>Adjudicatory</u> <u>Matters</u> :	Chairperson Arita called for a recess from the Board's meeting at 9:05 a.m. to discuss and deliberate on the following adjudicatory matters pursuant to HRS chapter 91. 1. <u>Settlement Agreements</u>

a. In the Matter of the Contractors' Licenses of Atlas Construction, Inc., and Bruce Kim; CLB 2021-234-L.

On or about October 31, 2019, Atlas Construction, Inc. ("Respondent Atlas") entered into a written contract with a homeowner to build a new construction residence in Hawaii ("Project"). The written contract failed to include the names and license numbers of subcontractors to be used on the Project. However, Bruce Kim and Respondent Atlas ("Respondents") subsequently provided the subcontractor information upon request by the homeowner.

On or about September 10, 2020, Respondent Atlas entered a subcontractor agreement with Lilia Construction LLC to grade and level the property and pour the foundation, driveway and sidewalks for payment of \$47,741.12.

Professional and Vocational Licensing records show Lilia Construction LLC did not hold a valid, active contractors license at the time of the subcontractor agreement. However, Lilia Eviota, the member/manager of Lilia Construction LLC, did hold an active sole proprietor contractors license at the time of contracting (CT 30877).

On or about November 11, 2020, Respondent Atlas entered into a subcontractor agreement with CJ's Tile and Marble to install tile and grout at the Project for payment of \$7,643.10.

Professional and Vocational Licensing records show Charles E. Williams II dba CJ's Tile and Marble previously held a contractors license (CT 29354), but the license expired and was forfeited effective November 30, 2016.

RICO alleges Respondent Atlas subcontracted with unlicensed entities and/or persons to perform work on the Project that requires a license.

RICO alleges Respondent Atlas failed to list the subcontractors and their license information in the initial contract for the Project.

If proven at an administrative hearing, the allegations would constitute violations of the following laws and rules:

- HRS § 444-17(17) (entering into a contract with an unlicensed contractor involving work or activity for the performance of which licensing is required under this chapter);
- HAR § 16-77-80(a)(5) (written contract shall include the approximate percentage of work to be subcontracted and the names and license numbers of all subcontractors); and
- HAR § 16-77-71, 16-77-75 (RME responsible for acts and omissions of contracting entity)

Respondents shall jointly and severally pay an administrative fine \$4,000.00.

b. In the Matter of the Contractors' Licenses of James M. Murray, and JM Finish Carpentry LLC, doing business as Ohana Construction; CLB 2022-45-L.

RICO alleges that on or about April 7, 2021, Complainant signed a written contract to have James M. Murray, and JM Finish Carpentry LLC, doing business as Ohana Construction ("Respondents") replace a roof and do some plumbing work at a residence in Hawaii in exchange for \$11,577.32. Complainant paid Respondents \$5,788.66.

The contract did not include the following disclosures: lien and bond rights, Contractor's Right to Repair Act, the project's start and end dates, the scope of the work, the license numbers and classifications of the contractors, and the list of subcontractors.

If proven at an administrative hearing the allegations would constitute violations of the following laws and rules:

- HRS § 444-25.5(b) (failure to include Contractor's Right to Repair Act);
- HAR § 16-77- 80(a)(1) (failure to include the license numbers and classifications of the contractors in the contract);
- HAR § 16-77-80(a)(3) (failure to include the date work is to commence and the number of days for completion in the contract);
- HAR § 16-77-80(a)(4) (failure to include the scope of the work to be performed in the contract); and
- HAR § 16-77-80(a)(5) (failure to include the approximate percentage of work to be subcontracted and the names and license numbers of all subcontractors in the contract)

Respondents agree to pay a fine, jointly and severally, in the amount of \$2,500.00.

c. In the Matter of the Contractors' License of Northwest Exteriors Inc., doing business as Windows Hawaii a Division of Northwest Exteriors; Thomas M. Orr, RME; CLB 2022-441-L

RICO alleges that Northwest Exteriors, Inc., doing business as Windows Hawaii a Division of Northwest Exteriors and Thomas M. Orr's ("Respondents")' homeowner contracts did not include all required homeowner disclosures. Thomas M. Orr ("Respondent Orr") did not sign or initial all of Respondents' contracts, and Respondent Orr was not in residence in the State of Hawaii during Respondents' contractor activity.

If proven at an administrative hearing the allegations would constitute violations of the following laws and rules:

- HRS § 444-25.5(b) (required disclosures in homeowner contracts);
- HAR § 16-77-71(a)(2) (RME shall sign or initial all contracts);
- HAR § 16-77-71(a)(4) (RME shall be in residence in Hawaii during the period a project is under construction); and
- HAR § 16-77-80 (required disclosures in homeowner contracts)

Respondents agree to pay a fine in the amount of \$8,000.00.

After discussion, it was moved by Mr. Polischeck, seconded by Mr. Alejado, and

	unanimously carried to approve the Settle Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order in the above cases.
	Following the Board's review, deliberation, and decisions in these matters, pursuant to HRS chapter 91, Chairperson Arita announced that the Board was reconvening to its open meeting at 9:14 a.m.

f. Shane E. K. Teves, RME Kore Construction LLC "B" General building

It was moved by Mr. Higashihara, seconded by Mr. Polischeck, and unanimously carried to defer Kore Construction and Mr. Teves's application for licensure in the "B" General building classification pending the submittal of (1) a revised project list, verifying forty-eight months of his on-site supervision and direction of his own employees constructing buildings from the "ground-up", which includes: (a) the trades performed in-house with his own employees and the trades that were subcontracted to other licensed contractors; and (b) amended "Amount of Supervisory Experience" as it should only include the actual amount of time spent on-site supervising his own employees performing work in the broad scope of the "B" General building classification. Do not include time spent supervising work that is not within the scope of the "B" General building classification and supervising subcontractors; and (2) a signed and notarized Experience Certificate from the RME of Coastal Construction Co, Inc.

- g. Christopher B. Metzler (Individual)

It was moved by Mr. Higashihara, seconded by Mr. Polischeck, and unanimously carried to defer Mr. Metzler's applications for licensure in the: (1) "A" General engineering classification pending the submittal of a revised project list verifying forty-eight months of his on-site supervision and direction of his own employees performing projects in the broad scope of the "A" General engineering classification (e.g. roadways, bridges, water lines, bringing utilities into a building) which includes: (a) the trades performed in-house with his own employees and the trades that were subcontracted to other licensed contractors; (b) a more detailed description of the "A" General engineering projects and the work he supervised; and (c) an amended "Amount of Supervisory Experience" as it should be commensurate with the number of workers (employees) that he supervised, the "Detailed Description of the Work You Supervised", and the "Contract Amount"; and (2) "B" General building classification pending the submittal of: (a) a revised project list, verifying forty-eight months of his on-site supervision and direction of his own employees constructing buildings from the "ground-up", which includes: (i) the trades performed inhouse with his own employees and the trades that were subcontracted to other licensed contractors; (ii) additional projects that he supervised more than ten years ago; (iii) a more detailed

description of the work performed by his employees under his supervision for each project; (iv) an amended "Amount of Supervisory Experience" as it should only include the actual amount of time spent on-site supervising his own employees performing work in the broad scope of the "B" General building classification. Do not include time spent for design, ordering materials, scheduling, or downtime for rainouts or waiting for delivery of materials, supervising work outside the scope of the "B" General building classification or supervising subcontractors; and (b) signed and notarized Experience Certificates from Logan Fellhauer and Randy Potochney that describe his on-site supervision and direction of his employees in their own words.

The Contractors Examination Summary for January and February 2023 were distributed to the Board for their information.

2023 Legislation: Relating to Procurement

a. H.B. 542, H.D. 2

Allows bidders to clarify or correct immaterial or technical information required as part of a bid submission for up to twenty-four hours after the bid submission deadline. Requires that bids for construction be opened no sooner than twenty-four hours after the deadline for the submission of bids. Defines "immaterial or technical information". Repeals 6/30/2026.

H.B. 542, H.D. 2 crossed over to the Senate and the Committee on Government Operations ("GVO") held a hearing on March 14, 2023. The Board submitted testimony in opposition.

GVO voted to defer this measure indefinitely.

Resolutions

b. S.R. 213 / S.C.R. 146 H.R. 54 / H.C.R. 52

Requesting the Department of Commerce and Consumer Affairs and the Contractors License Board to Ensure that the Contractors License Board Includes At least Two Members with Expertise in Specialty Structural Contracting.

Messrs. Hayashi and O'Donnell recused themselves.

Executive Officer Ito stated that the Board has opposed similar bills in the past for the following reasons:

- 1. Given that the contractor rules set forth over 90 different sub-specialty classifications, the Board believes that disproportionate board representation in any one subspecialty is problematic.
- 2. The Board believes that it does have the expertise to evaluate the experience of applicants in the following classifications and has been licensing contractors in the C-6 Carpentry framing, C-31 Masonry, C-32 Ornamental, guardrail, and fencing, C-35 Pile driving, pile and caisson drilling, and foundation, C-38 Post tensioning, C-41 Reinforcing steel, C-48 Structural steel, and C-56 Welding classifications for decades.
- 3. The Board is not aware of any incidents of structural failures or structural contracting issues.
- 4. It is unnecessary to have at least two specialty contractor members licensed in at least one of the eight classifications in the 4<sup>th</sup> whereas paragraph because the complement of general contractor and specialty contractor members on the Board provide a broad range of contracting expertise and experience to address structural contracting issues that may arise.

Chairperson Arita asked the Board if they would be comfortable if anyone else asked to have two members in another specialty classification added to the Board composition given that the objective is to have diverse representation on the Board. He stated that he understands what the iron workers want to accomplish; however, the Board's responsibility is to protect the public. Chairperson Arita stated that his position is to oppose this resolution because he believes that diversity is important and there should not be more representation for certain classifications on the Board.

Mr. Polischeck stated that in his years of serving on the Board there has always been a good amount of diversity on the Board. He felt that if certain classifications get more representation on the Board, the Board will be unbalanced and opposes these resolutions. Mr. Hayashi stated that historically the Board testifies in opposition to this kind of resolution. It was moved by Mr. Higashihara, seconded by Chairperson Arita, to oppose S.R. 213, S.C.R. 146, H.R. 54, and H.C.R. 52 for the reasons stated above. With Messrs. Hayashi and O'Donnell recusing themselves and five votes in favor, the motion was not carried.
