Agenda:

The agenda for this meeting was posted on the State electronic calendar as required by HRS section 92-7(b).

A brief video was played to explain procedures for this virtual meeting and how members of the public can participate and interact with the Board during the meeting.

Call to Order:

The meeting was called to order at 12:09 p.m. by Chairperson Williams, at which time a quorum was established.

Chairperson Williams proceeded with roll call. All Board members confirmed that they were present and alone.

By consensus, the Board amended the agenda to correct inadvertent errors, as follows (with new material underscored in bold and repealed material bracketed and stricken through):

Approval of the October 25, 2022, Minutes:

It was moved by Mr. Murata, seconded by Mr. Yap, and unanimously carried to approve the meeting minutes of the open session and the meeting minutes of the executive session of the October 25, 2022, meeting as circulated.

Adjudicatory Matters:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Chairperson Williams called for a recess from the meeting at 12:12 p.m., to discuss and deliberate on the following adjudicatory matters pursuant to Chapter 91, HRS (Note: Board members and staff entered the Microsoft Teams meeting).

After discussion, it was moved by Chairperson Williams, seconded by Vice-Chairperson Hall, and unanimously carried to approve the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order relating to the Matter of the Beauty Shop License of ROYAL NAILS, LLC; BAR 2019-97-L, the Matter of the Beauty Shop License of HUONG PHAN LLC, doing business as BEAUTY NAIL N SPA; BAR 2021-98-L, and the Matter of the Beauty Operator's License of SAAJIDA L.L. SERRANO; BAR 2022-147-L.

Following the Board's review, deliberation, and decision on these matters pursuant to Chapter 91, HRS, Chairperson Williams announced that the Board was reconvening to its open meeting at 12:29 p.m.

Barbering and Cosmetology Examinations:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item.

Alon Schwartz and Shawn Conder were promoted to panelists.

A. PSI Services, LLC
Alon Schwartz, Senior Vice President, Licensure
Shawn Conder, Account Services Director, Cosmetology-Barber
Division

Mr. Schwartz and Mr. Conder introduced themselves to the Board and provided a brief presentation on the PSI National Cosmetology Testing Program as summarized below:

- PSI Services, LLC, has been around for 75 years and has delivered state licensure examinations for 35 years (over 22 million tests delivered annually).
- PSI Services, LLC, Cosmetology-Barber Division looked into legislation and government regarding reduction of hours to deregulation.
- Found out they need to reduce barriers to licensure by reducing barriers/issues surrounding licensure testing.
- Created "The PSI Solution" which was a national exam program for barbering and cosmetology currently in California, Kentucky, Michigan, Massachusetts and Tennessee.
- "The PSI Solution" includes:
 - National Consistency in Testing: simplify endorsement/universal reciprocity, national compact of states for cosmetology;
 - 2) Eliminate Unnecessary Barriers to Licensure: remove unnecessary content, create tests that focus primarily on public health and safety;
 - 3) Researched the Surrounding Issues: Nevada Project, The

- Adversarial Opinions, Government and Legislative Opinion; and
- National Associations: Federation of Associations of Regulatory Boards (FARB), American Association of Cosmetology Schools (AACS)
- PSI's National Cosmetology/Barber Testing Program includes:
 - Test Titles: Master Cosmetology, Cosmetology, Master Barber, Barber, Master Esthetics, Esthetics, Nail Technology, Electrology, Instructor, Natural Hair Enhancements, Professional Lash Enhancements, Wax Technician
 - 2) Languages: English, Spanish, Vietnamese, Korean, Simplified Chinese
 - 3) Exam Types: Theory, Written Practical, Hands-on Practical
- PSI created a Test Advisory Board
- Test Delivery
 - 1) Online Proctoring: theory, written, practical, and virtual hands-on practical
 - 2) Test Centers: 400 test centers in the U.S., 5 test centers currently in Hawaii

The presentation ended and the floor was open for any questions or discussion.

Chairperson Williams inquired what the average first time passing rate is for barbering and cosmetology testing.

Mr. Schwartz stated he does not have that information at the moment but will provide that to the Board after the meeting.

Chairperson Williams inquired about how often PSI updates the tests.

Mr. Conder responded that PSI updates the tests every five (5) years.

Chairperson Williams questioned how often PSI physically monitors the security of the test centers to be sure the tests and information are secured.

Mr. Schwartz responded that all PSI test centers have cameras that are monitored and have continuous recording. PSI performs camera audits and physical audits of all the test centers at least once a year.

Mr. Murata asked if all the PSI tests for barbering and cosmetology are the same.

Mr. Conder responded that PSI has a standard core section, but the tests are tailored to each client's needs and requests.

Mr. Murata inquired if a state can add in their state laws and rules to the tests.

Mr. Conder answered in the affirmative.

Mr. Murata expressed concern regarding the security of the online athome proctoring.

Mr. Schwartz stated that there is security in place for online at-home proctoring. The candidate taking the test has to scan the room with their camera before and during the exam. He confirmed that all functions on the computer of the candidate are disabled; they cannot access any other screens, and the web browser for the exam is locked.

Vice Chairperson Hall inquired if the tests are available in the different languages offered.

Mr. Schwartz answered in the affirmative. He also noted that the English language is also made available for the other languages during the test.

Mary Ronnow attended the meeting in-person and requested to testify on this agenda item. She introduced herself to the Board as the Owner and Director of The Skin Institute Internationalé.

Ms. Ronnow explained that in order for her beauty school to keep their accreditation, GI bill pending title for funding, she has to report to government agencies how many individuals have taken and passed the test. She further stated that the Board's current testing provider, Prometric, has not been able to provide that information. She asked if PSI would allow her to obtain the information needed.

Mr. Schwartz answered in the affirmative, but only if the client (e.g., state agency) allows that.

Executive Officer Green requested that PSI provide the Board with a list of all the states that utilize the PSI exams for barbering and/or cosmetology with a breakdown of the specific exams that each state administers.

Mr. Schwartz confirmed he will provide that to the Board after the meeting.

Vice Chairperson Hall inquired as to the location of the testing sites.

Mr. Schwartz responded that there are testing sites on Oahu, Maui, Hawaii, and Kauai. He will provide to the Board a current list of all active testing locations in Hawaii and how often the tests provided.

Mr. Yap inquired as to the costs of the testing.

Mr. Schwartz responded that the exam fees vary and are determined by different variables, depending on the client's needs and the type of testing program.

Executive Officer Green requested that PSI provide the Board with the key variables that would help determine the cost.

Mr. Schwartz confirmed he will provide that to the Board after the meeting.

Chairperson Williams inquired on the processing time of when an applicant is approved for exam and the availability of testing dates.

Mr. Schwartz responded that PSI monitors the registration numbers to determine if the test center needs to be open more frequently for exams.

Discussion ensued regarding the testing material and Mr. Conder clarified that the theory portion of the exam is from Milady and Pivot Point. He stated that the information and study materials need to be available in both references, and that the references may not contradict each other, in order for it to be included in the exam.

Mr. Schwartz and Mr. Conder returned to attendee.

Sean Colton, Susan Colard, and Katrina Albrecht were promoted to panelists.

B. National Interstate Counsel of State Boards of Cosmetology ("NIC") & Prometric

Susan Colard, Executive Director/Government Relations, NIC Sean Colton, Senior Account Director, Prometric Katrina Albrecht, Client Success Manager, Prometric

Mr. Colton introduced himself, Ms. Colard, and Ms. Albrecht to the Board and provided a brief presentation on the Prometric contract and current partnership with NIC as summarized below:

- Contract: Prometric and Hawaii have partnered for approximately 20 years.
- Partnership with NIC: Hawaii Board transitioned to the NIC

content and computer-based testing in March 2020.

- Titles Offered
 - 1) Test Titles: Barber, Barber Styling, Cosmetology, Esthetician, Nail Technician, Body Piercing, Electrology, Hair Design, Hair Removal, Instructor, and Tattooing
 - 2) Languages: English, Spanish, Vietnamese, Korean, Russian, and Persian/Farsi
- Remote Proctoring has required standards such as the lockdown browser, which prevents candidates from screen printing, and a live proctor to monitor the candidate and is able to terminate the exam at any time.
 - 1) Flexibility: easy scheduling, able to test 24 hours a day, and results at the end of exam;
 - 2) Secure;
 - 3) Live proctoring and support for testing candidates (candidates can request proctors who speak other languages such as Spanish, Chinese, and French); and
 - 4) Approved by the credentialling bodies.

Mr. Colton stated that Prometric has a third-party client that performs quarterly audits (i.e., secret shoppers) of the entire remote process.

The presentation ended and the floor was open for any questions or discussion.

Chairperson Williams expressed concern that there have been many applicants who have not able to schedule their tests due to testing site availability.

Mr. Colton responded that Prometric has a site procurement and availability team that are monitoring all sites daily.

Vice Chairperson Hall asked how many testing sites Prometric currently has on each island.

Mr. Colton stated he will provide that to the Board after the meeting.

Ms. Albrecht stated the current Prometric testing sites are in Hilo (1 site), Honolulu (2 sites), Kailua (1 site) for the barber pen-and-paper exam, and Lahaina (1 site). Prometric is currently in the process of securing a testing site on Kauai.

Mr. Colton stated that there are multiple versions of each NIC exam offered.

Executive Officer Green inquired as to how often the NIC exam is updated.

Mr. Colton responded that an analysis is done every five (5) years, but new forms are released yearly with 25% overlap questions and 75% new questions.

Vice Chairperson Hall inquired about the materials/content of the NIC exam.

Mr. Colton Mr. clarified that the theory exam portion is from Milady and Pivot Point. He also stated that the information and study materials need to be available in both references, and that the references may not contradict each other, in order for it to be included in the exam.

Executive Officer Green asked Mr. Colton to provide the Board with a list of all the states that utilize the NIC exam for barbering and/or cosmetology with a breakdown of the specific exams each state administers.

Mr. Colton confirmed he will work with NIC to provide that to the Board after the meeting.

Mr. Colton stated that Prometric does offer a portal that schools can obtain exam result data, as permitted by the respective state.

Mr. Yap inquired about the current NIC test costs. He also commented that the current Prometric testing site in Lahaina, Maui is not a central location and would like to see other locations available on the island.

Chairperson Williams inquired about the cost to incorporate Hawaii state laws and rules questions to the current NIC theory exams.

Mr. Colton stated that he can provide that information to the Board after the meeting.

Ms. Colard encouraged the Board to reach out to her if anyone had questions in relation to the NIC or any concerns with the testing providers.

Mr. Basta stated that he had a question for Mr. Conder from PSI.

Mr. Conder was promoted to panelist.

Mr. Basta inquired about PSI's "universal reciprocity" and asked how many states recognize reciprocity within PSI.

Mr. Conder replied that PSI has no control over reciprocity between one state to another. However, PSI would like to see national consistency in testing.

Mr. Conder returned to attendee.

Chairperson Williams requested NIC to provide the Board with a list of states that grant reciprocity for NIC exams.

Ms. Colard stated that NIC will provide the Board a list of states with updated information regarding how many hours each state requires, license regulation, and who to contact for reciprocity.

Mr. Colton, Ms. Colard, and Ms. Albrecht returned to attendee.

There was no further discussion.

Executive Officer's Report:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Licensing:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

At 1:50 p.m., it was moved by Chairperson Williams, seconded by Vice-Chairperson Hall, and unanimously carried for the Board to enter into Executive Session to consider and evaluate personal information relating to individuals applying for licensure in accordance with HRS section 92-5(a)(1), and to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and

liabilities in accordance with HRS section 92-5(a)(4). (Note: Board members and staff entered into Microsoft Teams).

EXECUTIVE SESSION

At 2:51 p.m., it was moved by Vice Chairperson Hall, seconded by Chairperson Williams, and unanimously carried for the Board to move out of Executive Session and to reconvene to the Board's regular order of business.

A. Applications for Exam and License:

i. Patrick Hanawahine(Barber Exam & License)

It was moved by Vice-Chairperson Hall, seconded by Chairperson Williams, and unanimously carried to approve Mr. Hanawahine's barber application, with conditions.

ii. Sidney Wasina(Beauty Operator Exam [Waiver] & License – Hairdresser)

It was moved by Vice-Chairperson Hall, seconded by Chairperson Williams, and unanimously carried to correct an inadvertent error on the agenda with regard to Sidney Wasina's application (correction noted above with new material underscored in bold and repealed material bracketed and stricken through) and to approve Sidney Wasina's beauty operator application.

iii. Kawai Paa ([Beauty Operator Exam & License – Hairdresser] Barber Apprentice)

It was moved by Vice-Chairperson Hall, seconded by Chairperson Williams, and unanimously carried to correct an inadvertent error on the agenda with regard to Kawai Paa's application (correction noted above with new material underscored in bold and repealed material bracketed and stricken through) and to approve Kawai Paa's barber apprentice application.

B. Shop Application:

i. Jeffrey GaulSephora USA, Inc.(New: Beauty Shop License – for Esthetics)

It was moved by Vice-Chairperson Hall, seconded by Chairperson Williams, and unanimously carried to approve the beauty shop application for Sephora USA, Inc.

ii. Saajida L. Lane SerranoLightroom Honolulu, LLC(New: Beauty Shop License – for Cosmetology)

It was moved by Vice-Chairperson Hall, seconded by Chairperson Williams, and unanimously carried to approve the beauty shop application for Lightroom Honolulu, LLC.

C. Beauty School Application:

None.

D. Ratification List (see attached list)

It was moved by Vice-Chairperson Hall, seconded by Chairperson Williams, and unanimously carried to ratify the list of issued licenses attached (see attached list).

New Business:

Chairperson Williams asked if any members of the public would like to provide oral testimony on this agenda item.

A. Letter from Mary Ronnow, The Skin Institute Internationalé

Ms. Ronnow attended the meeting in-person and requested to testify on this agenda item. She introduced herself to the Board as the Owner and Director of The Skin Institute Internationalé (licensed beauty school).

i. Requirements for Licensed Instructors

Ms. Ronnow expressed that the The Skin Institute Internationalé is in need of licensed instructors. She stated that the school currently has a Board approved instructor 600-hour training program. She is requesting the Board to revise the instructor requirement to at least one year of licensed beauty operator experience <u>or</u> instructor training of at least 600 hours, to streamline the process.

Chairperson Williams cited Hawaii Revised Statutes ("HRS") section 439A-6(h), which states:

- "(h) A beauty instructor applicant may apply to teach in any of the practices of cosmetology if the applicant has:
- (1) Completed six hundred hours of a board approved course in the theory and practice of instruction; and
- (2) Served actively for a period of at least one year as a beauty operator in the State or in another jurisdiction having standards for beauty operators substantially equivalent to those of the State."

And Hawaii Administrative Rules ("HAR") section 16-78-20(a) which states:

- "(a) Instructor applicants shall provide verification of:
- (1) Having a current beauty operator license or an instructor license;
- (2) Having one year experience as a licensed beauty operator; and
- (3) Satisfactorily completing not less than six hundred hours or four months of beauty school instructor training in this State or another jurisdiction having substantially equivalent standards. If the training is not substantially equivalent, the applicant shall provide verification of one year instructor experience."

Chairperson Williams stated that pursuant to HRS section 439A-6(h) and HAR section 16-78-20(a), 600 hours of instruction <u>and</u> one year of experience as a licensed beauty operator are required.

Ms. Ronnow asked if there is a way to change the laws.

Executive Officer Green responded that bills may be put forth to amend laws through the legislative process.

ii. Unlicensed Teaching at Unlicensed Schools

Ms. Ronnow expressed her frustration with the increase of unlicensed teaching at unlicensed schools in the State.

Executive Officer Green stated that the Board has delegated authority to receive, arbitrate, investigate, and prosecute complaints to our Regulated Industries Complaints Office ("RICO"). If there is an allegation of unlicensed activity, complaints may be filed directly with RICO. Complaints that are submitted to the Board's office will be forward to RICO.

iii. Test Score Results Challenges

Ms. Ronnow stated that this agenda item was addressed in the Prometric/NIC and PSI presentations earlier, and she had no further question or comment.

- B. Email from Wendy Takahashi, The Skin Institute Internationalé
 - i. Eligibility regarding licensed estheticians becoming licensed instructors
 - ii. Proposal: Licensed estheticians should be eligible to become licensed instructors after completing the 600-hour Instructor Program OR after having one year's experience as a licensed esthetician.

Ms. Ronnow stated that this agenda item was addressed during her earlier agenda item with the Board, and she had no further question or comment.

Chairperson Williams re-stated that pursuant to HRS section 439A-6(h) and HAR section 16-78-20(a), 600 hours of instruction and one year of experience as a licensed beauty operator are required.

Ms. Ronnow left the meeting.

C. Carly Sai, Paul Mitchell the School
Paul Mitchell the School Honolulu, LLC, is requesting Board
review and approval of providing 100% of their curriculum
methodology as an online practical program.

Carly Sai was promoted to panelist.

Ms. Sai introduced herself to the Board as the Director of Paul Mitchell the School Honolulu, LLC (licensed beauty school).

Ms. Sai presented her request to the Board as summarized below:

- Paul Mitchell the School received a notice from the Board dated December 14, 2022 stating "effective January 1, 2023:

 (i) up to 25%, at most, of the theory curriculum may be taught via distance learning for students starting a program in a beauty school on or after January 1, 2023; and (ii) the practical application theory portion of any such distance learning shall not be performed on live subjects and may only be performed on mannequins."
- HAR section 16-78-22, Exhibit C entitled "Beauty School Curriculum" as follows:

- 1) Theory for Cosmetologist: 200 hours; 50 hours allowed to be taught via distance learning
- 2) Theory for Manicurist (Nail Technician): 100 hours; 25 hours allowed to be taught via distance learning
- 3) Theory for Cosmetician (Esthetician): 100 hours; 25 hours allowed to be taught via distance learning
- 4) Theory for Hairdresser: 100 hours; 25 hours allowed to be taught via distance learning
- Request: Approval for 25% of the total program hours to be taught online via distance learning for all approved programs
 - 1) Theory for Cosmetologist: 1,800 hours; requesting for 450 hours to be taught via distance learning
 - 2) Theory for Manicurist (Nail Technician): 350 hours; requesting for 87.5 hours to be taught via distance learning
 - Theory for Cosmetician (Esthetician): 550 hours; requesting for 137.5 hours to be taught via distance learning
 - 4) Theory for Hairdresser: 1,250 hours; requesting for 312.5 hours to be taught via distance learning
- How We Will Implement: 25% of curriculum is focused on the preparation for the State exam and professional development through study of textbook, vocabulary, quizzes, and prepping for the exams.
- School uses a platform called "Pivot Point Lab" (learning portal) which allows them to successfully teach and engage with students both online and in-person.
- School Schedule Example:

- "Pivot Point Lab": daily schedule, lessons, and a QR code to track hours while working online.
 - 1) Learning Connection
 - 2) Talking Points
 - 3) Show You Know
 - 4) Lesson Challenge
- Only "Pivot Point Lab" instruction and professional development will be taught via distance learning; no practical instruction will be taught via distance learning.
- Why We Teach This Way:
 - 1) Students are accustomed to learning from the textbook using digital resources; and
 - 2) Students will still have the option to come into school on

their distance learning day and complete these items on campus with an instructor.

The presentation ended and the floor was open for any questions or discussion.

Executive Officer Green stated that although the agenda item states that Ms. Sai is requesting approval of 100% of the curriculum methodology as an online practical program, it appears that she is requesting 100% of just the theory curriculum to be offered via distance learning.

Ms. Sai answered in the affirmative. She is requesting approval of 100% of the theory curriculum via distance learning that is not theory practical or practical, so as to allow up to 25% of the total curriculum.

Chairperson Williams inquired if there will be any lectures to follow up with the online training.

Ms. Sai responded that the learning leader does an online "face to face" with the student at the end of the day to review everything they learned that day. She noted that the learning leaders are working with the students throughout the day and engaging with them in the online portal.

Vice Chairperson Hall requested clarification on the process of how the learning leaders and students are connected online throughout the day.

Ms. Sai stated that all assignments are asynchronous, but there is an option in the online portal to connect via a Zoom call, which is available daily from 9:30 a.m. to 6:30 p.m. Hawaii Standard Time. She reiterated that she is requesting 100% of just the theory curriculum via distance learning, which only includes the preparation for the State exam and professional development through study of textbook and vocabulary. All practical theory and practical will be done in-person on campus with an instructor.
