Meeting Minutes of  
November 15, 2022:

Chair Tamayo asked if there were any comments or concerns regarding the Board and Executive Session Minutes of the November 15, 2022 meeting. There were none.

Chapter 91, HRS,  
Adjudicatory  
Matters:

Chair Tamayo called for a recess from the Board's meeting at 9:13 a.m. to discuss and deliberate on the following adjudicatory matters pursuant to HRS chapter 91.

- a. In the Matter of the License to Practice Physical Therapy of Grace A. Gayatinea-Ollivier; PTS-2022-3-L – Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order

After discussion, it was moved by Chair Tamayo, seconded by Ms. Keliinoi, and unanimously carried to accept the above-referenced Settlement Agreement.

At 9:26 a.m., the Board moved out of Chapter 91, HRS.

The Board returned to its regular order of business.

2023 Legislative Session:

a. Senate Bill No. 668

Allows the Governor to enter the State into the multi-state Physical Therapy Licensure Compact, which will allow a physical therapist licensed by a home state to practice under a multi-state licensure privilege in each party state.

The Board appreciates the intent and offers comments on the bill. Hawaii does not currently require applicants for licensure as a Physical Therapist or Physical Therapy Assistant to complete an FBI criminal background check. There is no provision in the Board's statutes or administrative rules that require a criminal background check. Hawaii Revised Statutes (HRS) Section 461J-6 and HRS Section 846-2.7 would need to be amended by adding language that would require applicants to complete an FBI criminal background check.

Legislative Liaison:

It was moved by Chair Tamayo, seconded by Ms. Chee, and unanimously carried to appoint Ms. Zazzera as the Board's legislative liaison.
