6. New Business: a. Discussion on requiring applicants to complete the National Certification Commission for Acupuncture & Oriental Medicine ("NCCAOM") Foundations of Oriental Medicine, Acupuncture with

Point Location, and Biomedicine exam modules for licensure and revising the acupuncture license application

The Board discussed revisions to the acupuncture license application and consulted Dr. Wai Low.

Chair Kroll asked Dr. Wai Low, "In what case will an applicant need to be approved by the Board in order to take the examination from the NCCAOM?"

Dr. Wai Low stated that an applicant might want to verify that their foreign education meets the Hawaii requirements before registering to take the NCCAOM exam.

Chair Kroll stated that NCCAOM must verify if the education meets their standards to sit for the exam. In addition to passing the NCCAOM exam, the applicant needs to meet Hawaii education and training requirements for a license.

The Board realized that the current application does not include requiring the Biomedicine module and inquired why it was not listed. Dr. Wai Low stated that when NCCAOM switched from a written comprehensive exam in 2004, the modules were separated into Foundations of Oriental Medicine and Acupuncture with Point Location, and Biomedicine was later separated into its own module.

The Board members agreed that the exam equivalency requirements on the application should include the following modules that are currently required for the NCCAOM Certification in Acupuncture: Biomedicine, Foundations of Oriental Medicine, and Acupuncture with Point Location.

It was moved by Vice Chair McMenemy, seconded by Dr. Foreman, voted on and unanimously carried to approve the amendment to the application to require the Biomedicine exam module for licensure.

The Board discussed removing outdated and confusing information from the instructions of the acupuncture license application. The EO will work on revising the application for the Board to review at the next meeting.
