	The Chair provided information on internet and phone access for today's virtual meeting and announced that today's meeting was being recorded and that the recording will be posted on the Board's web page.

	In accordance with Act 220, SLH 2021, all Board members attending virtually confirmed that they were alone in their nonpublic location.			
	After taking roll, quorum was established and the meeting was called to order at 9:05 a.m.			
Chair's Report:	Announcements			
	 The Chair recognized three members of the board whose terms expired: Vice Chair Olivia Kim, BSN, BS, RN, LPN, NHA - The Chair expressed her gratitude for the eight years of service each of them have given to the board and keeping the meetings moving with motions and minutes. APRN and representing Kauai County Tammie Napoleon, DNP, APRN, PPCNP – The Chair expressed her gratitude as well to Dr. Napoleon for her invaluable service and insights to nursing education and APRN education and practice; APRN Amy Stone Murai, APRN – The Chair thanked Ms. Stone Murai who served previously and provided historical insight has helped us understand why certain parts of the nursing regulations are what they are. Having background context is very meaningful, in reconsenting the regulations into a modern, where we are. 			
	The Chair presented the outgoing members with Certificates of Appreciation from the Department of Commerce and Consumer Affairs, Professional and Vocational Licensing Division.

Executive Officer's	2023 Legislative Session – Status Report on the following bills:		
<u>Report</u> :			

EO Fukunaga reported on the following bills:

APRN Practice

HB 650, HD2, SD1 Relating to Health

Authorizes advanced practice registered nurses to practice medical-aid-indying. Authorizes licensed advanced practice registered nurses and clinical nurse specialists with psychiatric or mental health training and licensed marriage and family therapists to provide counseling to a qualified patient. Reduces from twenty to five days, the mandatory waiting period between the two oral requests required for a qualified patient to obtain a prescription for medication. Waives the mandatory waiting period for terminally ill qualified patients who are not expected to survive the mandatory waiting period. (SD1)

This bill was transmitted to the Governor's office on April 28, 2023.

SB 599, SD1, HD2, CD1 Relating to Health

Allows certain physician assistants to sign orders for respiratory therapy and plans of care. Expands the class of health care providers under whom respiratory therapists may practice respiratory care to include physician assistants and advanced practice registered nurses. Effective 6/30/3000. (CD1)

This bill was transmitted to the Governor's office on May 3, 2023.

2023 Renewal – Status Report

EO Fukunaga reported that as of May 31, 2023, a total of 19,424 nurses have renewed their licenses.

The Center for Nursing reported that the responses to the survey is going well with about t 1,400 completions ahead of where they were in 2019 and wanted to thank PVL and all the staff for addressing prior issues and making it more successful this renewal period.

The Chair asked if there were any questions or discussion on this agenda item. Seeing none, she announced the next agenda item.

Hawai'i State Center for Nursing – Laura Reichhardt, Executive Director

Ms. Reichhardt reported on the following:

- The improved design of the nursing license renewal platform with the connection to the Hawaii State Center for Nursing, Nursing Workforce supply survey is working wonderfully. She reported that they have received more responses at this point in time than they had in 2019 and that they are having the best year in history and wanted to thank the board, PVL staff, renewal staff at the DCCA for all of your support;
- Their team is working on several events coming up, a simulation conference in October and an evidence-based conference in November and that they are very happy to be able to be putting on these meaningful events for our local nurses;
- That they have received and partnered with several grants for the nurse residency program and are expecting to have large increases in nurse residency program enrollment for Hawaii. She also stated that they will be venturing into two new initiatives, one is "special transitioning into practice" to help local nurses

Reports:

to get specialty training into those roles that nurses would have to go to the mainland to get that experience or local employers have to recruit from the mainland. The other initiative is supporting and bringing residency programs into the long-term care setting which is greatly needed and they hope will have a huge improvement in the recruitment and retention space for long term care facilities. They are hoping that this residency program model will allow employers to offer new graduate hiring; and

• Hiring for two positions with a third opening soon. One is a Graduate position, for someone to address retention and recruitment issues around temporary licensing since SB63 did not pass. She is working on the job description.

Hawai'i Association of Professional Nurses – Bradley Kuo, Legislative Coordinator

Mr. Kuo reported on the following:

- He recognized Dr. Joseph Giovannoni for his instrumental part in assisting with the Italy conference, "United in Human Caring".
 - Conference will take place June 22 23 in Florence, Italy.
 - Several APRNs from Hawaii will be presenting and attending and also others from around the world.
 - Provide 8.75 credits CEU's for conference supported by HAPN.
- They continue to plan HAPN's fall conference to include both APRNs and PAs.
 - One day conference.
 - November 2023 (date TBD).
- They are still awaiting approval by the Governor on several APRN bills
 - Pick up from where we left off in January continuing to lobby legislature's core(four) bills that should have but did not pass last term.

Hawai'i American Nurses Association - Marion Poirier, Secretary

Ms. Poirier reported on the following:

- Nancy (President), Katie (former President), Linda are going to Washington, DC to ANA membership Assembly, June 14 16.
 - Includes a Hill Day to visit all 4 concretional offices.
 - Brian Fykes, general member, will also be attending.
 - Report about Hill Day will be published in newsletter "The Hawaii Nurse" is issued to over 7,000 Hawaii nurses and healthcare stakeholders;
- Advocacy committee between legislative sessions are developing advocacy institute to educate nurses further about participation and policy making process;
- ANA trying to make a big push to make their goal of 500 members by end of the year. Currently we have 414 members.
- Planning Lobbying Day for September 2023 sponsored by ANA.
