Agenda: The agenda for this meeting was posted to the State electronic calendar as required by Hawaii Revised Statutes (“HRS”) section 92-7(b).

A short video was played to explain the meeting procedures and how members of the public could participate in the virtual meeting.

Call to Order: The meeting was called to order at 1:08 p.m., at which time quorum was established.

Chair Takanishi welcomed everyone to the meeting and proceeded with a

roll call of the Board members. All Board members confirmed that they were present and alone except for Dr. Ronald Fujimoto who joined the meeting at 1:47 p.m.

Approval of the
April 13, 2023
Minutes:

It was moved by Dr. Young, seconded by Dr. Sawai, and carried by a majority, with the exception of Dr. Dao who abstained himself from discussion and vote on this matter, to approve the meeting minutes of the open session and executive session of the April 13, 2023, meeting as circulated.

Chair Takanishi asked if anyone from the public would like to provide oral testimony on this agenda item. There was none.

Ch. 91, HRS,
Adjudicatory Matters:

Chair Takanishi called for a recess from the meeting at 1:09 p.m., to discuss and deliberate on the following adjudicatory matters pursuant to Chapter 91, HRS (Note: Board members and staff entered the Microsoft Teams meeting).

Chair Takanishi proceeded with a roll call of the Board members in Microsoft Teams. All Board members confirmed that they were present and alone.

A. In the Matter of the Physician's License to of Diana Gliga, M.D.; MED 2022-274-L; Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order; Exhibit 1.

After due consideration of the information received, it was moved by Chair Takanishi, seconded by Dr. Young, and unanimously carried, to approve the aforementioned Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

The Board noted that, pursuant to paragraph C.3., Dr. Gliga is required to:

Enroll in and successfully complete continuing medical education ("CME") courses, at Respondent's own expense, to be determined by the Board. The Board shall notify Respondent of which courses are to be completed, how they are to be completed, and when they are to be completed by.

The Board determined that Dr. Gliga shall enroll in and successfully complete the PBI Education Professional Boundaries (PB-24) Extended Course, in joint providership with the University of California, Irvine School of Medicine. This course is to be completed no later than the end of the suspension period.

B. In the Matter of the Physician's License of Reza Khodaverdian, M.D.; MED 2022-243-L; Settlement Agreement Prior to Filing of

Petition for Disciplinary Action and Board's Final Order; Exhibit "1".

After due consideration of the information received, it was moved by Dr. Jaffe, seconded by Dr. Dao, and unanimously carried, to approve the aforementioned Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

Following the Board's review, deliberation, and decision on these matters pursuant to Chapter 91, HRS, Chair Takanishi announced that the Board reconvenes to its Chapter 92, HRS, meeting at 1:40 p.m. Board members and staff returned to the Zoom meeting. All Board members confirmed that they were present and alone.

B. Request to Remove Conditions from Conditional License

It was moved by Dr. Sawai, seconded by Dr. Jaffe, and unanimously carried to return to the open session meeting at 3:00 p.m. Board members and staff returned to the Zoom meeting. All Board members confirmed that they were present and alone.

(i) Physician (Permanent/Endorsement):

- a. Katrina Nesta Glazebrook, M.D.

After due consideration of the information received, it was moved by Dr. Sawai, seconded by Mr. Belcher, and unanimously carried to defer the application and delegate the Executive Officer to inform the applicant that the application does not currently meet the statutory requirements for licensure in Hawaii.

- b. David Maitland Hough, M.D.

After due consideration of the information received, it was moved by Dr. Young, seconded by Dr. Jaffe, and unanimously carried to defer the application and delegate the Executive Officer to inform the applicant that the application does not currently meet the statutory requirements for licensure in Hawaii.

- c. Andrew Gabriel Turner, M.D.

After due consideration of the information received, it was moved by Dr. Fujimoto seconded by Dr. Dao and unanimously carried to approve Dr. Turner's application and issue a non-disciplinary letter of education.

(ii) Physician (Permanent/Non-Endorsement):

- a. Eleanor Marie Kelly, M.D.

Chair Takanishi informed the Board members that the application was not considered for licensure as it was withdrawn by the applicant prior to the Board's review.

- b. Igor Mitreski, M.D.

After due consideration of the information received, it was moved by Dr. Jaffe, seconded by Dr. Dao, and unanimously carried to inform Dr. Mitreski that the Board determined that he must repay the remaining balance (\$4,500.00) of his fine, in full. The Board also determined that it does not have the authority or the expertise to determine what examination Dr. Mitreski should take or when the appropriate time the examination should be taken. As decided in the past, the Board determined that he participate in a post-licensure assessment program. Drexel University College of Medicine's Program was chosen by the applicant.

c. Tonguc Pinar, M.D.

After due consideration of the information received, it was moved by Chair Takanishi, seconded by Mr. Belcher, and unanimously carried to defer Dr. Pinar's application.

After due consideration of the information received, it was moved by Mr. Belcher, seconded by Dr. Jaffe, and unanimously carried to approve Mr. Lawlor's application and include a Letter of Education informing him of his obligation to report to the Board of any disciplinary sanctions within thirty days.

B. Request to Remove Conditions from Conditional License:

(i) Samuel E. Fuller, M.D.

After due consideration of the information received, it was moved by Dr. Elizabeth Ann Ignacio, seconded by Dr. Dao, and unanimously carried to approve Dr. Fuller's request to have the conditions removed from his conditional license.

2023
Legislation:

Mr. Belcher expressed his appreciation, on behalf of the Hawaii Medical Board, of Ms. Quiogue's hard work during the legislative session as the Executive Officer of the Hawaii Medical Board, and as Licensing Administrator.

Dr. Jaffe concurred with Mr. Belcher in offering his appreciation.

Chair Takanishi concurred with Mr. Belcher, and added that Ms. Quiogue provided well written testimonies to the legislation on behalf of the Board. He went on to say that he was happy that

Hawaii became the 40th State to join the Interstate Medical Licensure Compact.

It was moved Dr. Young, seconded by Mr. Mun, and unanimously carried to ratify the attached list of individuals for licensure or certification from April 13, 2023.

Chair Takanishi asked if anyone from the public would like to provide oral testimony on these agenda items. There was none.

2023
Legislation:

A. H.R. 107, H.D. 2 REQUESTING THE AUDITOR TO CONDUCT AN ANALYSIS REGARDING THE SCOPE OF PRACTICE FOR ADVANCED PRACTICE REGISTERED NURSES AND PHYSICIAN ASSISTANTS

B. H.B. 884, H.D. 1, S.D. 2, C.D. 1, RELATING TO TRAVELING TEAM PHYSICIANS

The purpose of this bill is to exempt from state licensure requirements out-of-state traveling team physicians who accompany a sports team to Hawai'i, under certain conditions.

C. S.B. 390, S.D. 1, H.D. 2, C.D. 1, RELATING TO EMERGENCY MEDICAL SERVICES

The purpose of this measure is to repeals the sunset date of section 2 of Act 119, Session Laws of Hawai'i 2021, making permanent the requirement that the Hawai'i Medical Board issue licenses in four levels of emergency response practice in counties with a population of five hundred thousand or greater and the creation of an additional licensure category for emergency medical technicians 1 who are certified at a higher practice level than emergency medical technicians but do not provide ambulance services.

D. ACT 02 (GOV. MSG. NO. 1121): S.B. 438, RELATING TO PROFESSIONAL AND VOCATIONAL LICENSING

The purposes of this measure are to: reduce the period for which an application shall be considered abandoned from two years to one year; specify the conditions under which applications for licenses and examinations will be deemed abandoned; provide that the one-year period after which an application is considered abandoned cannot be extended; provide that a licensing authority shall not be required to act on any abandoned application and that the licensing authority may destroy abandoned applications; and

clarify that an application submitted after an abandoned application shall be treated as a new application and that the applicant shall comply with any new licensing requirements in effect at the time of the new application.

E. S.B. 599, S.D. 1, H.D. 2, C.D. 1, RELATING TO HEALTH

The purposes of this bill are to: allow certain physician assistants to sign orders for respiratory therapy and plans of care; and expand the class of health care providers under whom respiratory therapists may practice respiratory care to include physician assistants and advanced practice registered nurses.

F. S.B. 674, S.D. 1, H.D. 2, C.D.1, RELATING TO THE INTERSTATE MEDICAL LICENSURE COMPACT

The purposes of this bill are to: adopt the Interstate Medical Licensure Compact to create a comprehensive process that complements the existing licensing and regulatory authority of state medical boards and provides a streamlined process that allows physicians to become licensed in multiple states; require the Department of Commerce and Consumer Affairs to adopt rules to implement and administer the Compact.

Correspondence:

A. Email inquiry from Rami Abu Sbeit, M.D. dated May 16, 2023, regarding whether the Board will accept ACGME-International Training.

Chair Takanishi relayed to the Board members that, by email dated May 16, 2023, Dr. Sbeit requested that the Board determine whether it would accept ACGME-International training.

Chair Takanishi explained that ACGME-International training programs have its own accreditation system, its own board and had created its own accreditation system, separate from the ACGME to ensure some form of standards. An ACGME-International program is not recognized as being equivalent to an ACGME accredited training program and, thus, the Board cannot accept an ACGME-International program in lieu of or to substitute the license requirements set forth in the Hawaii Revised Statutes sections 453-4 or 453-4.6.

Chair Takanishi asked if there were any questions or comments. There being none, the Board moved on to the next order of business.

A. Ethics Training:

Ms. Quiogue reminded members that beginning January 1, 2023, all state legislators, state employees, and members of state boards and commissions are required to take ethics training on a periodic basis.

B. Financial Disclosures

Ms. Quiogue reminded the Board members that Financial Disclosure Statements for State Officials should have been filed no later than May 31, 2023.

Chair Takanishi asked that the next meeting agenda include a report from the Chairperson and Vice-Chairperson who attended the if some time could be spared during the next Board meeting to provide updates on the recent Federation of State Medical Board meeting.
