Agenda: The agenda for this meeting was posted to the State electronic calendar as required by Hawaii Revised Statutes (“HRS”) section 92-7(b).

A short video was played to explain the meeting procedures and how members of the public could participate in the virtual meeting.

Call to Order: The meeting was called to order at 11:38 a.m., at which time quorum was established.

Chair Takanishi welcomed everyone to the meeting and proceeded with a roll call of the Board members. All Board members confirmed that they were present and alone except for Dr. Michael Jaffe who joined the meeting at 11:50 a.m.

Ch. 91, HRS, Adjudicatory Matters: Chair Takanishi called for a recess from the meeting at 11:48 a.m., to discuss and deliberate on the following adjudicatory matters pursuant to Chapter 91, HRS (Note: Board members and staff entered the Microsoft Teams meeting).

Chair Takanishi proceeded with a roll call of the Board members in Microsoft Teams. All Board members confirmed that they were present and alone.

A. In the Matter of the License to Practice Medicine of Diana A. Gliga, M.D.; MED 2022-274-L; Settlement Agreement After December 20, 2022 Notice Prohibiting Practice in Hawai'i Pending Entry of a Final Order, Intent to Enter a Final Order Imposing Disciplinary Action, and Respondent's Right to Request a Hearing, and Board's Final Order; Exhibit 1.

After due consideration of the information received, it was moved by Dr. Sawai, seconded by Dr. Dr. Dao, and unanimously carried, to approve the aforementioned Agreement After December 20, 2022 Notice Prohibiting Practice in Hawai'i Pending Entry of a Final Order, Intent to Enter a Final Order Imposing Disciplinary Action, and Respondent's Right to Request a Hearing, and Board's Final Order.

Pursuant to paragraph C.3. of the Settlement Agreement, Dr. Gliga agreed to, among other things, enroll in and successfully complete continuing medical education (“CME”) courses, at her own expense, which is to be determined by the Board.

The Board determined that Dr. Gliga shall enroll in and successfully complete the PBI Professional Boundaries (PB-24) Extended Course, in joint providership with the University of California, Irvine School of Medicine. This course shall be completed no later than the end of the suspension period and prior to her application for reinstatement pursuant and subject to

the requirements and conditions set forth in Hawaii Revised Statutes §§ 92-17 and 436B-20.

B. Request to Remove Conditions from Conditional License

(i) Mark Allen Pithan, M.D.

It was moved by Dr. Dao, seconded by Dr. Jaffe, and unanimously carried to return to the open session meeting at 3:30 p.m. Board members and staff returned to the Zoom meeting. All Board members confirmed that they were present and alone.

(i) Physician (Permanent/Endorsement):

a. Andrew Gabriel Turner, M.D.

It was moved by Mr. Belcher, seconded by Dr. Dao, and carried by a majority, with the exception of Dr. Fong who abstained from the vote, to approve Dr. Turner's application and issue a non-disciplinary letter of education. The vote to approve this application with a non-disciplinary letter of education are:

(ii) Physician (Permanent/Non-Endorsement):

a. Igor Mitreski, M.D.

After due consideration of the information received, it was moved by Dr. Jaffe, seconded by Mr. Belcher, and unanimously carried to deny Dr. Mitreski's application.

The Board based its decision on the following citations of the HRS and Hawaii Administrative Rules ("HAR"), which find factual support in the records and files of Dr. Mitreski's application.

HRS §436B-19 provides that:

In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore, or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

* * *

- (7) Professional misconduct, incompetence, gross negligence, or manifest incapacity in the practice of the licensed profession or vocation;

- (8) Failure to maintain a record or history of competency, trustworthiness, fair dealing, and financial integrity;
- (9) Conduct or practice contrary to recognized standards of ethics for the licensed profession or vocation;
- (12) Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license;
- (13) Revocation, suspension, or other disciplinary action by another state or federal agency against a licensee or applicant for any reason provided by the licensing laws or this section;
- (14) Criminal conviction, whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions, or duties of the licensed profession or vocation; and
- (17) Violating this chapter, the applicable licensing laws, or any rule or order of the licensing authority.

Hawaii Revised Statute §453-4 provides that:

- (b) Before any applicant shall be eligible for licensure, the applicant shall furnish proof satisfactory to the board that:

* * *

- (1) The applicant is of demonstrated competence and professional knowledge.

HRS §453-8 provides that:

- (a) In addition to any other actions authorized by law, any license to practice medicine and surgery may be revoked, limited, or suspended by the board at any time in a proceeding before the board, or may be denied, for any cause authorized by law, including but not limited to the following:

* * *

- (7) Professional misconduct, hazardous negligence causing bodily injury to another, or manifest incapacity in the practice of medicine or surgery;
- (8) Incompetence or multiple instances of negligence, including but not limited to the consistent use of medical service, which is inappropriate or unnecessary;
- (9) Conduct or practice contrary to recognized standards of ethics of the medical profession as adopted by the Hawaii Medical Association, the American Medical Association, the Hawaii Association of Osteopathic Physicians and Surgeons, or the American Osteopathic Association;
- (11) Revocation, suspension, or other disciplinary action by another state or federal agency of a license, certificate, or medical privilege; and
- (12) Conviction, whether by nolo contendere or otherwise, of a penal offense substantially related to the qualifications, functions, or duties of a physician or osteopathic physician, notwithstanding any statutory provision to the contrary.

HAR §16-85-107 provides that:

- (a) An application for issuance of a license or certificate shall be denied when an application is insufficient or incomplete or when an applicant has failed to provide satisfactory proof that the applicant meets the requirements under chapters 453 or 463E, HRS, or this chapter. In addition, the board may deny issuance of a license or certificate:

* * *

- (1) When the applicant has committed any of the acts for which a license or certificate may be suspended or revoked under sections 453-8 or 463E-6, HRS, or section 16-85-112;
- (2) If the applicant fails to demonstrate that the applicant possesses a good reputation for honesty, truthfulness, fairness, and financial integrity; or

- (3) If the applicant has had disciplinary action taken by any jurisdiction, including any federal or state regulatory body.

HAR §16-85-112 provides that:

In addition to any other acts or conditions provided in sections 436B-19 and 453-8, HRS, the board may refuse to renew, reinstate, or restore, or may deny, revoke, suspend, or condition in any manner, any license or certificate for any one or more of the following acts or conditions:

* * *

- (1) Failure to comply with, observe, or adhere to any law in a manner such that the board deems the licensee or certificate holder to be an unfit or improper person to hold a license or certificate; and
- (3) Violating this chapter, the applicable licensing laws, or any rule or order of the board.

The Board considers Dr. Mitreski's conduct concerning and contrary to the recognized standards of ethics as adopted by the American Medical Association ("AMA"). Specifically, the Board believes that Dr. Mitreski failed to uphold the following AMA Principles of Medical Ethics:

- II. **A physician shall uphold the standards of professionalism**, be honest in all professional interactions, and strive to report physicians deficient in character or competence, or engaging in fraud or deception, to appropriate entities.
- III. **A physician shall respect the law** and also recognize a responsibility to seek changes in those requirements which are contrary to the best interests of the patient.

Emphases added.

- b. Tonguc Pinar, M.D.

After due consideration of the information received, it was moved by Chair Takanishi, seconded by Dr. Jaffe, and unanimously carried to approve Dr. Pinar's application for a license subject to certain conditions.

The Board based its decision on the following citations of the HRS, which find factual support in the records and files of Dr. Pinar's application:

HRS §436B-19 provides that:

In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore, or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

* * *

- (3) Being addicted to, dependent on, or a habitual user of a narcotic, barbiturate, amphetamine, hallucinogen, opium, or cocaine, or other drugs or derivatives of a similar nature;
- (4) Practicing the licensed profession or vocation while impaired by alcohol, drugs, physical disability, or mental instability;
- (13) Revocation, suspension, or other disciplinary action by another state or federal agency against a licensee or applicant for any reason provided by the licensing laws or this section; and
- (14) Criminal conviction, whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions, or duties of the licensed profession or vocation.

The Board hereby imposes the following conditions on Dr. Pinar's conditional license:

1. Dr. Pinar's license is conditioned.
2. Dr. Pinar shall remain compliant with the Massachusetts Physician Health Services, Inc ("PHS") Substance Use/Behavioral Health Monitoring Contract effective October 21, 2022
3. Dr. Pinar shall ensure that the PHS submits quarterly compliance letters to the Hawaii Medical Board on the fifth (5th) of every third (3rd) month. These compliance

letters shall include, but not be limited to, assessments regarding: (1) his compliance with the monitoring contract; and (2) his ability to safely practice as a physician. The first report shall be due to the Hawaii Medical Board no later than November 5, 2023.

4. If, at any time, the PHS determines that Dr. Pinar is not in compliance with the monitoring contract, he shall immediately notify the Hawaii Medical Board and immediately cease practicing medicine until the PHS specifies to the Hawaii Medical Board what conditions, if any, it recommends for him to safely resume the practice of medicine. Depending upon the PHS' written report and recommendations, the Hawaii Medical Board may evaluate what, if any, further conditions and/or limitations are warranted for Dr. Pinar to practice medicine and impose such conditions and/or limitations on your license. If he fails to refrain from using drugs or alcohol and inappropriate behavior, the Hawaii Medical Board also will consider whether to suspend, revoke, or otherwise discipline his license.
5. Dr. Pinar may only begin to practice medicine in the State of Hawaii after being evaluated by Pu`ulu Lapa`au, The Hawaii Program for Healthcare Professionals ("Pu`ulu Lapa`au") or a licensed-professional, organization, or agency of their choosing. Pu`ulu Lapa`au shall determine whether monitoring is required and the length of monitoring.
6. Should Pu`ulu Lapa`au determine that Dr. Pinar enter into a monitoring contract with them, Pu`ulu Lapa`au shall determine the length of said contract. However, said monitoring contract may be extended by the Hawaii Medical Board if the Hawaii Medical Board believes that reasonable grounds exist.
7. Similar to condition number 4, if Pu`ulu Lapa`au determines that Dr. Pinar is not in compliance with the monitoring contract, he shall immediately notify the Hawaii Medical Board and immediately cease practicing medicine until Pu`ulu Lapa`au specifies to the Hawaii Medical Board what conditions, if any, it recommends for him to safely resume the practice of medicine. Depending upon Pu`ulu Lapa`au's written report and recommendations, the Hawaii Medical Board may evaluate what, if any, further conditions and/or limitations are warranted for him to practice medicine and impose such conditions and/or limitations on his license. If Dr. Pinar fails to refrain from using

drugs or alcohol and inappropriate behavior, the Hawaii Medical Board also will consider whether to suspend, revoke, or otherwise discipline his license.

8. Similar to condition number 3, if it is determined that Dr. Pinar enter into a monitoring contract with Pu`ulu Lapa`au, Pu`ulu Lapa`au shall submit quarterly compliance letters to the Hawaii Medical Board on the fifth (5th) of every third (3rd) month. These compliance letters shall include, but not be limited to, assessments regarding: (1) his compliance with the monitoring contract; and (2) his ability to safely practice as a physician.
9. The Hawaii Medical Board, at its discretion, may pursue additional disciplinary action as provided by law to include further fines and other sanctions as the Hawaii Medical Board may deem appropriate if Dr. Pinar violates any further provision of the statutes or rules governing the conduct of physicians in the State of Hawaii, or if he fails to abide by the terms of his conditional license.
10. The Hawaii Medical Board, at its discretion, may pursue additional disciplinary action as provided by law to include further fines and other sanctions as the Hawaii Medical Board may deem appropriate if Dr. Pinar violates any further provision of the statutes or rules governing the conduct of physicians in the State of Hawaii, or if he fails to abide by the terms of his conditional license.
11. Should Dr. Pinar wish to have any condition removed from his license, he shall make a request in writing to the Board, at which time the Board would consider his request. When doing so, Dr. Pinar shall provide evidence of full compliance with his monitoring contract with PHS and/or Pu`ulu Lapa`au, The Hawaii Program for Healthcare Professionals and all other conditions placed on his conditional license.

c. Suhaila Mahjabeen Arif, M.D.

After due consideration of the information received, it was moved by Mr. Belcher, seconded by Mr. Mun, and unanimously carried to sponsor Dr. Arif to retake USMLE Step 3.

d. Alexander Dong Lee, M.D.

After due consideration of the information received, it was moved by Dr. Fong seconded by Dr. Dao, and unanimously carried to approve Dr. Lee's application and issue a non-disciplinary letter of education reminding Dr. Lee to familiarize himself with the controlled substance and prescribing laws and rules of this State.

The Board recommends reviewing Hawaii Revised Statutes Chapter 328, Food, and Cosmetics, and Hawaii Revised Statutes Chapter 329, Uniform Controlled Substances Act, both of which may be obtained online at: <https://www.capitol.hawaii.gov/hrsall/ChaptersByVolume.aspx?id=6>.

e. Robert Hugh Lemon, M.D.

After due consideration of the information received, it was moved by Dr. Dao, seconded by Dr. Sawai, and unanimously carried to approve Dr. Lemon's application.

f. Curt Eliot Liebman, M.D.

After due consideration of the information received, it was moved by Dr. Ignacio, seconded by Dr. Sawai, and unanimously carried to approve Dr. Liebman's application pending the receipt of a letter from the Agency for Health Care Administration of Florida and the resolution of the 2017 civil action.

g. Caridad Padron, M.D.

After due consideration of the information received, it was moved by Dr. Sawai, seconded by Dr. Jaffe, and unanimously carried to approve Dr. Padron's application.

h. Timothy Bush Reed, M.D.

After due consideration of the information received, it was moved by Dr. Dao, seconded by Mr. Mun, and unanimously carried to approve Dr. Pinar's application for a license subject to certain conditions.

The Board based its decision on the following citations of the HRS, which find factual support in the records and files of Dr. Reed's application:

HRS §436B-19 provides that:

In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore, or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

* * *

- (4) Practicing the licensed profession or vocation while impaired by alcohol, drugs, physical disability, or mental instability;
- (7) Professional misconduct, incompetence, gross negligence, or manifest incapacity in the practice of the licensed profession or vocation; and
- (14) Criminal conviction, whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions, or duties of the licensed profession or vocation.

The Board hereby imposes the following conditions on Dr. Reed's conditional license:

1. Dr. Reed's license is conditioned.
2. Dr. Reed shall enter into a monitoring contract with Pu`ulu Lapa`au, The Hawai`i Program for Healthcare Professionals ("Pu`ulu Lapa`au") within sixty (30) days of the Board's letter advising him of the conditional license. The length of the contact shall be determined by Pu`ulu Lapa`au. However, said monitoring contract may be extended by the Board if the Board believes that reasonable grounds exist.
3. Dr. Reed shall provide a copy of his fully executed contract with Pu`ulu Lapa`au to the Board within forty-five (45) days of the date of this letter.
4. Dr. Reed may only begin to practice medicine in the State of Hawaii after he receives written confirmation from the Board that he has secured proper monitoring in the State of Hawaii with Pu`ulu Lapa`au and is issued a medical license number by the Board.

5. If, at any time, Pu`ulu Lapa`au, determines that Dr. Reed is not in compliance with the monitoring contract, he shall immediately notify the Board and immediately cease practicing medicine until Pu`ulu Lapa`au specifies to the Board what conditions, if any, it recommends for him to safely resume the practice of medicine. Depending upon Pu`ulu Lapa`au, written report and recommendations, the Board may evaluate what, if any, further conditions and/or limitations are warranted for him to practice medicine and impose such conditions and/or limitations on your license. If he fails to refrain from using drugs or alcohol, the Board also will consider whether to suspend, revoke, or otherwise discipline his license.
6. During the period of his conditional license, Dr. Reed shall ensure that Pu`ulu Lapa`au, submits quarterly written reports to the Board on the fifth (5th) of every third (3rd) month. These written reports shall include, but not be limited to, assessments regarding: (1) his compliance with the monitoring contract; and (2) his ability to safely practice as a physician. The first quarterly report is due on the 5th of the following month of the issuance of his conditional medical license number.
7. The Board, at its discretion, may pursue additional disciplinary action as provided by law to include further fines and other sanctions as the Board may deem appropriate if Dr. Reed violates any further provision of the statutes or rules governing the conduct of physicians in the State of Hawaii, or if he fails to abide by the terms of his conditional license.
8. Should Dr. Reed wish to have any condition removed from his license, he shall make a request in writing to the Board, at which time the Board would consider his request. When doing so, Dr. Reed shall provide evidence of full compliance with his monitoring contract with Pu`ulu Lapa`au and all other conditions placed on his conditional license.

After due consideration of the information received, it was moved by Chair Takanishi, seconded by Mr. Mun, and unanimously carried to approve Dr. Pithan's request to have the conditions removed from his conditional license.

Chair Takanishi stated that he will provide a report of the meeting at its next scheduled meeting on October 12, 2023, at which time they will provide a summary of their attendance at the FSMB's 2023 Annual Meeting, *Building on Essential*, held in Minneapolis, Minnesota.

Election of

Vice-Chairperson:

Chair Takanishi asked the Board members for nominations of the Chairperson and Vice-Chairperson positions.

Dr. Jaffe nominated Mr. Belcher for the position of Vice-Chair. It was moved by Dr. Jaffe, seconded by Dr. Dao, and unanimously carried to elect Mr. Belcher as Vice-Chairperson.

Dr. Dao nominated Dr. Takanishi for the position of Chairperson. It was moved by Dr. Dao, seconded by Mr. Mun, and unanimously carried to elect Dr. Takanishi as Chairperson.

Interstate Medical
Licensure Compact
Commission (IMLCC):

A. Appointment of Commissioners

The Board must appoint two voting representatives who will serve as Commissioners on the IMLCC. A Commissioner shall be a(n): allopathic or osteopathic physician appointed to a member board; executive director, executive secretary, or similar executive of a member board; or a member of the public appointed to a member board.

Chair Takanishi shared that the members of the FSMB were happy that Hawaii is the 37th state to join the IMLCC. He went on to say that two representatives would be appointed to serve as commissioners and asked for nominations.

Dr. Jaffe stated that he was interested in serving as a commissioner. By consensus, Dr. Jaffe would serve as one of Hawaii's voting members on the IMLCC.

Dr. Ignacio asked what the time commitment would be.

Ms. Quiogue stated that the IMLCC meets four times per year. This was confirmed by Chair Takanishi.

Chair Takanishi went on to say that this topic would be placed on the following meeting's agenda.

Correspondence:

A. Inquiry dated July 8, 2023, from Brandon M. Trento, regarding medical licensure inquiry for patient examinations specific to performing medical demonstrations (non-invasive) on patients in the State of Hawaii.

Chair Takanishi referenced Mr. Trento's email, which queries whether there is licensure reciprocity in this State. Specifically, would a physician, who holds a valid license in another jurisdiction, be able to perform a non-invasive procedure on a patient in Hawaii. In this example, the physician would be required to touch said patient for treatment. This physician may likewise have to perform medical demonstrations of such procedure to other PAs (physician assistants). Would the out-of-state physician's valid medical license permit this?

Chair Takanishi stated that in addition to the response Ms. Quiogue provided Mr. Trento on July 8, 2023, any medical demonstrations performed on a patient in this State would require a medical license. Medical demonstrations performed on non-humans (e.g., mannequins) would not require a license.

Mr. Trento also inquired whether a temporary permit would be issued for such medical demonstrations.

Chair Takanishi stated that Hawaii does not offer temporary permits or licenses for this type of practice.

Lastly, in accordance with Hawaii Administrative Rules §16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision, and therefore is not to be viewed as binding upon the Board, Committee, or Department of Commerce and Consumer Affairs.

B. Inquiry from Kenneth Riff, M.D. dated July 31, 2023, regarding physician assistant scope of practice and supervision requirements.

Chair Takanishi relayed that Dr. Riff inquired whether a physician assistant can see a nurse practitioner's patients if the physician assistant is supervised by a physician.

Chair Takanishi stated that yes, the physician assistant may see the nurse practitioner's patient so long as they are supervised by a physician.
