Agenda: The agenda for this meeting was posted to the State electronic calendar as required by Hawaii Revised Statutes (“HRS”) section 92-7(b).

A short video was played to explain the meeting procedures and how members of the public could participate in the virtual meeting.

Call to Order: The meeting was called to order at 1:08 p.m., at which time quorum was established.

Chair Takanishi welcomed everyone to the meeting and proceeded with a roll call of the Board members. All Board members confirmed that they were present and alone.

Approval of the September 14, 2023, Minutes: It was moved by Dr. Jaffe, seconded by Dr. Ignacio, and carried by a majority, with the exception of Dr. Pratt and Dr. Young who abstained from the discussion and vote on this matter, to approve the meeting minutes of the open session of the September 14, 2023, meeting with the following amendment:

The Board based its decision on the following citations of the HRS and Hawaii Administrative Rules (“HAR”), which find factual support in the records and files of Dr. Manzur’s application.

HRS §436B-19 provides that:

In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore, or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

* * *

- (5) Procuring a license through fraud, misrepresentation, or deceit;
- (12) Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license;
- (17) Violating this chapter, the applicable licensing laws, or any rule or order of the licensing authority.

HRS §453-8 provides that:

(a) In addition to any other actions authorized by law, any license to practice medicine and surgery may be revoked, limited, or suspended by the board at any time in a proceeding before the board, or may be denied, for any cause authorized by law, including but not limited to the following:

* * *

- (7) Professional misconduct, hazardous negligence causing bodily injury to another, or manifest incapacity in the practice of medicine or surgery;
- (9) Conduct or practice contrary to recognized standards of ethics of the medical profession as adopted by the Hawaii Medical Association, the

American Medical Association, the Hawaii Association of Osteopathic Physicians and Surgeons, or the American Osteopathic Association;

- (11) Revocation, suspension, or other disciplinary action by another state or federal agency of a license, certificate, or medical privilege; and
- (12) Conviction, whether by nolo contendere or otherwise, of a penal offense substantially related to the qualifications, functions, or duties of a physician or osteopathic physician, notwithstanding any statutory provision to the contrary.
- (15) Submitting to or filing with the board any notice, statement, or other document required under this chapter, which is false or untrue or contains any material misstatement or omission of fact.

(c) Notwithstanding any other law to the contrary, the board may deny a license to any applicant who has been disciplined by another state or federal agency. Any final order of discipline taken pursuant to this subsection shall be a matter of public record.

HAR §16-85-107 provides that:

(a) An application for issuance of a license or certificate shall be denied when an application is insufficient or incomplete or when an applicant has failed to provide satisfactory proof that the applicant meets the requirements under chapters 453 or 463E, HRS, or this chapter. In addition, the board may deny issuance of a license or certificate:

* * *

- (1) When the applicant has committed any of the acts for which a license or certificate may be suspended or revoked under sections 453-8 or 463E-6, HRS, or section 16-85-112;
- (3) If the applicant has had disciplinary action taken by any jurisdiction, including any federal or state regulatory body.

The Board considers Dr. Manzur's conduct concerning and contrary to the recognized standards of ethics as adopted by the American Medical Association ("AMA").

Specifically, the Board believes that Dr. Manzur failed to uphold the following AMA Principles of Medical Ethics:

- II. **A physician shall uphold the standards of professionalism**, be honest in all professional interactions, and strive to report physicians deficient in character or competence, or engaging in fraud or deception, to appropriate entities.
- III. **A physician shall respect the law** and also recognize a responsibility to seek changes in those requirements which are contrary to the best interests of the patient. Emphases added.

c. Dion Carlo DePaolis, M.D.

After due consideration of the information received, it was moved by Dr. Ignacio, seconded by Mr. Belcher, and unanimously carried to approve Dr. DePaolis' application and issue a non-disciplinary letter of education.

i. Sujan Thyagaraj, M.D. aka Sujan T. Raj, M.D.

The Board based its decision on the following citations of the HRS and Hawaii Administrative Rules ("HAR"), which find factual support in the records and files of Dr. Thyagaraj's application.

HRS §436B-19 provides that:

In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore, or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

* * *

- (7) Professional misconduct, incompetence, gross negligence, or manifest incapacity in the practice of the licensed profession or vocation;
- (9) Conduct or practice contrary to recognized standards of ethics of the medical profession as adopted by the Hawaii Medical Association, the American Medical Association, the Hawaii

Association of Osteopathic Physicians and Surgeons, or the American Osteopathic Association;

- (12) Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license;
- (13) Revocation, suspension, or other disciplinary action by another state or federal agency against a licensee or applicant for any reason provided by the licensing laws or this section;

HRS §453-8 provides that:

(a) In addition to any other actions authorized by law, any license to practice medicine and surgery may be revoked, limited, or suspended by the board at any time in a proceeding before the board, or may be denied, for any cause authorized by law, including but not limited to the following:

* * *

- (7) Professional misconduct, hazardous negligence causing bodily injury to another, or manifest incapacity in the practice of medicine or surgery;
- (9) Conduct or practice contrary to recognized standards of ethics of the medical profession as adopted by the Hawaii Medical Association, the American Medical Association, the Hawaii Association of Osteopathic Physicians and Surgeons, or the American Osteopathic Association;
- (11) Revocation, suspension, or other disciplinary action by another state or federal agency of a license, certificate, or medical privilege; and

(c) Notwithstanding any other law to the contrary, the board may deny a license to any applicant who has been disciplined by another state or federal agency. Any final order of discipline taken pursuant to this subsection shall be a matter of public record.

HAR §16-85-107 provides that:

(a) An application for issuance of a license or certificate shall be denied when an application is

insufficient or incomplete or when an applicant has failed to provide satisfactory proof that the applicant meets the requirements under chapters 453 or 463E, HRS, or this chapter. In addition, the board may deny issuance of a license or certificate:

The Board considers Dr. Thyagaraj's conduct concerning and contrary to the recognized standards of ethics as adopted by the American Medical Association ("AMA"). Specifically, the Board believes that Dr. Thyagaraj failed to uphold the following AMA Principles of Medical Ethics:

- I. **A physician shall be dedicated** to providing competent medical care, with compassion and respect for human dignity and rights.
- II. **A physician shall uphold the standards of professionalism**, be honest in all professional interactions, and strive to report physicians deficient in character or competence, or engaging in fraud or deception, to appropriate entities.
- III. **A physician shall respect the law** and also recognize a responsibility to seek changes in those requirements which are contrary to the best interests of the patient.
- IV. **A physician shall respect the rights of patients, colleagues, and other health professionals**, and shall safeguard patient confidences and privacy within the constraints of the law.
- VIII. **A physician shall, while caring for a patient**, regard responsibility to the patient as paramount. Emphases added.

After due consideration of the information received, it was moved by Chair Takanishi, seconded by Dr. Sawai, and unanimously carried to defer the application and delegate the Executive Officer to inform the applicant that he application does not meet the statutory requirements for licensure in Hawaii.

B. Delegation to Executive Officer

It was moved by Mr. Belcher, seconded by Dr. Fong, and carried by a majority, with the exception of Dr. Jaffe who abstained from the discussion and vote on this matter, to delegate the authority to sign Board's Proposed Final Orders to the Executive Officer of the Hawaii Medical Board to expedite the process.

C. 2024 Proposed Legislation: Relating to Healthcare Provider Credentialing

The purpose of this legislative proposal is to authorize credentialing conducted by the Hawaii Health Systems Corporation, health plans accredited by the National Committee on Quality Assurance, and hospitals accredited by the Joint Commission to serve as prima facie credentialing for purposes of health plan network participation. Authorizes a healthcare credentialing clearinghouse pilot program within the Department of Health.

Chair Takanishi stated that the Board will discuss the proposed legislation at a subsequent meeting.

Executive Officer Report:

A. 2024 Board Meeting Schedule

Chair Takanishi reminded the Board members to mark their calendars with next year's scheduled meetings.

B. Reminder: Ethics Training

Board members are required to complete mandatory ethics training no later than December 31, 2023.

Ms. Quiogue stated that a member of the public had raised their hand.

Oren Ganor, M.D. entered the Zoom meeting at 4:28 p.m.

Dr. Ganor introduced himself to the Board members.

Chair Takanishi explained that the meeting was to end at 4:30 p.m. per Sunshine Law and went on to ask DAG Wong if Dr. Ganor could testify.

DAG Wong stated that Dr. Ganor could offer one-way testimony, but there could be no discussion or consideration due to the time limit.

Chair Takanishi explained to Dr. Ganor that he does not meet the statutory requirements for licensure. He went on to explain that the Board had explored all possible pathways of licensure afforded to foreign medical school graduates and, unfortunately, was not able to find a means to qualify him for licensure. He went on to say that he will receive official correspondence from the Board delineating the reason for its deferral.

Dr. Ganor explained was surprised that he did not meet the licensing requirements of Hawaii as he has been practicing

medicine in Massachusetts for eight years and in New Hampshire for two-and-a-half years.

DAG Wong stated that, as this was no longer a one-way testimony, the meeting would have to end. She went on to explain that all states have different laws and rules and Dr. Ganor may have met the requirements for licensure in other States, but not Hawaii's.
