Call to Order: In accordance with Act 220, SLH 2021, all Board members attending virtually

confirmed that they were alone in their nonpublic location. After taking roll, a quorum was established, and Chair Nagashima called the meeting to order at 9:08 a.m.

Meeting:

Chair Nagashima noted that under "Guests", Jeneesa Johnson should be corrected to Jeneesa Jackson. Upon a motion by Chair Nagashima, seconded by Darci Frankel, it was voted on and unanimously carried to approve the open session and executive session minutes of the November 22, 2023, meeting as amended.

Applications:

Chair Nagashima asked if any members from the public would like to provide oral testimony on this agenda item. Jeneesa Jackson and Liqin Yuan were recognized to speak. EO Doi explained that they had the option of discussing each of their applications during executive session instead of the open session. Both applicants opted to speak about their applications during executive session.

Ratification List (see attached list):

Upon a motion by Chair Nagashima, seconded by Ms. Frankel, it was voted on and unanimously carried to approve the attached list of individuals for licensure.

Executive Session:

It was moved by Chair Nagashima, seconded by Ms. Frankel, and unanimously carried to enter executive session at 9:16 a.m., in accordance with HRS §92-5(a)(1), to consider and evaluate personal information relating to individuals applying for professional licenses cited in HRS §26-9 and, pursuant to HRS §92-5(a)(4), to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities and liabilities.

At 10:53 a.m., it was moved by Chair Nagashima, seconded by Ms. Frankel, and unanimously carried to move out of executive session. Sean St. Louis explained that he was unable to login to the Microsoft Teams platform and therefore recused himself from voting.

1) Sara McKibbin

Upon a motion by Chair Nagashima, it was voted on and carried by the majority to approve Sara McKibbin's application to sit for the Hawaii massage exam and to deny the request for an exam waiver. Ms. Frankel recused herself and Mr. St. Louis abstained from voting on this matter.

2) Dustin Meza

Upon a motion by Chair Nagashima, seconded by Ms. Frankel, it was voted on and carried by the majority to approve Dustin Meza's application to sit for the Hawaii massage exam and to deny the request for an exam waiver and CPR waiver. Mr. St. Louis abstained from voting on this matter.

3) Devon Ehrenberg

Upon a motion by Chair Nagashima, seconded by Ms. Frankel, it was voted on and carried by the majority to approve Devon Ehrenberg's application to sit for the Hawaii massage exam, and to defer the request for an exam waiver, pending submission of proof of current licensure in Oregon. Mr. St. Louis abstained from voting on this matter.

4) Shaunna Lee Skidmore

Upon a motion by Chair Nagashima, seconded by Ms. Frankel, it was voted on and carried by the majority to approve Shaunna Lee Skidmore's application to sit for the Hawaii massage exam. Mr. St. Louis abstained from voting on this matter.

5) Jeneesa Jackson

Upon a motion by Chair Nagashima, seconded by Ms. Frankel, it was voted on and carried by the majority to approve Jeneesa Jackson's application to sit for the Hawaii massage exam. Mr. St. Louis abstained.

6) 123 Spa LLC

Upon a motion by Chair Nagashima, seconded by Ms. Frankel, it was voted on and carried by the majority to approve 123 Spa LLC's application. Mr. St. Louis abstained from voting on this matter.

7) Tamara Shumaker

Upon a motion by Chair Nagashima, seconded by Ms. Frankel, it was voted on and carried by the majority to defer Tamara Shumaker's application for licensure, pending documentation of 110 practical training hours. Mr. St. Louis abstained from voting on this matter.

8) Liqin Yuan

Upon a motion by Chair Nagashima, seconded by Ms. Frankel, it was voted on and carried by the majority to deny Liqin Yuan's application to sit for the Hawaii massage exam, pursuant to Hawaii Revised Statutes ("HRS") §§452(a)(1) and 436B-19(5). Mr. St. Louis abstained from voting on this matter.

9) Fire Palace Inc.

Upon a motion by Chair Nagashima, seconded by Ms. Frankel, it was voted on and carried by the majority to approve Fire Palace Inc.'s application. Mr. St. Louis abstained from voting on this matter.

10) Kentaro Ball

Upon a motion by Chair Nagashima, seconded by Ms. Frankel, it was voted on and carried by the majority to deny Kentaro Ball's application to sit for the Hawaii massage exam, pursuant to HRS §§ 452-24(a)(3) and 436B-19(4) and (13). Mr. St. Louis abstained from voting on this matter.

Executive Officer's Report:

a. Update on Hawaii Administrative Rules Title 16 Chapter 84

EO Doi explained that she submitted the draft with the recommended changes from the Legislative Reference Bureau ("LRB") and the Regulated Industries Complaints Office ("RICO") to the Administrative Services Office.

b. Massage therapy examination statistics

EO Doi presented the Board with the massage therapy examination statistics for November 2023 and December 2023.

New Business:

a. Legislative delegation for 2024 session

EO Doi explained that the 2024 legislative session will begin soon and would like the Board to select up to two massage therapists with whom she could consult regarding submitting in case bills relating to massage therapy are scheduled for hearing in between Board meetings. Chair Nagashima and Ms. Frankel offered to assist the EO. Upon a motion by Chair Nagashima, seconded by Ms. Skoog, it was voted on and unanimously carried to allow EO Doi to consult with Chair Nagashima and Ms. Frankel regarding legislative matters.

Mr. Arakaki departed the meeting at 11:13 a.m.

<u>Unfinished</u> <u>Business:</u>

a. Rule Revisions – Title 16, Chapter 84, Hawaii Administrative Rules

Chair Nagashima explained that the Board has been working on rule revisions for years and asked that Board members review the draft and come prepared to discuss at the next Board meeting. Chair Nagashima suggested increasing the required education and training hours from 570 hours to 625 hours. Mr. St. Louis suggested increasing the required education and training hours to 800 hours, noting it would increase professionalism and reduce prostitution. Ms. Frankel noted that increasing the number of hours could make it financially difficult for massage schools to continue. Ms. Skoog noted that increasing the number of required practical hours will not help students pass the anatomy portion of the Hawaii massage exam, which is the section of the exam where most applicants fail. She noted that she would be in favor of increasing the number of required anatomy hours. Chair Nagashima also added that the Board consider language regarding exam misconduct.
