Agenda: The agenda for this meeting was posted to the State electronic calendar as required by Hawaii Revised Statutes (“HRS”) section 92-7(b).

A short video was played to explain the meeting procedures and how members of the public could participate in the virtual meeting.

Call to Order:

The meeting was called to order at 1:14 p.m., at which time quorum was established.

Chair Takanishi welcomed everyone to the meeting and proceeded with a roll call of the Board members. The following were present and confirmed that they were alone:

Chair Takanishi, Vice Chair Belcher, Dr. Fong, Dr. Ignacio, Dr. Dao, Dr. Sawai, Mr. Mun, and Dr. Young.

Drs. Jaffe and Pratt were excused from the meeting.

Election of Officers:

Dr. Sawai nominated Dr. Takanishi to serve as Chairperson of the Board. Dr. Takanishi asked if there were any other nominations for chairperson. There were no further nominations. It was moved by Dr. Sawai, seconded by Dr. Young, and unanimously carried to elect Dr. Takanishi as the Chairperson of the Board.

Federation of State  
Medical Boards  
(FSMB):

A. 2024 FSMB Annual Meeting: *The Science of Sound Decisions*:

Chair Takanishi informed members that he attended the FSMB's Annual Meeting, held in Nashville, Tennessee, between April 18-20, 2024. This was a record setting meeting with 600 attendees.

There were several keynote speakers and a multitude of topics discussed, including: the use of AI in clinical practice; access to evidence-based treatment for opioid disorder; and other topics to better address and guide medical boards in its role.

Dr. Ignacio asked that Chair Takanishi recommend future reading materials for members to better assist them in their role as a member, regulator, and physician.

Chair Takanishi encouraged members to inform its executive officers of any topic they would like added to the agenda for future discussion. For example, the Board considered amending its applications to address addiction and mental health issues, which would optimize patient safety and physician health.

B. Provider Bridge:

Chair Takanishi informed members that Provider Bridge ([ProviderBridge.org](https://www.providerbridge.org)<sup>1</sup>), supports license portability by making it easier to connect volunteer health care professionals with state agencies and health care entities in order to quickly increase access to care for patients in rural and underserved communities.

As members are aware, Hawaii became the 37<sup>th</sup> jurisdiction to join the Interstate Medical Licensure Compact. This program would assist with license portability, too, and will address some of Hawaii's healthcare professional shortages.

Chair Takanishi reminded members that for future board meetings they may request to have specific topics placed on the agenda for discussion, this may include past topics such as amendments to
