Call to Order: There being a quorum present, Chairperson Nishek called the meeting to order at 9:02 a.m.

Chairperson Nishek introduced and welcomed new Board members Alan Shintani and Russell Inouye.

Agenda: The agenda was posted on the State electronic calendar as required by Hawaii Revised Statutes ("HRS") section 92-7(b).

Executive Session: At 9:03 a.m. it was moved by Mr. Polischeck, seconded by Mr. Lau and unanimously carried to enter into executive session pursuant to HRS section 92-5(a)(4) to consult with Christopher Leong, Deputy Attorney General, on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities.

### General Overview of the Board's Duties and Responsibilities

At 9:36 a.m., it was moved by Mr. Lau, seconded by Mr. Torigoe, and unanimously carried to move out of executive session and to reconvene to the Board's regular order of business.

Minutes: It was moved by Mr. Polischeck, seconded by Mr. Suehiro, and unanimously carried to approve the Applications Committee Meeting Minutes of July 1, 2024 and the Board Meeting Minutes of June 21, 2024.

### Committee Reports:

1. Scope of Activity Committee:  
Paul Alejado and John Polischeck, Co-Chairpersons

#### Hawaii Department of Transportation

Requests a determination on whether a C-14 Sign contractor's license is required for the installation and relocation of regulatory and warning road signs. The new and relocated road signs will either be mounted on new traffic signal poles or on their own sign supports (tubular metal posts).

Steven Yoshida, Department of Transportation, stated that this question came up when a bidder on a project did not have a C-14 Sign contractor license. Although the signage is minimal, they would like to know if a C-14 Sign contractor license is required to install traffic signs. Mr. Yoshida stated that the contractor will be installing the sign support poles as well as the traffic signals and poles. Mr. Polischeck stated that a C-13 Electrical contractor is required to install traffic signal poles. Mr. Yoshida stated that the bidder has a C-13 Electrical contractor license.

Recommendation: Based solely on the information and testimony provided, a C-14 Sign contractor license is required to install regulatory and warning road signs and the tubular metal posts that the signs will be mounted on.

It was moved by Mr. Polischek, seconded by Mr. Suehiro, and unanimously carried to approve the above scope recommendation.

Chairperson Nishek called for a recess from the Board's meeting at 9:45 a.m. to discuss and deliberate on the following adjudicatory matter pursuant to HRS chapter 91.

For Declaratory Relief in the form of (1) withdrawal of the Board's letter dated April 5, 2024, and (2) a determination that a C-48 structural steel contractor's license is required for the construction of the Prefab Galvanized Metal Racking System Kit carport, as opposed to the C-13 electrical license for the Kapolei Police Station Installation of Photovoltaic System, City Project No. IX-73-22-0.

Chairperson Nishek informed the Board that Mr. O'Donnell submitted a letter dated July 17, 2024 withdrawing the Hawaii Iron Workers Union Local 625's Petition for Declaratory Relief.

3. Board's Final Order

In the Matter of the Petition for Declaratory Relief of James S. Markiewicz, Trustee and Joanne C. Markiewicz, Trustee;  
CLB-DR-2023-001

It was moved by Mr. Polischek, seconded by Mr. Lau and unanimously carried to amend the Hearings Officer's Recommended Decision and affirm that a C-22 license is required to install Fleetwood Aluminum Sliding Door Series 3050, 3070, and 3200-T and Fleetwood Aluminum Framed Window Series 250-T that require field assembly and glazing.

Following the Board's review, deliberation, and decisions in these matters, pursuant to HRS chapter 91, Chairperson Nishek announced that the Board was reconvening to its open meeting at 9:56 a.m.

After discussion, it was moved by Mr. Higashihara, seconded by Mr. Polischek, and unanimously carried to defer Aina Contractors Inc and Mr. Murdoch's applications for licensure in the "B" General building classification pending the submittal of a revised project list (on the Board's form) verifying forty-eight months of Mr. Murdoch's on-site supervision and direction of his employees constructing buildings from the "ground-up", specifying the work that was performed in-house with his own employees and the work or trades that was subcontracted to other licensed contractors. Contractors Examination Summary

The Contractors Examination Summary for June 2024 was distributed to the Board for their information.

2024 Legislation

Relating to Contractors

- a. H.B. 1633, H.D. 1, S.D. 1, C.D. 1

Repeals the leasing restriction on owner-builders who obtain an owner-builder exemption to act as their own contractor and who build or improve residential or farm buildings or structures on property they own or lease and do not offer the buildings or structures for sale.

Chairperson Nishek informed the Board that this measure was vetoed by Governor Green.

- b. S.B. 371, S.D. 1

Defines "incidental and supplemental work" for purposes of specialty contractors under the contractors law.

Mel Kahele, Iron Workers Stabilization Fund Local 625, stated that they introduced S.B. 371 and asked that “incidental and supplemental” work be reduced to five percent. He asked the Board to reconsider its Board’s Final Order (“BFO”) because he doesn’t think it is fair for their contractors, signatories, and members. Forty-nine percent of a ten-billion-dollar project is five million dollars of work that can be performed as “incidental and supplemental” work. The Board had asked him to provide information to prove that their signatories are being impacted. He stated that their signatories don’t want to get involved because they feel that the general contractors will retaliate against them. Mr. Kahele stated that he does not have any information to provide. He also stated that at the April 2024 meeting, one of the Board members had asked DAG Leong what does the Board need to do to amend its BFO?

DAG Leong requested that Messrs. Hayashi and O’Donnell recuse themselves from this agenda item. Mr. O’Donnell asked why he is being asked to recuse himself when he is a public member on the Board. Executive Officer Ito stated that their employer is the impetus behind this matter and asked whether Mr. Kahele or Gary Kurokawa could speak on this matter. Mr. O’Donnell stated that Mr. Kahele represents the labor management fund and Mr. Kurokawa left to attend a more important meeting.

Mr. Hayashi stated that SB 371 is dead and the Board should not be discussing a dead bill because the Board will not be taking a position on a dead bill. Executive Officer Ito stated that the iron workers requested to have SB 371 on the meeting agenda and even if the bill is dead, their employer is still the impetus behind amending the definition of “incidental and supplemental” work. Executive Officer Ito asked that representatives from their organization present testimony otherwise there is an appearance of a conflict of interest. There does not appear to be a separation of their personal agenda and Board business. DAG Leong agreed that the subject matter is the same even if the bill is dead. Messrs. Hayashi and O’Donnell declined to recuse themselves from this agenda item.

DAG Leong stated that the BFO in the DC 50 case on remand cannot be amended because it is a decision of the Board made pursuant to the Supreme Court's specific instructions remanding the case to the Board solely to reconsider whether the jalousie window work qualified as "incidental and supplemental" in light of the cost and extent of work involved. Further the Supreme Court did not take up the subsequent appeal that was filed after the Board issued its BFO on remand. Thus, the DC 50 case has been adjudicated and is final. Other paths to amend the current BFO are: (1) change the statute through the legislative process; (2) engage in rule making; or (3) adjudicate another petition for declaratory relief, which must be filed based on an actual controversy that is at issue.

Mr. Higashihara asked DAG Leong if his understanding is correct that the circuit court, intermediate court, and the Supreme Court all affirmed the Board's decision. DAG Leong stated yes. Mr. Hayashi stated that the CLB defined what is a majority, not the court. DAG Leong clarified that the Supreme Court remanded the BFO to the Board to define majority, the Board did so, and the Supreme Court ultimately affirmed the BFO issued on remand.

Mr. Polischek stated that the Board's criteria for "incidental and supplemental" work is that the work must be subordinate to, directly related to, and necessary for the completion of the work of greater importance that is within the scope of the primary work the specialty contractor is licensed to perform and represents less than 50% of the project. He stated that the Board looks at all the criteria and looks at the percentage after it considers the other criteria. Anyone using the criteria cannot only pick one criteria, such as the percentage and consider the work to be "incidental and supplemental" work. Mr. O'Donnell stated that subcontractor performing the "incidental and supplemental" work should be required to have the qualifications to perform the "incidental and supplemental" work. He stated that "incidental and supplemental" work is all about forty-nine percent; laborers will be erecting structural steel work. DAG Leong stated that "incidental and supplemental" work must be subordinate to, directly related to,

and necessary for the completion of the work of greater importance that is within the scope of the licensee's license (i.e. the primary work of the specialty contractor is licensed to perform).

Executive Officer Ito asked that Mr. O'Donnell consider all the specialty classifications, not just the specialty classifications related to iron workers. Examples of "incidental and supplemental" work performed by other specialty classifications are electricians that remove trim or molding to fix wiring may need to paint the trim or molding after replacing it; electrical contractors would need to qualify for a painting and decorating license to perform that "incidental and supplemental" work. Another example would be a plumber that needs to remove the drywall to fix the pipes; plumbing contractors would need to qualify for a drywall license to perform the "incidental and supplemental" work of replacing the drywall.

Mr. Lau clarified that "incidental and supplemental" work is only related to the specialty contractor work. Mr. Kahele stated that the current definition is forty-nine percent of the total project. Executive Officer Ito stated that at its April 26, 2024 meeting, the Board agreed to clarify that "incidental and supplemental" work is related to the specialty contractor work. Executive Officer Ito asked at that meeting if the iron workers would be agreeable to leaving in the less than fifty percent with the clarification that "incidental and supplemental" work only pertains to the specialty work and Mr. Kahele responded no.

Mr. Kahele stated that if DAG Leong says that the only way to change the percentage is through legislation, he will do that. Executive Officer Ito stated that that the Board cannot pick a number out of the air that represents "incidental and supplemental" work because that would be arbitrary. The Board needs to get input from all the specialty contractors, not just the iron workers, before making a decision. Mr. Kahele stated that the Board needs to use common sense.

Mr. Polischek stated that the Board uses the “incidental and supplemental” work criteria and only applies the percentage of “incidental and supplemental” work to the specialty work. Mr. Hayashi asked DAG Leong to look at paragraph B on page six of the BFO on Remand. It states, “majority of the project”. Mr. Suehiro stated that there are other criteria to meet before considering the percentage of “incidental and supplemental” work and in practice, the Board considers the percentage of the specialty work, not the project. If someone owns less than a majority of a company, that means they own forty-nine percent or less of the company. If the Board chooses a number without any input, it is making an arbitrary decision. Every job is not identical. Mr. Polischek stated that the contractors are not applying the criteria; they are just using the percentage. Mr. Suehiro suggested removing the percentage.

Mr. Lau asked if there is a specific example of loss due to “incidental and supplemental” work. Mr. Kahele stated that he does not have any examples but they had a problem with someone doing “incidental and supplemental” work and he was going to file a complaint, but Ms. Goto from RICO told him they couldn’t do anything about it.

Mr. Hayashi stated that the contractors that inquire about “incidental and supplemental” work provide the dollar amounts for the project because they want a determination of “incidental and supplemental” work based on less than forty-nine percent of the project. Executive Officer Ito stated that she asks the contractor to provide the dollar amount of the “incidental and supplemental” work and the related specialty work because the Board needs that information when making “incidental and supplemental” work determinations.

Executive Officer Ito stated that she suggested more educational outreach to clarify “incidental and supplemental” work. Currently, the Board sends out information on the Okada Trucking and DC 50 case with every contractor renewal packet and that information is also posted on the Board’s website.

Mr. Polischek stated that the percentage should be lowered because contractors are only using the percentage as the criteria for “incidental and supplemental” work. Executive Officer Ito stated that the Board must consider the specialty contractors whose work is smaller, for example, residential flooring or plumbing work. If the Board chooses a number that is too low, it may affect the smaller specialty contractor’s ability to perform “incidental and supplemental” work. She emphasized the importance of input from the specialty contractors before making a decision on the percentage. Mr. Kahele stated that in the past there was no number. Contractors just used common sense. The iron workers will lose their signatories depending on how “incidental and supplemental” work is interpreted.

Mr. O’Donnell suggested forming a committee to work on “incidental and supplemental” work. Executive Officer Ito stated that the Board may decide to form a committee once they receive input from specialty contractors. Mr. O’Donnell stated that the iron workers stabilization fund is going back to the legislature and report that they cannot get an agreement on a number. Executive Officer Ito stated that the Board has not received any information that they can use as a basis to amend the percentage in the “incidental and supplemental” work criteria. However, the Board has agreed to clarify that “incidental and supplemental” work is related to the specialty contractor work. The Board asked for a suggestion on the path to take. Executive Officer Ito suggested to amend the criteria in the Board’s administrative rules. The Board currently has a draft that it can work on. The Board came to a consensus to amend the criteria for “incidental and supplemental” work through its administrative rules.

Consumer

Education Fund:      Media on Hiring Licensed Contractors

William Nhieu, Communications Officer for the Department of Commerce and Consumer Affairs, provided an update on the public service announcement (“PSA”) on hiring licensed contractors. The Board approved \$50,000.00 for the production of a new PSA on hiring licensed contractors. The request for proposal

went out this week. There was a delay due to an issue regarding the release of the storyboard. The procurement closes on August 7, 2024.

Mr. Nhieu also provided scripts of the radio announcements that are being broadcast in Maui county. The Board approved \$20,000.00 for these radio ads. There is a Maui specific version and a general version. For this flight of ads, there are 60, 30 and 15 second spots which will run over the next 3 months. The next flight will be more enforcement centric and will run for 3 months. Mr. Nhieu also distributed statistics on social media.

Mr. Nhieu proposed a paid-vertorial which is a platform to convey your public service announcement. The cost starts at \$1,000 and can go up to and exceed \$4,000. It creates a segment that is manageable, the station creates a script and produces it. The paid-vertorials usually air in the morning. The cost includes the production for a couple of broadcasts. Depending on the station, we may own the paid-vertorial and it can be used in for future advertisements. Mr. Nhieu will inquire if we will own the paid-vertorial and if we can get a government or non-profit rate. Mr. Nhieu suggested a budget of \$10,000 and the Board needs a spokesperson to do the paid-vertorial. Executive Officer Ito suggested having someone from Maui that the community would recognize to do the paid-vertorial, maybe a past Board member. Mr. Suehiro suggested Shane Victorino.

It was moved by Mr. Lau, seconded by Mr. Polischeck, and unanimously carried to approve a budget of \$10,000 including tax for a paid-vertorial. Mr. Nhieu will provide the Board with proposals from the different television stations.

Mr. Nhieu presented another ad proposal initiative for advertising space at the Kahului airport. The vendor recommends the location at the main escalator exit which has a flow of inter-island travelers. The second location recommended by the vendor is the southwest corner. Another location is the TSA outbound escalator. He provided static and digital option pricing. The Board felt that advertising at the airport would not be targeting the demographic that they are trying to reach.

Mr. Nhieu will provide a summary of the Board's initiatives.
