Call to Order: There being a quorum present, Chairperson Nishek called the meeting to order at 9:06 a.m.

Agenda: The agenda was posted on the State electronic calendar as required by Hawaii Revised Statutes ("HRS") section 92-7(b).

Minutes: It was moved by Mr. Polischeck, seconded by Mr. Alejado, and unanimously carried to approve the Applications Committee Meeting Minutes of August 5, 2024.

1. Scope of Activity Committee:
Paul Alejado and John Polischeck, Co-Chairpersons

Hawaii Department of Transportation

Requests a determination on whether a C-32 Ornamental, guardrail, and fencing contractor may perform the installation and relocation of regulatory and warning road signs. The new and relocated road signs will either be mounted on new traffic signal poles or on their own sign supports (tubular metal posts).

Steven Yoshida, Highways Division, Department of Transportation, stated that at the July 19, 2024 meeting, the Board determined that a C-14 Sign contractor was required to install regulatory and warning road signs and the tubular metal posts that the signs will be mounted on. He is now asking whether a C-32 ornamental, guardrail, and fencing contractor may also install these signs. Mr. Alejado stated that based upon the information submitted, the signs do not have an electrical component. Mr. Yoshida confirmed that these are not electrical signs, they are just flat traffic signs. Executive Officer Ito stated that at last month's meeting, the Board stated that a C-13 Electrical contractor is required to install traffic signal poles. Mr. Yoshida stated that the general contractor has a C-13 Electrical contractor license. Mr. Polischeck stated that based upon the information submitted, a C-32 ornamental, guardrail, and fencing contractor may install these signs. Mr. Yoshida asked for confirmation that both the C-14 Sign and the C-32 ornamental, guardrail, and fencing contractor may install these signs. The Board responded yes.

Recommendation: Based solely on the information and testimony provided, a C-32 ornamental, guardrail, and fencing contractor may install regulatory and warning road signs and the tubular metal posts that the signs will be mounted on.

It was moved by Mr. Alejado, seconded by Mr. Polischeck, and unanimously carried to approve the above scope recommendation.

Mr. Shintani entered the meeting at 9:11 a.m.

waste water treatment plants, power plants, mass excavation). The “Amount of Supervisory Experience” should only include the actual amount of time spent on-site supervising his own employees performing work in the broad scope of the “A” General engineering classification.

- “B” General building classification – a revised project list verifying forty-eight months of Mr. Woods’ on-site supervision and direction of his own employees constructing buildings from the “ground-up”. The revised project list must include additional projects building structures from the “ground-up” and from start to finish. The “Amount of Supervisory Experience” should only include the actual amount of time spent on-site supervising his own employees performing work in the broad scope of the “B” General building classification.
- C-48 Structural steel classification – a revised project list verifying forty-eight months of Mr. Woods’ on-site supervision and direction of his own employees performing projects in the broad scope of the C-48 Structural steel classification including large structural steel projects. The revised project list should exclude work that is not in the description of the C-48 classification, e.g. tank work. The “Amount of Supervisory Experience” should only include the actual amount of time spent on-site supervising his own employees performing work in the broad scope of the C-48 Structural steel classification.

Each revised project list in the “A” General engineering, “B” General building, and C-48 Structural steel classification must state the trades performed in-house with Mr. Woods’ own crew and the work or trades subcontracted to other licensed contractors.

The revised project list must include a detailed description of the masonry work he supervised (e.g. cubic yards, height of vertical concrete work, the kind of form work, scaffolding, and shoring).

Media on Hiring Licensed Contractors

The Board reviewed a summary of CLB approved funds and campaign initiatives prepared by Kayla Setzler, DCCA Communications Specialist. The Board also reviewed the estimates for the unlicensed contractor signs from HonBlue, Signs Today, One Day Signs Hawaii, Sign Builders Hawaii, and Peterson Sign Company. Chairperson Nishek suggested purchasing 24" x 18" signs because a larger sign may be blown down by wind. Peterson Sign Company prices are reasonable and the signs come with stakes. The Board discussed placing banners at hardware stores and at DPP. The Board also discussed possibly having contractors on Maui volunteer to place the signs. It was moved by Chairperson Nishek, seconded by Mr. Suehiro, and unanimously carried to purchase 200 24" x 18" signs from Peterson Sign Company and approve the "Homeowner Be Careful", "Unlicensed Contractors Beware" and "Maui Strong" signs.

Ms. Setzler presented options for advertorial from KITV and Hawaii News Now (HNN). Although HNN cost is more than KITV, their reach is greater than KITV. HNN's reach is 88,000 impressions per segment; facebook reach is 4.6 million, and Instagram reach is 1.9 million. With a budget of \$10,000, the Board will be able to purchase 5 segments: 2 pre-produced segments on location and 3 live in-studio segments. It will also be posted on their social media and the HNN page. It was moved by Chairperson Nishek, seconded by Mr. Polischek and

unanimously carried to purchase up to \$10,000 to produce advertorials on HNN.
The Board will decide on who will be interviewed in the advertorial.
